Details:

Atlantia SpA, ACS and Hochtief AG have reached a binding agreement, relating to a joint investment in Abertis Infraestructuras SA. Under the terms of the agreement:

- Hochtief AG makes a voluntary public takeover offer for all outstanding shares in Abertis Infraestructuras SA ("Abertis"), whereby shareholders will receive €18.36 in cash for each Abertis share ("the Offer").
- Atlantia SpA would withdraw its public tender offer for Abertis shares.

Adjustments:

Provided that the Offer becomes effective, the contracts shall be de-listed with immediate effect and will be settled using the Fair Value method. In determining the Fair Value settlement prices, the following will apply:

Futures:

- **Dividends:** The dividend payments (as published by Markit Dividends) which are shown in the Attachment to this Notice will be used in determining the Fair Value settlement prices.
- **Interest rates:** Euribor interest rates shall be used in determining the Fair Value settlement prices.
