### INTRODUCTION OF SINGLE STOCK FUTURES ON BE SEMICONDUCTOR INDUSTRIES

#### Executive Summary

This Notice informs Members of the introduction of Single Stock Futures on BE Semiconductor Industries on the Amsterdam Derivatives Market as from 27 July 2018.
