**Details:** The board of Volvo proposes an ordinary dividend of SEK 5.50 and special dividend of SEK 7.00.

**Adjustments:** After the close of business on 8 April 2020 the following contract adjustments will be made:

- **Ratio Method**
- **Cum Event Price:** Official closing price of Volvo B shares on Nasdaq OMX Stockholm on 8 April 2020.
- **Lot Size:** The lot size will be divided by the Ratio. The adjusted lot size will be specified in the Final Notice.

$$\text{Ratio: } \frac{(\text{Cum Event Price} - \text{SEK } 5.50 - \text{SEK } 7.50)}{(\text{Cum Event Price} - \text{SEK } 5.50)}$$

**Futures:**

- **Variation Margin:** Daily Settlement Prices for 8 April 2020 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on 9 April 2020.
- **New contract:** In such case that the Ratio results in an adjusted lot size exceeding the standard lot size for contracts **VV6** (100) and **VV8** (10,000), new contracts (O-class) will be introduced. Contracts VV6 and VV8 will keep the standard lot size.
- **Single Stock Dividend Futures:** Ordinary dividends with an ex-date on or before the Effective Date shall be multiplied by the Ratio for the purpose of

determining the EDSP at the end of the life time of the **Dec20** maturity in contract VV8.

**Outstanding orders:** All outstanding orders for contracts VV6 and VV8 will be cancelled automatically after the end of the trading session on 8 April 2020. The priority of these orders will then be lost. New orders can be submitted as from 9 April 2020.
