### INTRODUCTION OF ADDITIONAL EXPIRY MONTHS IN AMSTERDAM MARKET OPTION CLASSES

#### Executive Summary

This notice informs Members that Euronext will add options series with an initial lifetime of 18 and 24 months to the Individual Equity Option classes on BE Semiconductor Industries NV and NN Group NV shares. Euronext will add options series with an initial lifetime of 36 months to the Individual Equity Option classes on Randstad NV shares.

#### 1. Introduction

1.1. Euronext will add options series with an initial lifetime of 18 and 24 months to the Individual Equity Option classes on BE Semiconductor Industries NV (contract code: BES) and NN Group NV (contract code: NN) shares. Furthermore, Euronext will add options series with an initial lifetime of 36 months to the Individual Equity Option classes on Randstad NV (contract code: RND) shares.

#### 2. Impacted contracts

- 2.1. On Thursday 7 October 2021 the **December-2022** and **June-2023** expiry months will be available for trading next to the already listed expiry months in contracts **BES** and **NN**.
- 2.2. On Thursday 7 October 2021 the **December-2023** expiry month will be available for trading next to the already listed expiry months in contract **RND**.

#### 3. Lifecycle

3.1. After the introduction of the new option series, the initial lifecycle for contracts BES and NN will be as follows:

3.2. After the introduction of the new option series, the initial lifecycle for contract RND will be as follows:
