Executive Summary

This notice informs Members of the introduction of additional expiry months for 6 Individual Equity Option classes listed on the Paris derivatives market as from 24 December 2018.

1. Introduction

1.1 Euronext intends to add maturities with an initial lifetime of 1, 2 and 3 months for 5 Individual Equity Option classes (IEOs) on the Paris derivatives market as from 24 December 2018.
