



Disclosure of transparency notifications

(Article 14 of the Law of 2 May 2007 on the disclosure of significant shareholdings in listed companies)

bpost discloses 2 notifications of significant shareholdings that it has received from BlackRock, Inc (and affiliates) in accordance with the Belgian Law of 2 May 2007 on the disclosure of significant shareholdings in listed companies.

1. Summary of the notifications

- In a first notification dated July 24, 2017, BlackRock, Inc., also on behalf of its subsidiaries set forth in the notification, notified that, following a disposal of bpost voting securities or bpost voting rights, it increased its holding and it crossed upward the 3% threshold of voting rights in bpost SA de droit public ("bpost") on July 19, 2017.
 - On July 19, 2017, BlackRock, Inc., taking into account the subsidiaries set forth in the notification, held 3,03% of the voting rights of bpost.
- In a second notification dated July 25, 2017, BlackRock, Inc., also on behalf of its subsidiaries set forth in the notification, notified that, following a disposal of bpost voting securities or bpost voting rights, it decreased its holding and it crossed downward the 3% threshold of voting rights in bpost on July 20, 2017.

2. Threshold crossed

Threshold that is crossed: 3%

Article 13 of bpost articles of association provides the following on disclosure of significant shareholdings: "As regards the application of Title II of the Law of May, 2 2007 on the disclosure of significant shareholdings in issuers whose shares are admitted to trading on a regulated market and other provisions and the Royal Decree of February, 14 2008 on the disclosure of significant shareholdings, the applicable successive thresholds are established at 3%, 5% and any multiple of 5%."
