

## Openbaarmaking van transparantiekennisgevingen

(artikel 14 van de wet van 2 mei 2007 met betrekking tot de openbaarmaking van belangrijke deelnemingen in beursgenoteerde vennootschappen)

**bpost maakt 2 kennisgevingen openbaar die zij heeft ontvangen van BlackRock, Inc (en verbonden vennootschappen) met toepassing van de wet van 2 mei 2007 met betrekking tot de openbaarmaking van belangrijke deelnemingen in beursgenoteerde vennootschappen.**

### 1. Samenvatting van de kennisgevingen

- In een **eerste kennisgeving** gedateerd op 7 augustus 2017, heeft BlackRock, Inc., mede namens de door haar gecontroleerde ondernemingen zoals in de kennisgeving uiteengezet, meegedeeld dat zij, ten gevolge van een verwerving van stemrechtverlenende effecten of stemrechten in bpost NV van publiek recht ("bpost"), haar deelneming heeft **verhoogd** en de 3% drempel van stemrechten heeft overschreden op 4 augustus 2017. Op **4 augustus 2017** hield BlackRock, Inc., via de door haar gecontroleerde ondernemingen, een deelneming die **3,01%** van de stemrechten in bpost vertegenwoordigt.
- In een **tweede kennisgeving** gedateerd op 8 augustus 2017, heeft BlackRock, Inc., mede namens de door haar gecontroleerde ondernemingen zoals in de kennisgeving uiteengezet, meegedeeld dat zij, ten gevolge van een verwerving van stemrechtverlenende effecten, haar deelneming in bpost heeft **verhoogd** op **7 augustus 2017**. Op die datum hield BlackRock, Inc., via de door haar gecontroleerde ondernemingen, een deelneming die **3,13%** van de stemrechten in bpost vertegenwoordigt.

### 2. Overschreden drempel

Overschreden drempel: 3%

Artikel 13 van de statuten van bpost bepaalt het volgende inzake openbaarmaking van belangrijke deelnemingen: *"In toepassing van Titel II van de Wet van 2 mei 2007 op de openbaarmaking van belangrijke deelnemingen in emittenten waarvan aandelen zijn toegelaten tot de verhandeling op een gereguleerde markt en houdende diverse bepalingen en het koninklijk besluit van 14 februari 2008 op de openbaarmaking van belangrijke deelnemingen, worden de toepasselijke opeenvolgende drempelwaarden vastgesteld op 3%, 5% en ieder veelvoud van 5%."*
