<b>C: Additional information:</b> <a href="#">Indumenta Pueri, S.L. is a company incorporated and with his tax residence in Spain being the parent company of the “Indumenta Pueri Group” which files his Consolidated Financial Statements in Spain.</a>
<a href="#">From its origins, the “Indumenta Pueri Group” main activity is the design, production, market and distribution of children’s fashion. Mayoral Moda Infantil, S.A.U. is the subsidiary, which coordinates this textile activity.</a>
<a href="#">Additionally, the Group has other subsidiaries which activity is to invest the group’s cash surpluses in the capital market. One of these subsidiaries called “Wilmington Capital, S.L.”, reached a qualifying holding of 5.002% in ALTRI on December 16th 2016. This subsidiary has transferred all the ALTRI’s titles to a sister company called “Global Portfolio Investments, S.L.” on December 29th 2017. As result of this transaction, Wilmington Capital does not have any share of ALTRI and Global Portfolio Investments has 11.000.000 shares.</a>
