

## **Jerónimo Martins SGPS, S.A.**

### **Participação Qualificada**

Nos termos e para os efeitos do n.º 1 do art. 17.º do Código dos Valores Mobiliários, Jerónimo Martins SGPS, S.A. informa ter recebido, no passado dia 18 de Agosto, uma comunicação, dando conta da nova agregação de participações do grupo de Standard Life Aberdeen PLC - sociedade resultante da fusão de Standard Life PLC e de Aberdeen Asset Management PLC - em Jerónimo Martins SGPS, S.A..

Assim, de acordo com a referida comunicação, em virtude da mencionada fusão, cujos efeitos se produziram a 14 de Agosto de 2017, Standard Life Aberdeen PLC, passou a deter 23.127.393 direitos de voto (3,68%) em Jerónimo Martins SGPS, S.A., tal como se extrai do formulário em anexo.

**10. Additional information<sup>xvi</sup>:**

As a result of the completion of the court-sanctioned scheme of arrangement and all-share merger under Part 26 of the Companies Act 2006 of Aberdeen Asset Management PLC and Standard Life plc which became effective on 14 August 2017, this notification details the assets under management of the new Combined Group ('Standard Life Aberdeen plc') as of the dates noted above.

In reference to section 8, the shares detailed are managed by the named discretionary investment management entity within multiple portfolios on behalf of underlying clients, based on investment management agreements whereby the client has delegated the exercise of the voting power to the referenced investment manager.

Please note that one of the underlying investment management entities, Standard Life Investments Limited, manages 2.98% of voting rights and is above the 2% notifiable threshold.

- in the circumstances foreseen in letter (e) of Article 10 of that Directive, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 9, under letters (a) to (d) of Article 10 of that Directive or under a combination of any of those situations, the controlled undertaking;

- in the circumstances foreseen in letter (f) of Article 10 of that Directive, the deposit taker of the shares, if he can exercise the voting rights attached to the shares deposited with him at his discretion, and the depositor of the shares allowing the deposit taker to exercise the voting rights at his discretion;
