Dividend to shareholders of 15 euro cents per share

Novabase – Sociedade Gestora de Participações Sociais, S.A. (“Novabase”) hereby informs the intention of the Board of Directors to propose, at the 2017 Annual General Meeting of Shareholders, the distribution of 4.7 Million Euros to shareholders. This payment, equal to 49.2% of the consolidated net profit, represents a dividend of 15 euro cents per share.
