Acquisition of treasury shares

In order to meet the future obligations of the stock option plan for members of the Management Committee (initiated in 2005 and renewed in 2010 and 2015), the Board of Directors of Van de Velde NV proceeded with the purchase of shares on the market of Euronext Brussels. - 14/03/2017: 305 shares. Average price = 55,65 €/share. Maximum price = 55,75 €/share. Minimum price = 55,56 €/share;
- 15/03/2017: 360 shares. Average price = 55,57 €/share. Maximum price = 55,60 €/share. Minimum price = 55,51 €/share.

The authorization to acquire own shares was granted to the Board of Directors on April 30, 2014 during the extraordinary meeting of shareholders.
