Today, Lotus Bakeries has increased its issued capital following the exercise of 1,770 warrants by Lotus employees. In this way the number of Lotus Bakeries shares has risen from 812,513 to 814,283. The 1,770 newly issued shares are scheduled to be listed on Euronext Brussels on 10 April 2017.
