Sonae Capital, SGPS, S.A. hereby informs, as required by Article 14, paragraph 8, of the Regulation No. 5/2008 of the Portuguese Securities Market Commission (CMVM), that its Director, Maria Cláudia Teixeira de Azevedo, has informed that, according to the terms of Article 248-B of the Portuguese Securities Code and of Article 14, paragraph no. 1, of the Portuguese Securities Market Commission Regulation no. 05/2008, she has purchased, on 29th March 2018, 168,718 of Sonae Capital’s shares under the Medium Term Incentive Plan of Sonae Capital, SGPS, S.A.. This transaction was completed over-the-counter at a reference price of € 0.928 Sonae Capital share market closing price of 29th March 2018.

As a result of this transaction, and under the terms of Article 20 of the Portuguese Securities Code, to this director shall hereinafter be attributable the voting rights pertaining to 449,213 shares directly held, and to 43,912 shares indirectly held through the controlled company Linhacom S.A..
