Sonae Capital, SGPS, S.A. hereby informs, as required by Article 14, paragraph 8, of the Regulation No. 5/2008 of the Portuguese Securities Market Commission (CMVM), that its Director, Ivone Maria Pinho Teixeira da Silva, has informed that, according to the terms of Article 248-B of the Portuguese Securities Code and of Article 14, paragraph no. 1, of the Portuguese Securities Market Commission Regulation no. 05/2008, she has purchased, on 29<sup>th</sup> March 2018, 167,525 of Sonae Capital’s shares under the Medium Term Incentive Plan of Sonae Capital, SGPS, S.A.. This transaction was completed over-the-counter at a reference price of € 0.928, Sonae Capital share market closing price of 29<sup>th</sup> March 2018.

As a result of this transaction, it shall be attributable to the aforementioned Director the voting rights pertaining to 277,595, shares, directly held.
