

Announcement of disposal of own shares

Brussels, 21 May 2021, 8:30 CEST – Titan Cement International S.A. (Euronext Brussels, ATHEX and Euronext Paris, TITC) announces, in accordance with article 8:6 of the Royal Decree of 30 April 2019 implementing the Belgian Companies and Associations Code, the disposal by its subsidiary, Titan Cement Company S.A. (“Titan S.A.”), of 45,838 shares of Titan Cement International S.A. (“TCI”), to sixteen (16) executive Titan Group employees, in the context of existing stock option plans.

The above TCI shares were sold on 14, 17, 18, 19 and 20 May 2021 by Titan S.A., through OTC transactions, at an exercise price of € 10 per share (i.e. € 458,380 in total).

Following the above transactions, Titan S.A. owns 1,008,942 TCI shares, representing 1.22% of the voting rights of TCI.
