
Exmos. Senhores,

A 1 Thing, Investments, S.A. (doravante “**1 Thing**”) vem, por este meio, comunicar, nos termos e para os efeitos do disposto no artigo 16.º do Código dos Valores Mobiliários, que adquiriu, na presente data e pelo preço base de € 8,3 por ação, 4.175.000 ações representativas de 3,00% do capital social e dos direitos de voto da Greenvolt – Energias Renováveis, S.A. (doravante “**Greenvolt**”), por efeito do contrato de compra e venda de ações (“*share purchase agreement*”) celebrado na presente data entre a V-Ridium Holding Limited (doravante “**V-Ridium**”) e a 1 Thing, que teve por objeto a venda, pela V-Ridium à 1 Thing, de 4.175.000 ações representativas de 3,00% do capital social e dos direitos de voto da Greenvolt, bem como a concessão à 1 Thing de uma opção para adquirir 2.365.875 ações adicionais representativas de 1,7% do capital social e dos direitos de voto da Greenvolt.

Em virtude de tal operação, a 1 Thing aumentou a sua participação na Greenvolt de 9.848.239 ações representativas de 7,08% para 14.023.239 ações representativas de 10,08% do capital social e dos direitos de voto da Greenvolt, sendo-lhe imputáveis, por efeito da opção de compra acima referida, um total de 16.389.114 direitos de voto da Greenvolt.

Na sequência da mencionada operação e, pelo facto do administrador Pedro Miguel Matos Borges de Oliveira ser também administrador da Greenvolt, mais se informa, nos termos e para os efeitos do disposto na alínea b) do número 1 do artigo 20.º do Código dos Valores Mobiliários, que se consideram imputáveis a Pedro Miguel Matos Borges de Oliveira um total de 16.389.114 ações correspondentes a 11,78% do capital social e dos direitos de voto da Greenvolt.
