10. Additional information^{xvi}:

The initial acquisition of a qualifying shareholding was made by V-Ridium Europe Spółka z ograniczoną odpowiedzialnością ("V-ridium Europe") following the acquisition of 9.59% in Greenvolt's IPO. On June 30, 2023, V-ridium Europe was incorporated into V-ridium Holding Limited. Both V-ridium Holding Limited and V-ridium Europe had a similar shareholding composition, with none of their shareholders holding more than 50% of the voting rights of either company.

On January 12, 2024, V-ridium Holding Limited sold 4,175,000 shares in Greenvolt (equivalent to 3% of the share capital and the voting rights) to 1Thing Investments S.A., as disclosed by the latter to the market, so V-ridium Holding Limited ceased to have a qualifying holding in Greenvolt.
