#### **Care Property Invest signs agreement to acquire monumental care residence in Bloemendaal (NL)**

---

*Schoten, Belgium – Tuesday 18 June 2024*

Today, Care Property Invest signed the agreement under suspensory conditions to acquire the luxury real estate project 'Fleurâge Residences', an up-and-running care residence with 22 apartments located in the affluent municipality of Bloemendaal in the Dutch province of North Holland. The total investment value for the project is estimated to be approximately €10.2 million.

The transaction takes place in the form of an asset deal, whereby Care Property Invest will acquire the real estate of this project through its Dutch subsidiary Care Property Invest.NL9 B.V. after fulfilment of the suspensory conditions - expected in Q4 2024. The project will generate additional income for the Company from then on.

For the operation of the care residence, Care Property Invest is joining forces for the ninth time with Domus Valuas, which offers high-standing living and care at various exclusive locations in The Netherlands. The cooperation is based on a new long-term rental agreement of the 'triple net' type with a duration of minimum 20 years (renewable and annually indexable).

The estate in question has been a household name in Bloemendaal and the surrounding area for almost three centuries. The monumental main building from 1720 and the two adjoining coach houses contain 22 apartments for elderly people with care needs. Furthermore, the estate includes an impressive courtyard and a tea dome. The landscaped garden forms a beautiful walking area with many flower beds and a picking garden. Care Property Invest and Domus Valuas are also making a joint commitment to realise another gatehouse with six additional apartments, after obtaining an irrevocable and enforceable environmental permit.

### The operator

The national residential care organization Domus Valuas, formed in November 2022 from a merger between Valuas Zorggroep and Domus Magnus, offers intensive private elderly care at unique locations in The Netherlands. Today, the group has 31 operational residences. Of these, Care Property Invest now has nine in its portfolio. Meanwhile, Domus Valuas has become a valued residential care provider for frail and needy elderly people in The Netherlands. The operator focuses on elderly people with physical discomfort as well as residents with (incipient) memory problems. The recent merger created a substantial increase in synergies, economies of scale and innovative power, which will further strengthen Domus Valuas' position in the care market. The merged company operates in eight Dutch provinces, providing care to over 750 residents and foresees approximately 1,500 employees. This also creates new opportunities for Care Property Invest, as a sustainable real estate investor.

<b>Project:</b>	The project consists of a main building, 2 coach houses and a tea dome. The care residence has 22 apartments equipped for elderly people with care needs. The owner and operator intend to construct 6 additional apartments in a gatehouse yet to be built. The current apartments are between 50 and 115m <sup>2</sup> and have private bathrooms and luxury kitchenettes. Common and staff areas are located in the main building. Next to the buildings are beautiful, well-maintained gardens, paths and a courtyard.
<b>Location:</b>	The unique estate is located near the village centre of Bloemendaal, in the province of North Holland. The municipality is located in one of the most affluent regions of The Netherlands. The project therefore has a very clear focus on the luxury segment within the healthcare sector. Shops, restaurants and culture are within walking distance. The bus stop is 150m away and the train stop is 750m away. The project is a 10-minute drive from Haarlem, accessible via the nearby N208. A drive to the capital Amsterdam takes about 30 minutes.
<b>Sustainability:</b>	With an EPC label A, the apartments in the coach houses comply with current regulations. The buildings include underfloor heating, an adjustable ventilation system and sun blinds on the ground floor. The main building, dating from the early 18th century, has an EPC label G. Certain energy-saving measures, such as solar panels, are not possible due to the monumental character of the property.
<b>Year of construction/renovation:</b>	The main building dates from 1720 and underwent another series of major repair and maintenance works in 2022 and 2023. The coach houses were erected in 2016. The estate also contains a teahouse ('tea dome').
<b>Transaction:</b>	Asset deal
<b>Type of contract:</b>	New long-term lease agreement of the 'triple net' type with a minimum duration of 20 years (renewable and annually indexable)
<b>Total investment value:</b>	Approximately €10.2 million.
