

Oxurion Receives Transparency Notification from Atlas Special Opportunities LLC

Leuven, BELGIUM – September 3, 2024 – 06:00 PM CET - [Oxurion NV](#) (Euronext Brussels: OXUR), a biopharmaceutical company headquartered in Leuven, today announced that, pursuant to Belgian Transparency legislation¹ it has received a transparency notification as follows:

Oxurion received a transparency notification on August 30, 2024, from Atlas Special Opportunities, LLC indicating that as of July 22, 2024, it held 2,028,567,725 shares of the then outstanding 13,362,647,372 shares, and therefore crossed above the threshold (15%) by virtue of the purchase of voting securities. Oxurion received a transparency notification on August 30, 2024, from Atlas Special Opportunities, LLC indicating that as of July 31, 2024, it held 1,937,193,391 shares of the then outstanding 13,362,647,372 shares, and therefore crossed below the threshold (15%) by virtue of the sale of voting securities. 


