On 5 November 2024, Care Property Invest has received a transparency notification.

As a result of the disposal of voting securities or voting rights, the overall percentage of voting rights exercisable by BlackRock, Inc. fell below the threshold of 3% on 1 November 2024.

In accordance with Article 18 §1 j° Article 6 §3 of the Law of 2 May 2007 on the disclosure of major shareholdings in issuers whose shares are admitted to trading on a regulated market and containing various provisions, a notification to the issuer and the FSMA is required.

The market capitalisation of Care Property Invest amounted to approximately €446 million on 04/11/2024. The Company aims to create a stable share for its shareholders with a low risk profile and a stable and steadily growing dividend.
