

Oxurion Receives Transparency Notifications from Atlas Special Opportunities II LLC

Oxurion received a transparency notification on May 15, 2025, from Atlas Special Opportunities II, LLC indicating that as of May 8, 2025, it held 202,731 shares of the then outstanding 4,634,663 shares, and therefore crossed under the threshold (5%) by virtue of the selling of voting securities.

Oxurion received a transparency notification on May 15, 2025, from Atlas Special Opportunities II, LLC indicating that as of May 12, 2025, it held 1,724,103 shares of the then outstanding 6,156,035 shares, and therefore crossed above the threshold (25%) by virtue of the purchase of voting securities.
