## Care Property Invest completes sale of project in Deinze (BE)

*Schoten, Belgium – Monday 6 October 2025*

Care Property Invest has completed the sale of the 'De Nieuwe Ceder' project, located on Parijsestraat in Deinze (East Flanders). The residential care project for people with acquired brain injury, comprising 86 residential units and completed in 2019, has been transferred to Leieborg vzw. The sale generated a market-based return of €9.4 million.

The new owner, Leieborg vzw, is an experienced and renowned care organisation for people with disabilities and enjoys the full support of the Deinze city council to further expand its operations at this beautiful location.

The sale strengthens Care Property Invest's financial position. The funds released can be reallocated to new investments and contribute to keeping the debt ratio under control. At the same time, we continue to look opportunistically at divestments with the aim of further optimising our portfolio.
