### **Execution of Addendum No. 5 to the Second Group of Airports Concession Agreement.**


**Lima, 17 March 2026.-** Aeropuertos Andinos del Perú S.A., a subsidiary of the Company, has entered into Addendum No. 5 to the Concession Agreement for the Second Group of Airports with the Ministry of Transport and Communications. This addendum will enable the execution of projects valued at over US \$470 million, benefiting more than 5 million passengers and the Southern Macro-Region.

This addendum is intended to facilitate the execution of projects for the new runway in Juliaca, internal and external drainage works, and the improvement of said airport's terminal. Furthermore, it contemplates the expansion of the Arequipa Airport, the optimization of the airport terminals in Puerto Maldonado and Tacna, and the construction of new perimeter fencing for the airports in Juliaca, Arequipa, Tacna, and Puerto Maldonado.
