InPost completes share buyback programme

InPost SA ("InPost") announces the completion of its share repurchase programme to meet its obligations under its employee incentive programmes, as announced on 8 April 2026.

Between 8 April 2026 and 9 April 2026, 625,000 shares, representing 0.1% of InPost's issued share capital, were repurchased at an average price of EUR 15.16 per share, for a total consideration of EUR 9,471,966.00. A breakdown of daily aggregated transactions is set out below and daily share purchase transaction details are in appendix.

The buyback program has been conducted in accordance with applicable rules and regulations, including the Market Abuse Regulation 596/2014 and the Commission Delegated Regulation (EU) 2016/1052, and based on the authority granted by the annual general meeting of shareholders on 19 May 2022. The buyback programme has been executed by an independent intermediary.
