



Rating_Action: Moody's assigns Aa3 local currency issuer rating to Sparebanken Vest Boligkreditt AS

Stockholm, March 31, 2023 – Moody's Investors Service ("Moody's") has today assigned Aa3 long-term local currency issuer rating and Aa3 long-term foreign and local currency Counterparty Risk Ratings to Sparebanken Vest Boligkreditt AS (SPV Boligkreditt). Concurrently, Moody's also assigned short-term foreign and local currency Counterparty Risk Ratings of P-1. Moody's has also assigned a long-term Aa3(cr) and a short-term P-1(cr) Counterparty Risk Assessments. All applicable ratings are in line with those of its parent savings bank in Norway, Sparebanken Vest.

The outlook on the long-term issuer rating is stable, also in line with the senior unsecured rating outlook of the parent bank.

RATINGS RATIONALE

The ratings of SPV Boligkreditt reflect Moody's view that the creditworthiness of the fully owned mortgage subsidiary is similar with that of Sparebanken Vest. In our opinion, SPV Boligkreditt is highly integrated with its parent, Sparebanken Vest and financially indistinguishable from it. Moody's does not expect that the obligations of SPV Boligkreditt would be treated differently to those of Sparebanken Vest, should the parent bank face any financial difficulty, and therefore Moody's aligned the ratings of the two entities.

SPV Boligkreditt represented approximately 56% of the Sparebanken Vest's loans and 27% of its capital as of December 2022. All services are provided through the Sparebanken Vest's distribution network, while the vast majority of SPV Boligkreditt's operations, including management and reporting, are also outsourced to its parent bank through a service agreement. SPV Boligkreditt is directly regulated by the Norwegian Financial Stability Authority and has to fulfill its own capital requirements as well as comply with the regulation on Liquidity Coverage Ratio (LCR) and Net Stable Funding Ratio (NSFR).

FACTORS THAT COULD LEAD TO AN UPGRADE OR DOWNGRADE OF THE RATINGS

The ratings and assessments of SPV Boligkreditt could be upgraded if the parent entity's ratings are upgraded.

The ratings and assessments of SPV Boligkreditt could be downgraded if i) the parent entity's ratings are downgraded or ii) if there was any loosening as to the degree of integration between Sparebanken Vest and SPV Boligkreditt.
