



## SEAPEAK LLC DECLARES DISTRIBUTIONS ON SERIES A AND B PREFERRED UNITS

Hamilton, Bermuda, December 13, 2024 – Seapeak LLC (Seapeak or the Company) has declared cash distributions of \$0.5625 per unit on the Company's Series A preferred units (NYSE:SEAL PR A) and \$0.5313 per unit on the Company's Series B preferred units (NYSE:SEAL PR B) for the period from October 1, 2024 to December 31, 2024. The cash distributions are payable on January 15, 2025, to all unitholders of record as at December 31, 2024.

Seapeak's preferred unit distributions are reported on Form 1099 for United States tax purposes.
