**Kongsberg, December 17, 2024:** Kongsberg Automotive (KA) welcomes investors, analysts, and interested parties to its second annual breakfast meeting and networking opportunity in Oslo, Norway today. At the Capital Markets Day (CMD) in May this year, KA presented long-term goals of above EUR 1 billion in revenues and an EBIT margin at or above 8.5% in 2028. From early 2025, the company will start providing a quarterly award announcement.
