WPU - Waste Plastic Upcycling A/S ("WPU" or the "Company") Announcement of Capital Increase Registration

Reference is made to announcement no. 16 – 2024, dated December 17, 2024, which addresses, among other matters, the exercise of warrants and the subscription for a total of 1,527,900 newly issued company shares.

The warrants have been exercised, and the increase in the Company's share capital has been registered with the Danish Central Business Register. A total of 1,527,900 new shares have been issued.

Chairperson of the Board and Primary insider Niels Stielund has exercised warrants to subscribe to 416,700 newly issued company shares.

Similarly Vice-Chairperson of the Board and Primary insider Klaus Henrik Lindblad has exercised warrants to subscribe to 277,800 newly issued company shares.

Furthermore, the former members of the Company's Board of Directors have exercised their remaining warrants, subscribing to a total of 833,400 newly issued Company shares.

Following the share capital increase, the Company's total share capital now stands at DKK 527,075.53, distributed across 52,707,553 shares, each with a nominal value of DKK 0.01.
