


# EURONEXT SERIES INTRODUCTION POLICY FOR OSLO BØRS INDIVIDUAL EQUITY OPTIONS (IEOs)

Oslo Børs determines the minimum number of series to be introduced for an IEO class per Maturity and per Scale, as detailed in this Series Introduction Policy.

#### **SERIES INTRODUCTION POLICY**

1. Euronext determines the minimum number of series to be introduced for an IEO class per Maturity and per Scale (A-C), as illustrated in the graphic below:



Time to maturity

2. Exercise Price Intervals are applied depending on the Exercise Price Range and the Scale (A-C) as follows:

4. Similarly, an option class with a **remaining time to maturity of 6 months and an ATM strike at NOK 85** would have the following series introduced:

In order to ensure that the most appropriate series are introduced for all Individual Equity Option classes, Euronext will continue to monitor the series policy and reserves the right to deviate from and amend the series introduction policy if market conditions require. In a situation of high/low volatile market conditions, Euronext may decide to introduce additional series or to double/half the Exercise Price Intervals for a certain maturity or group of maturities.
- 6. In addition to the series introduction policy, Euronext will continue to allow Members to request additional series in an option class according to the series on request policy.





1. Euronext determines the minimum number of series to be introduced for Index Options per Maturity and per scale (A-C), as illustrated in the graphic below:

2. Exercise price Intervals are applied depending on the Exercise Price Range and the Scale (A-C) as follows:
