Index weights are constructed using an optimization process that aims to achieve the PAB decarbonisation objectives while minimizing the sectorial weights' deviation relative to the Index Starting Universe. Euronext® ESG Eurozone Biodiversity Leaders PAB index meets the requirement of the "EU Paris-aligned Benchmarks" (PAB). The index serves as an underlying for structured products, funds and exchange traded funds.
