It excludes companies with the worst ESG score and Carbon Risk rating, or involved in controversial activities, tobacco, controversial weapons, coal or assessed to be in breach with international standards such as UNGC principles. The Environmental, Social and Governance and Carbon Risk rating is assessed by ISS ESG. The index serves as an underlying for structured products, funds, exchange traded funds, options and futures.

#### **Investability**

Stocks are screened to ensure liquidity to ensure that the index is investable.
