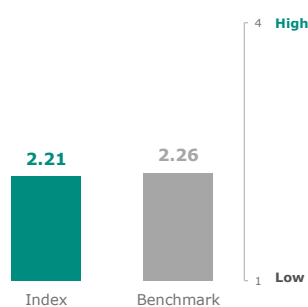

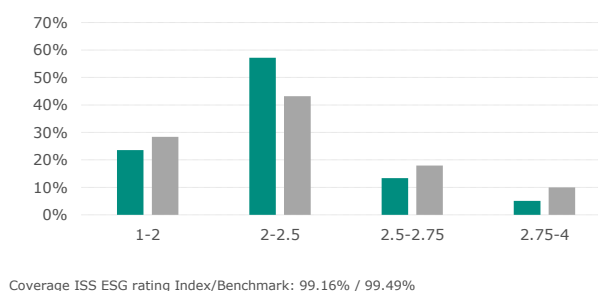

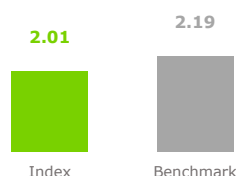
Weighted average ESG rating



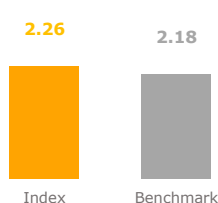
ESG score distribution



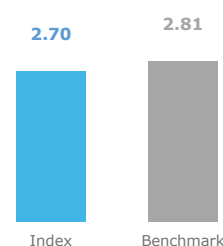

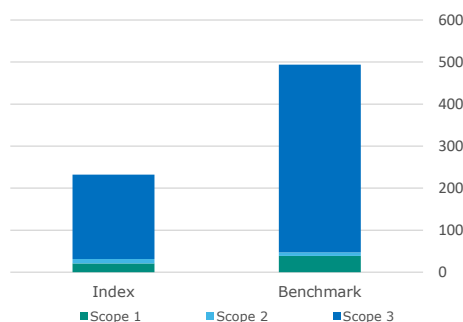

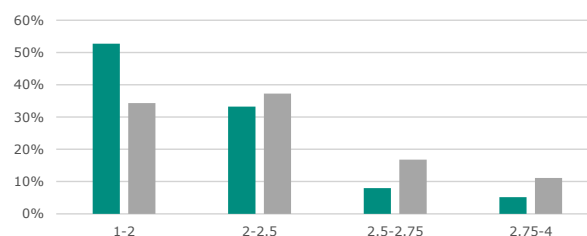

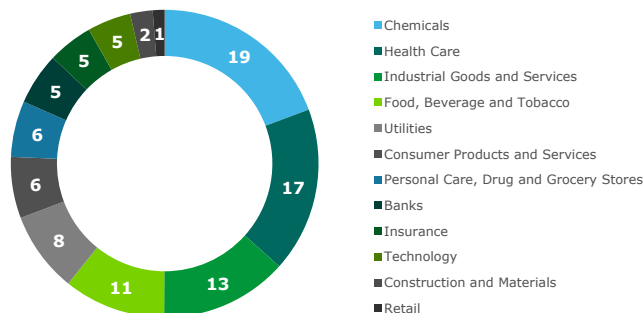
Carbon footprint

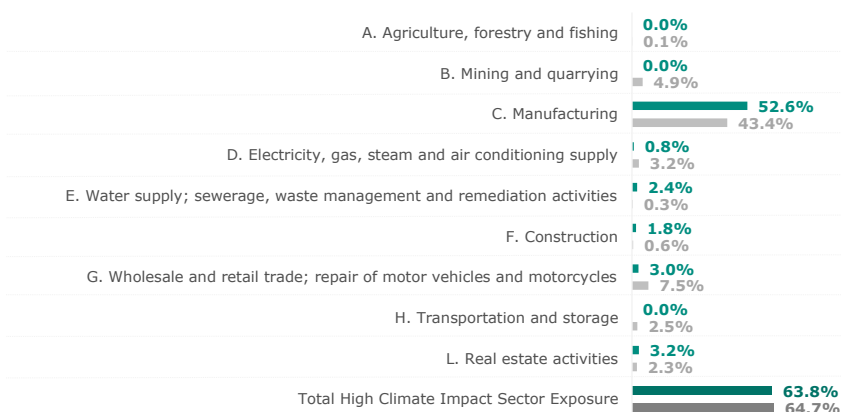

High Climate Impact Sectors Exposure (NACE)



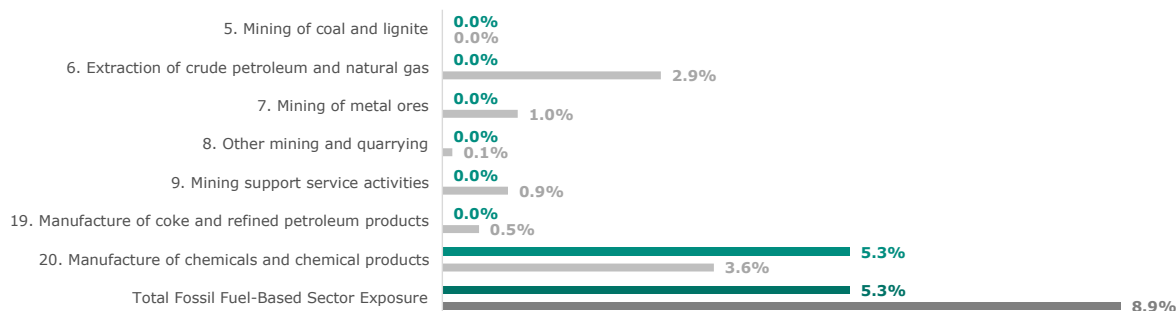

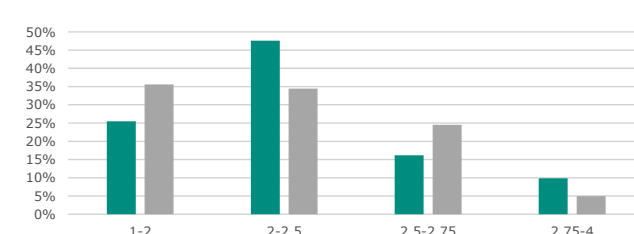

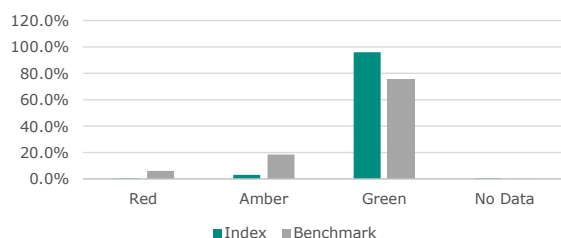

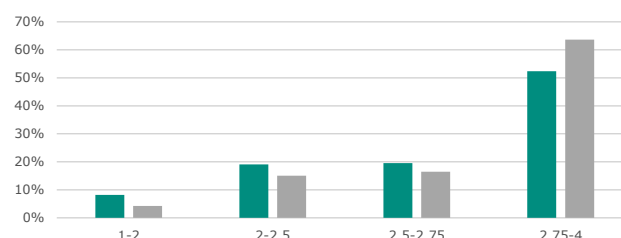

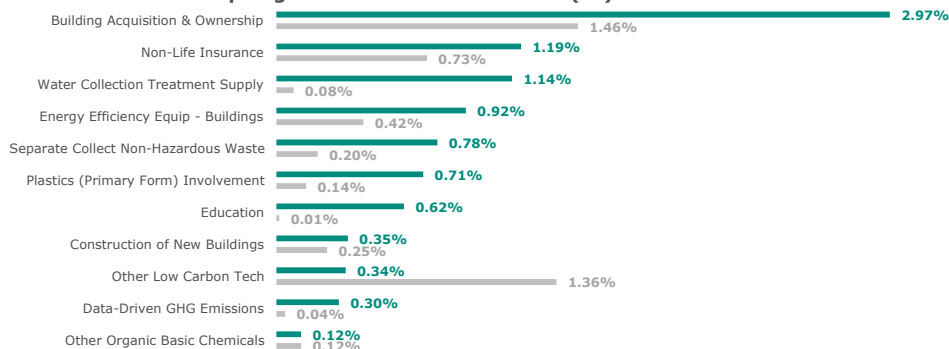

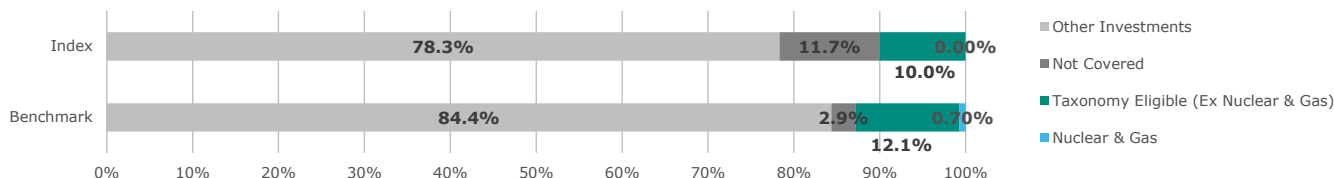
Top Eligible Activities of the Index (%)

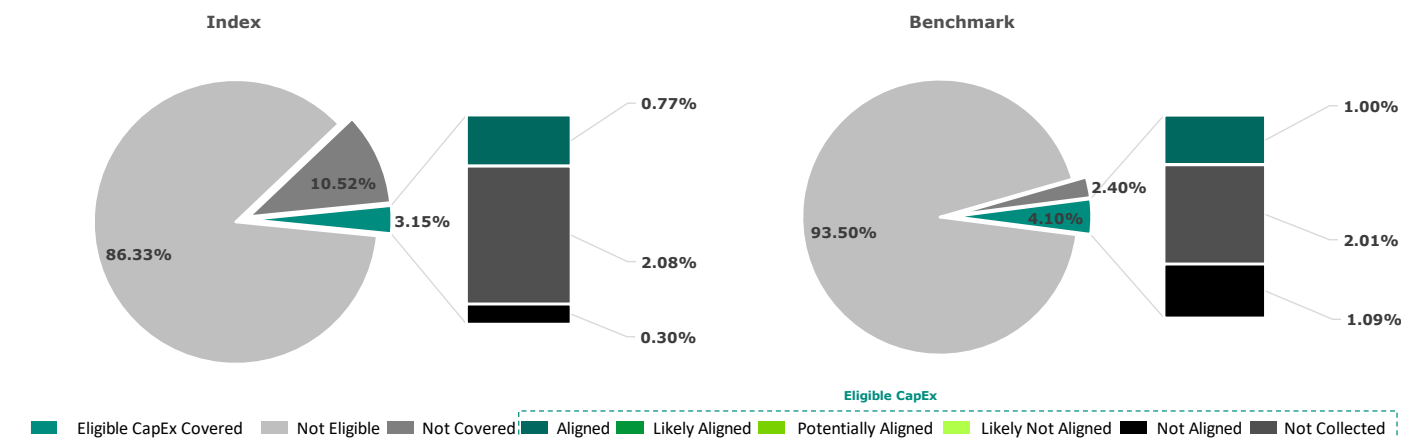
