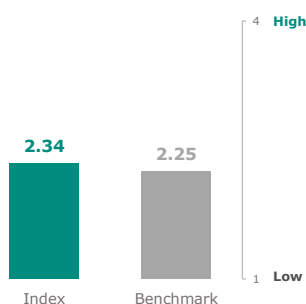

Companies may be excluded if their level of commitment is insufficient with regard to their overall score or their score in one of six key areas reviewed in the Equitics methodology or are subject to serious, proved, or recurrent controversies. Then 50 highest ranking companies are selected according to their overall Equitics score. The index is Non-Market capitalization weighted, weighting are based on the overall Equitics scores. The index serves as an underlying for structured products, funds and exchange traded funds. The index rules are available on our website. Euronext acts as Supervisor. 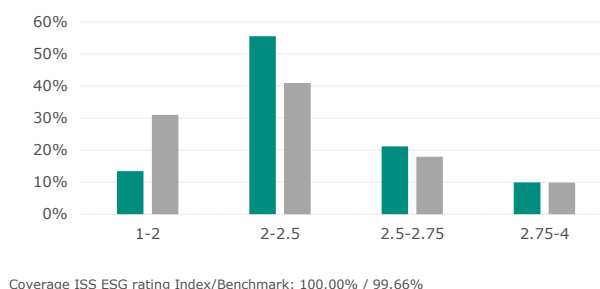

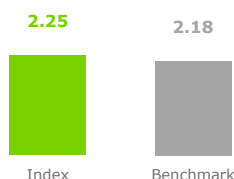
Weighted average ESG rating



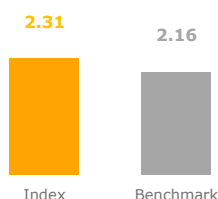
ESG score distribution



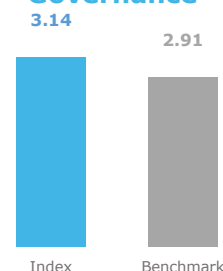

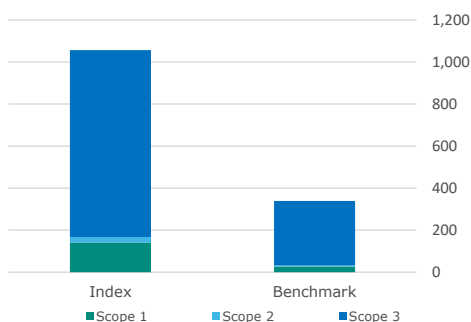

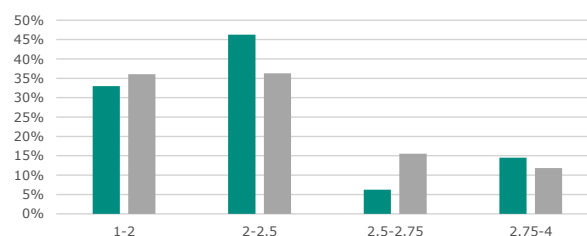

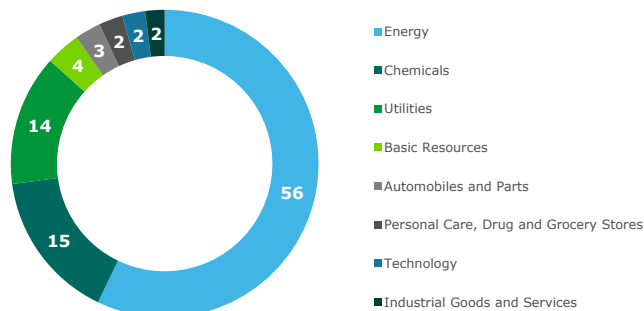
### Carbon footprint

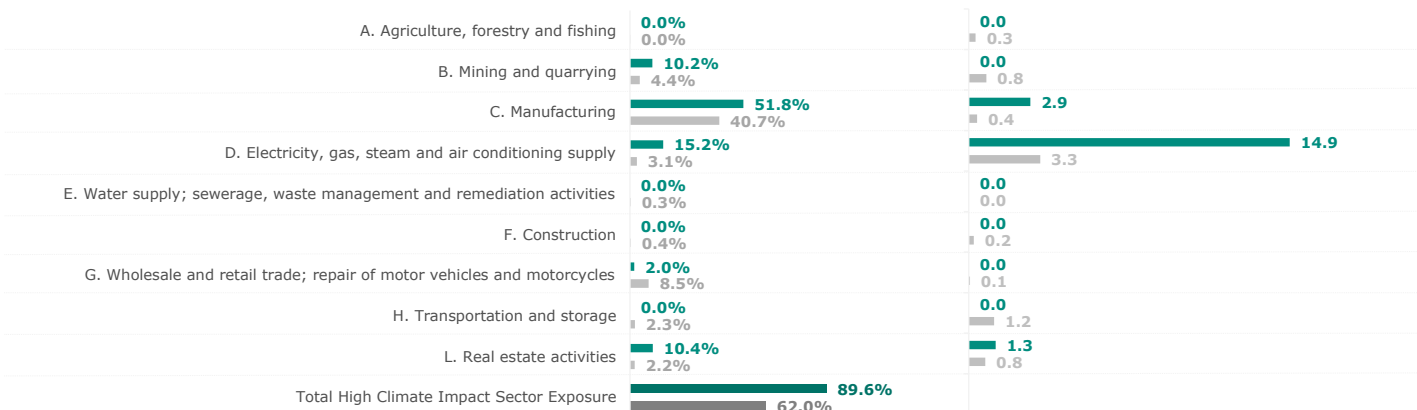

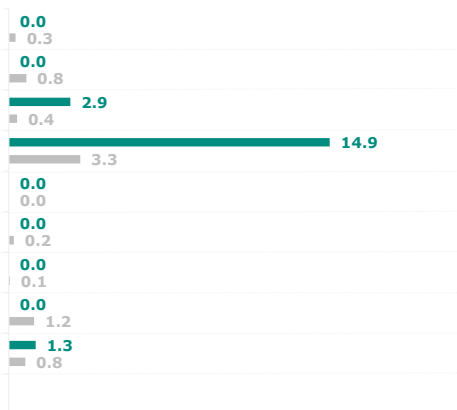

## High Climate Impact Sectors Exposure (NACE)



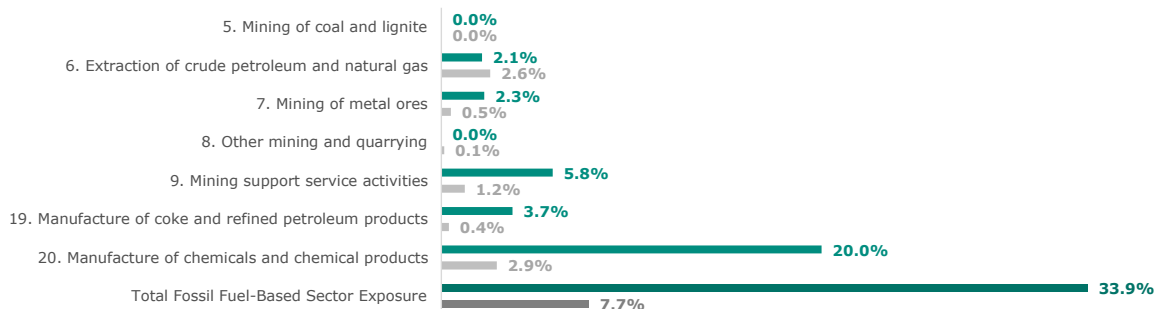

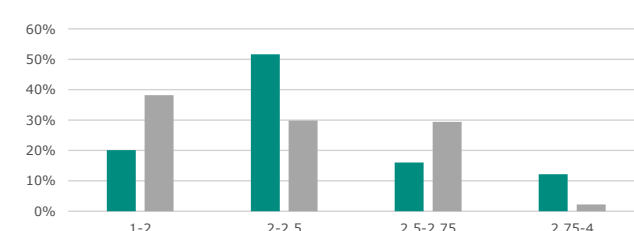

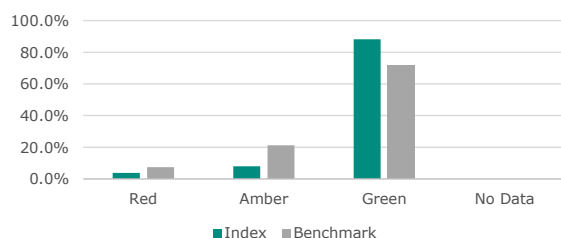

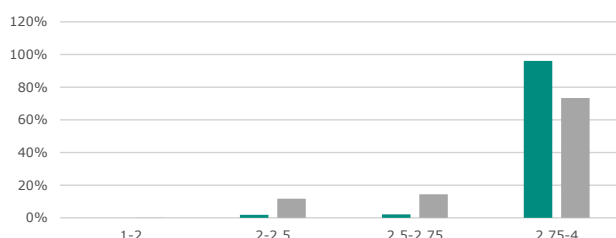

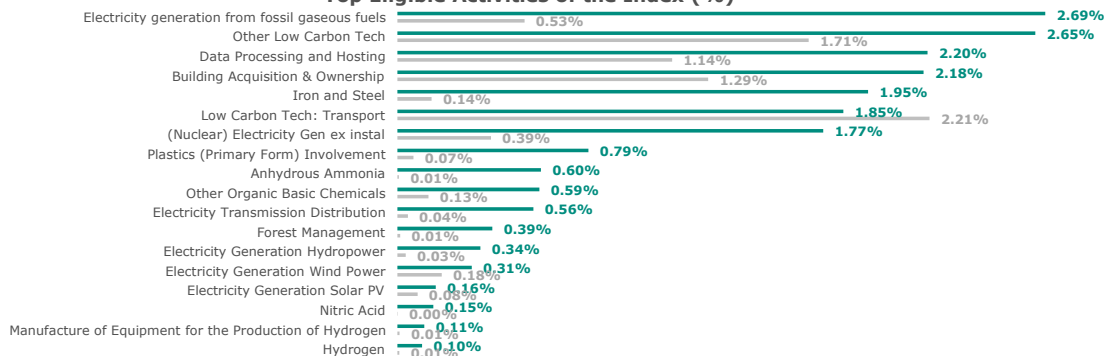

### Top Eligible Activities of the Index (%)

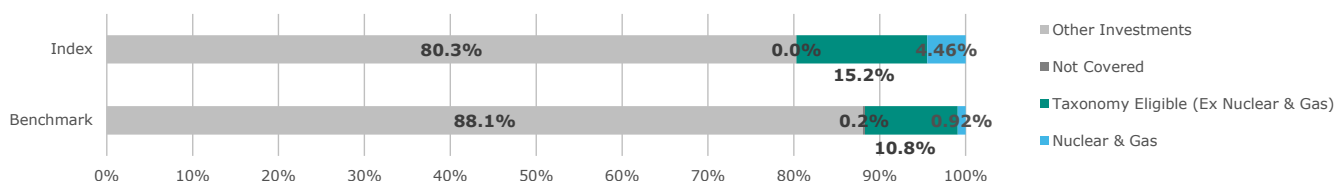

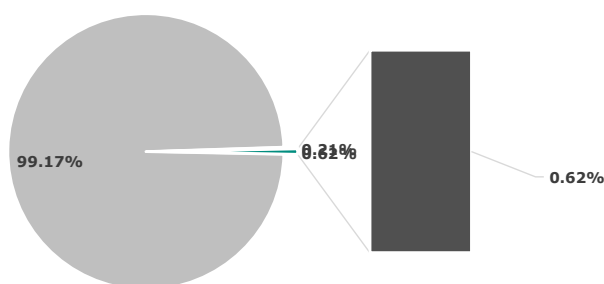
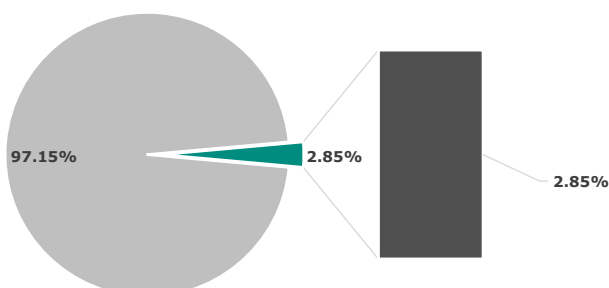
