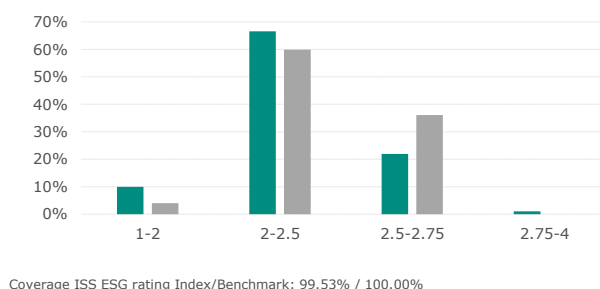

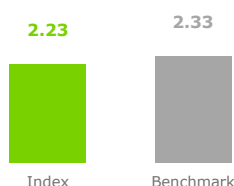
Weighted average ESG rating



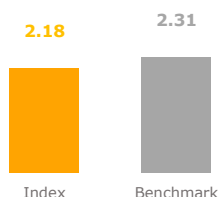
ESG score distribution



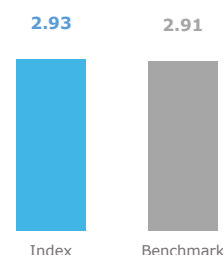

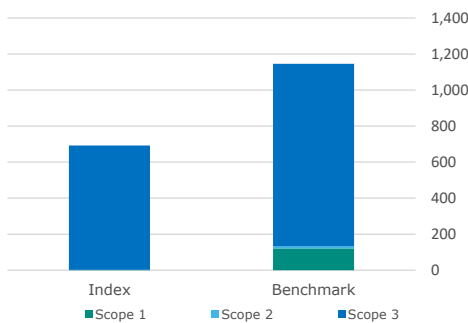

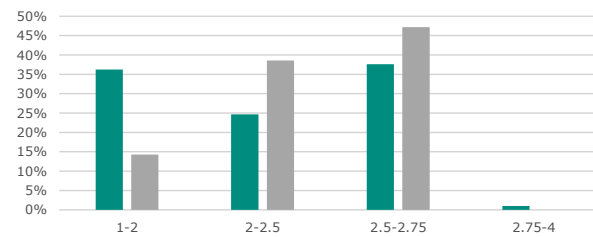

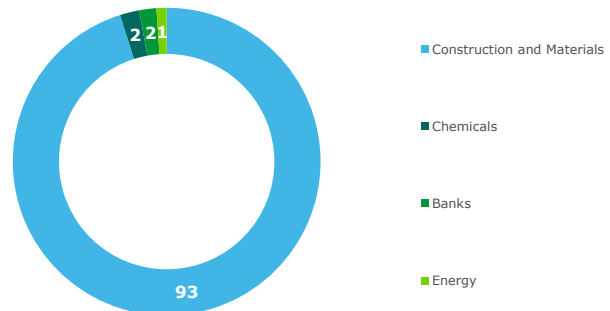
Carbon footprint

Carbon footprint tCO₂e/Enterprise Value

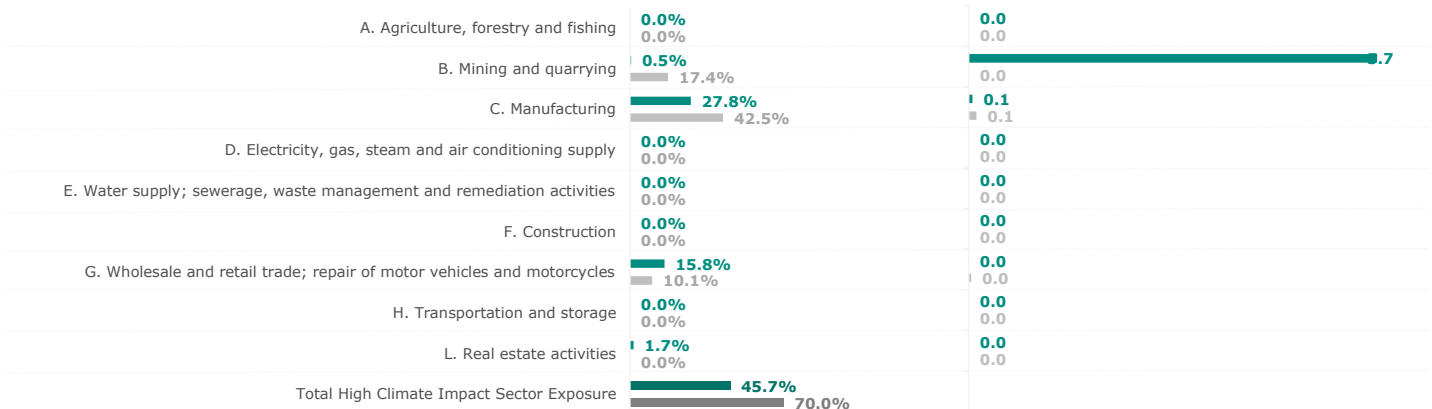

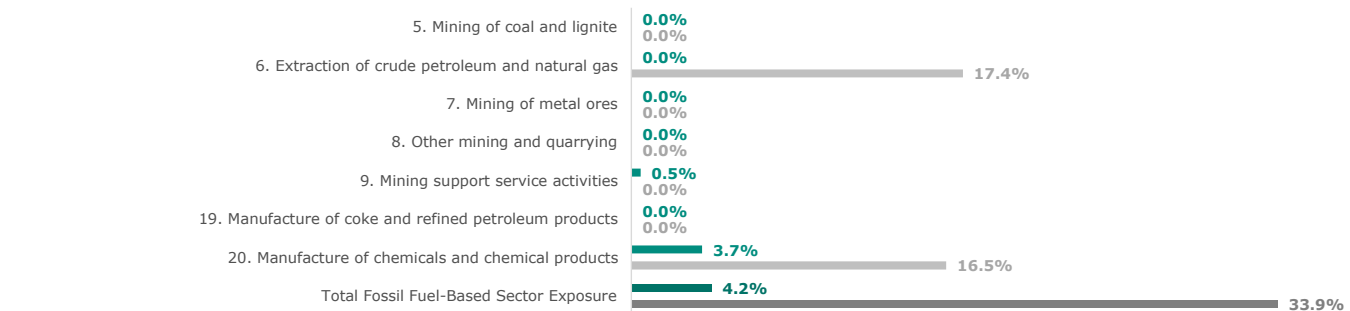
High Climate Impact Sectors Exposure (NACE)

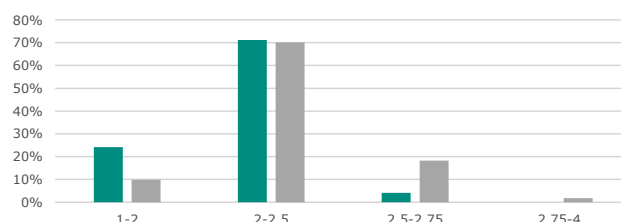

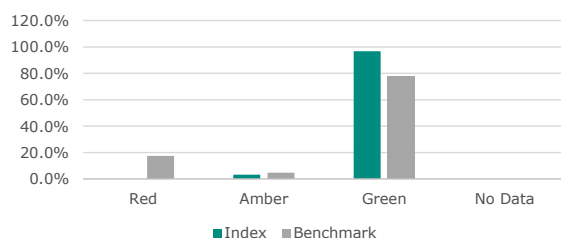

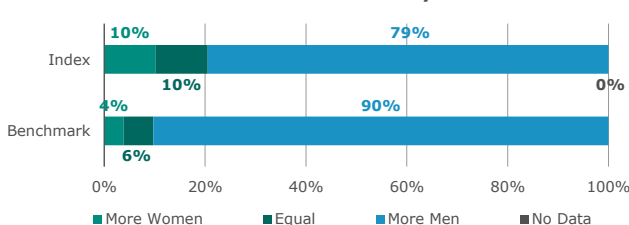

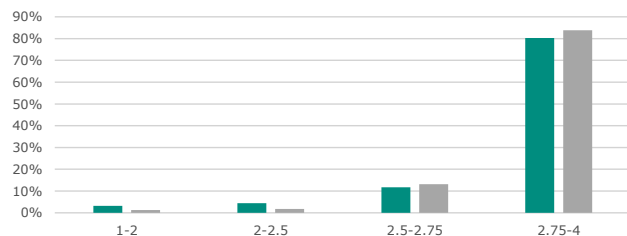

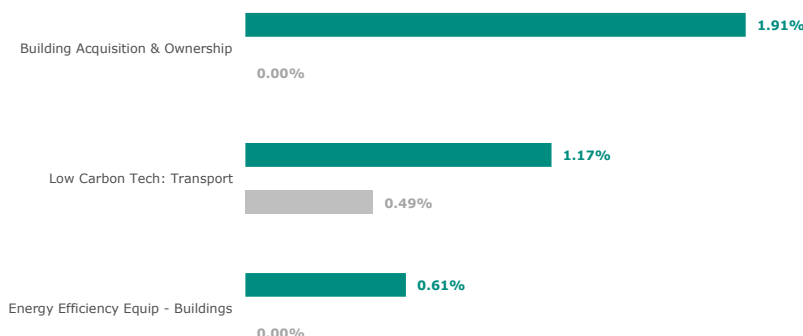

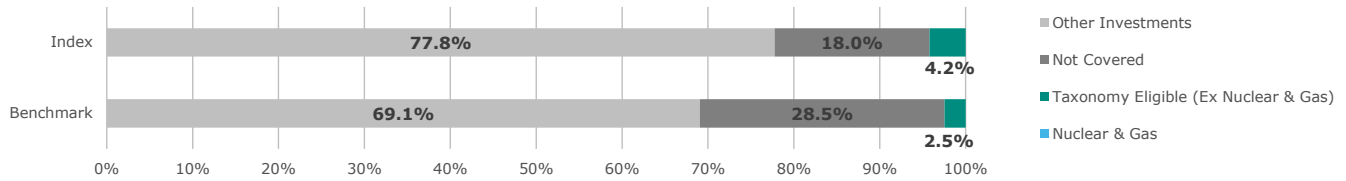

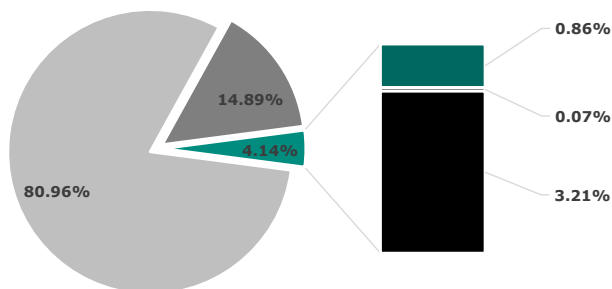

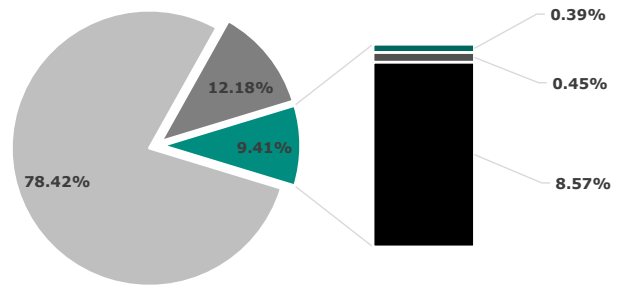
Eligible Capital Expenditure Overview

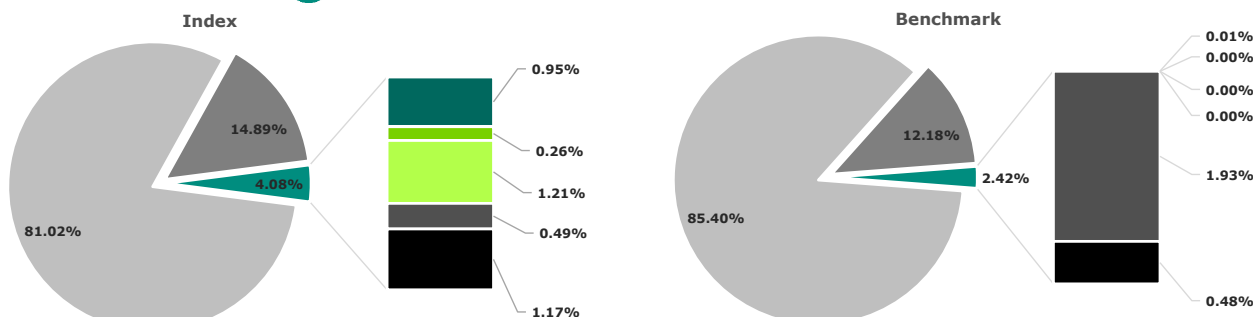

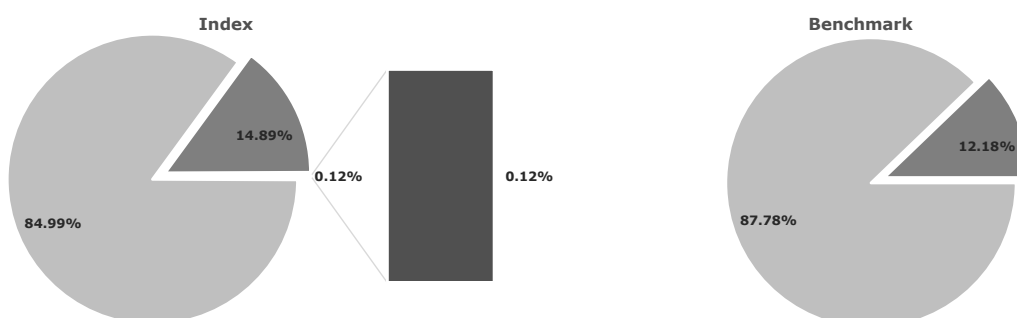
