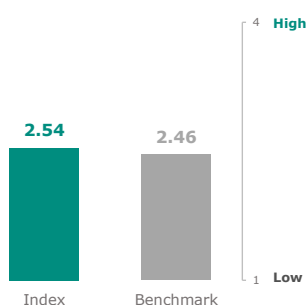
Objective

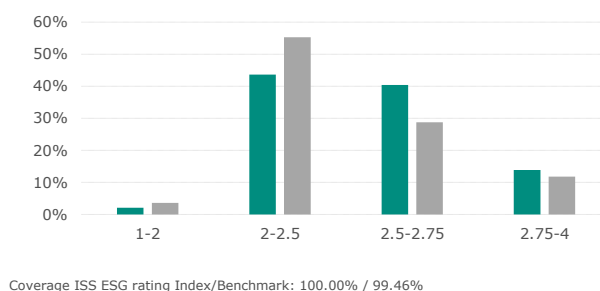

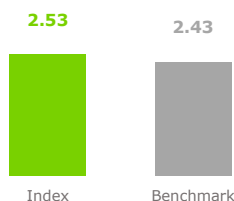
Weighted average ESG rating



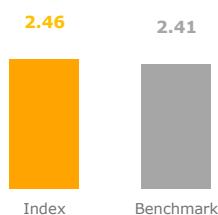
ESG score distribution



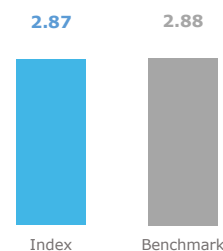

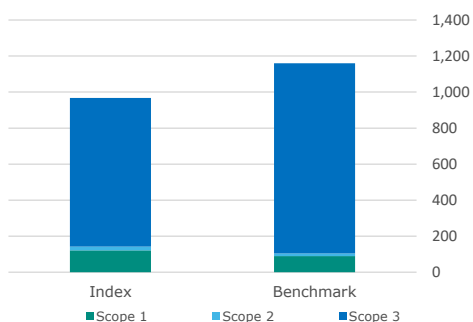

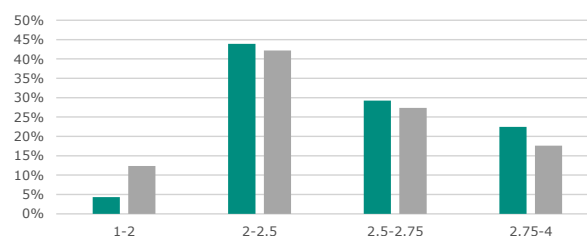

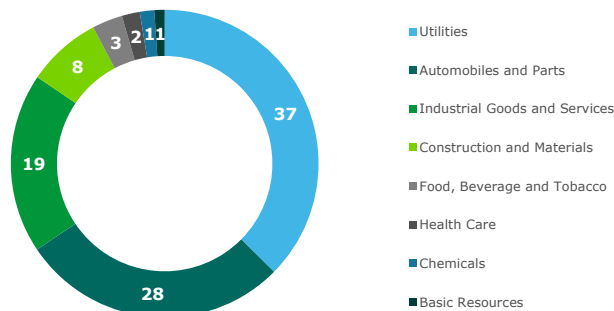
Carbon footprint

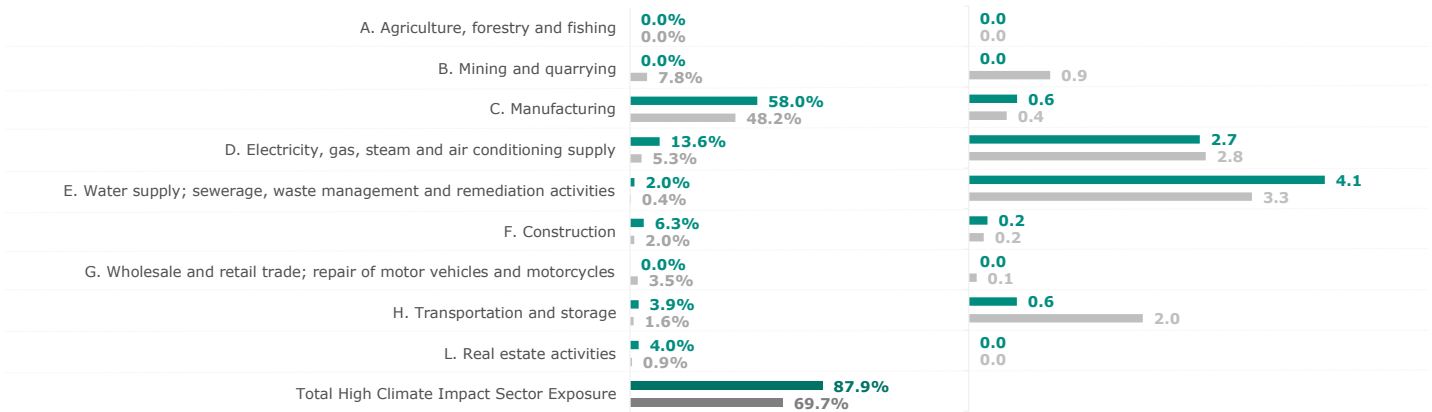

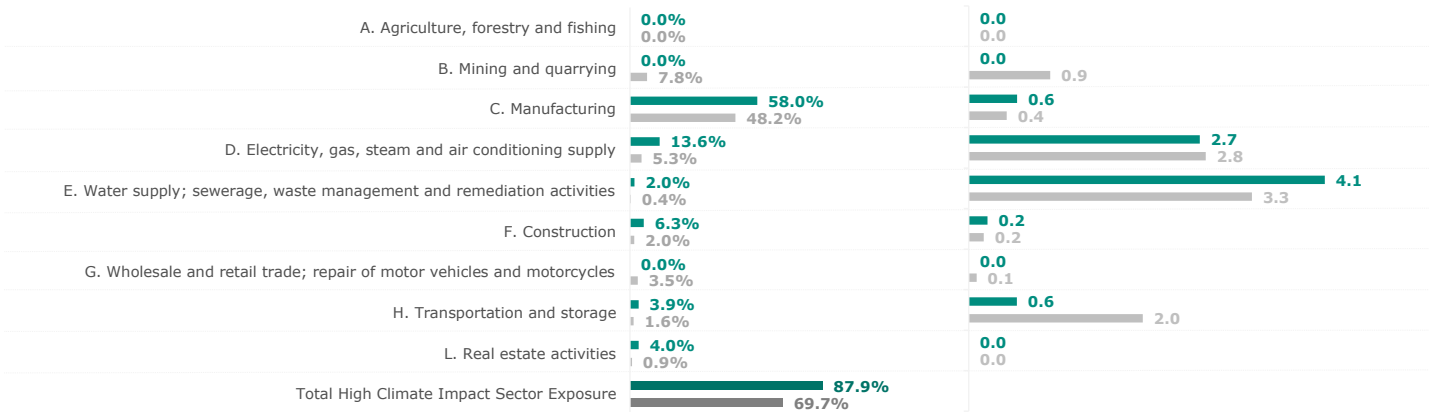

High Climate Impact Sectors Exposure (NACE)



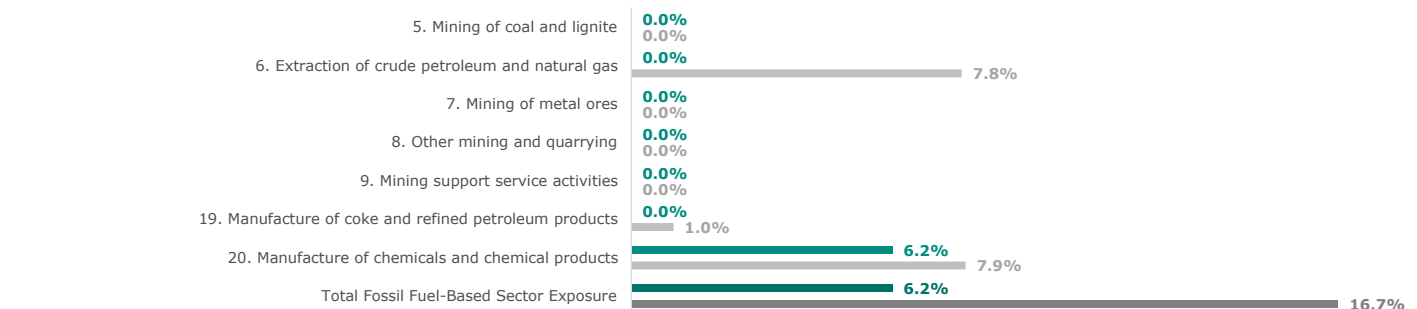

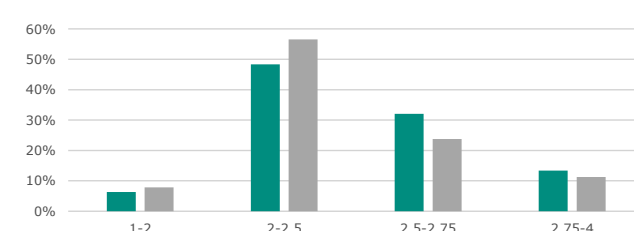

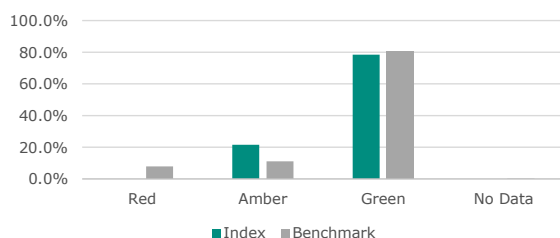

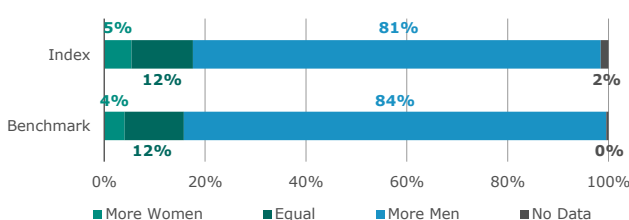

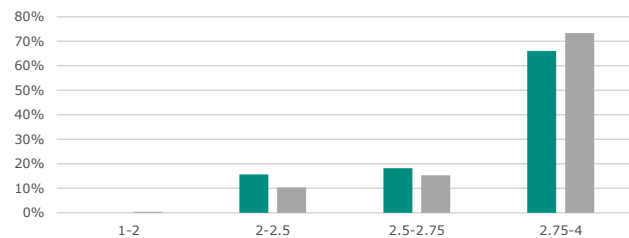

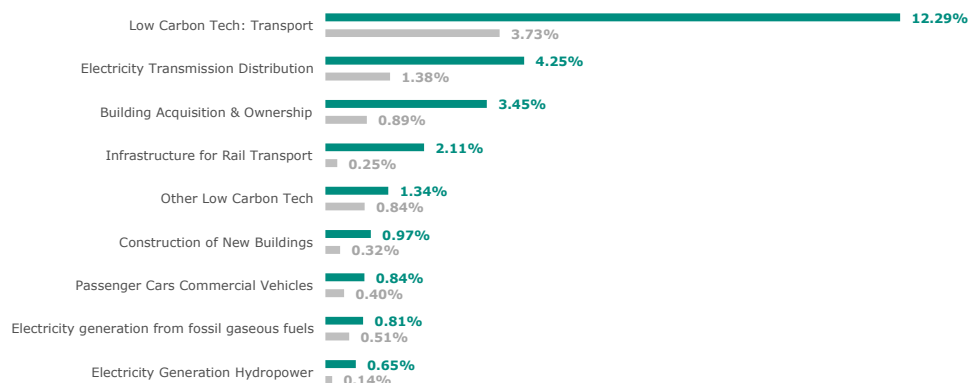

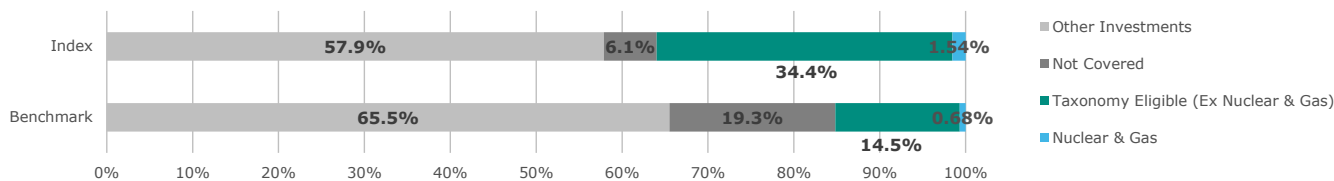
