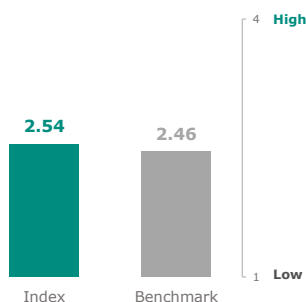
Objective

The Euronext® Core Europe PAB 50 index selects the 50 best stocks in terms of free float market capitalisation included in selected markets of Euronext® Eurozone 300 index, companies involved in controversial weapons, production of tobacco, involved in coal, oil, natural gas and electricity producers with lifecycle GHG Emissions higher than 100Gco2/kWh and the 30 worst ESG scores are excluded from the universe. Euronext® Core Europe PAB 50 index meets the requirement of the "EU Paris-aligned Benchmarks" (PAB). The index serves as an underlying for structured products, funds and exchange traded funds. 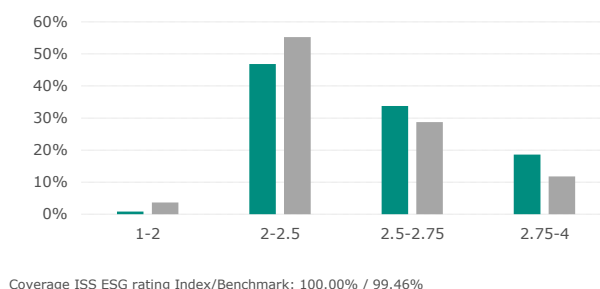

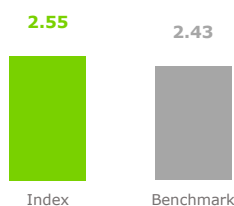
Weighted average ESG rating



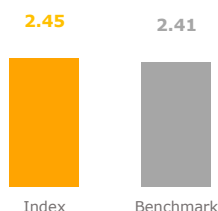
ESG score distribution



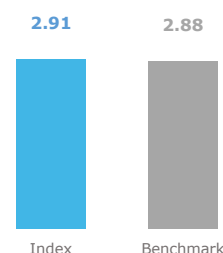

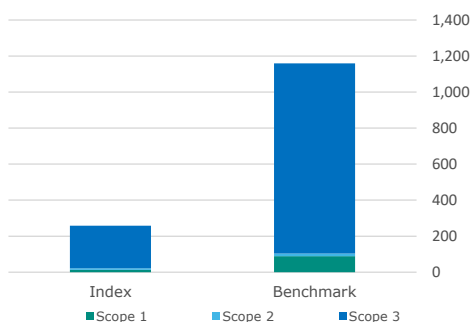

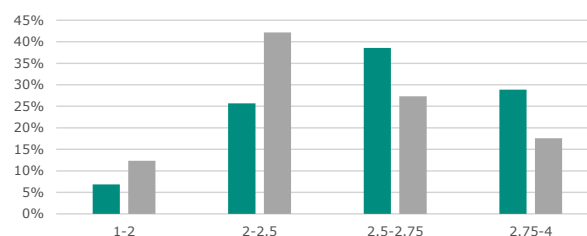

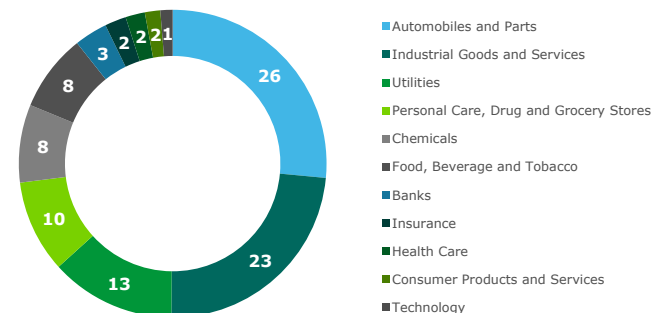
Carbon footprint

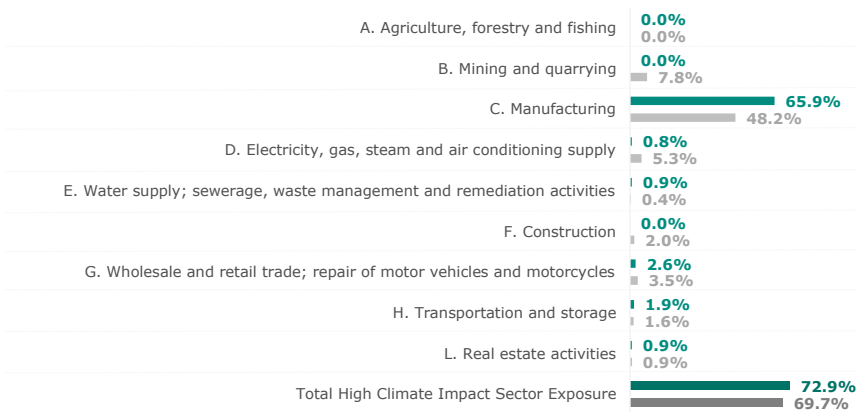

The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 99.07% of the total weight of the index, 98.54% for the benchmark.

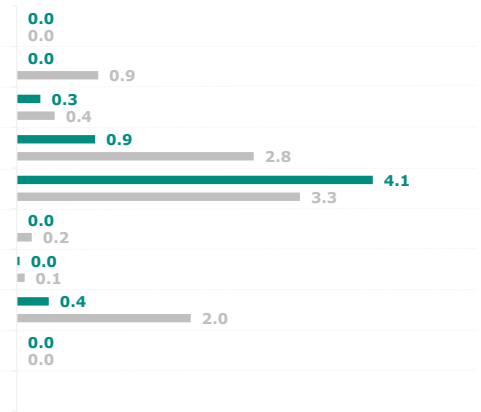

High Climate Impact Sectors Exposure (NACE)



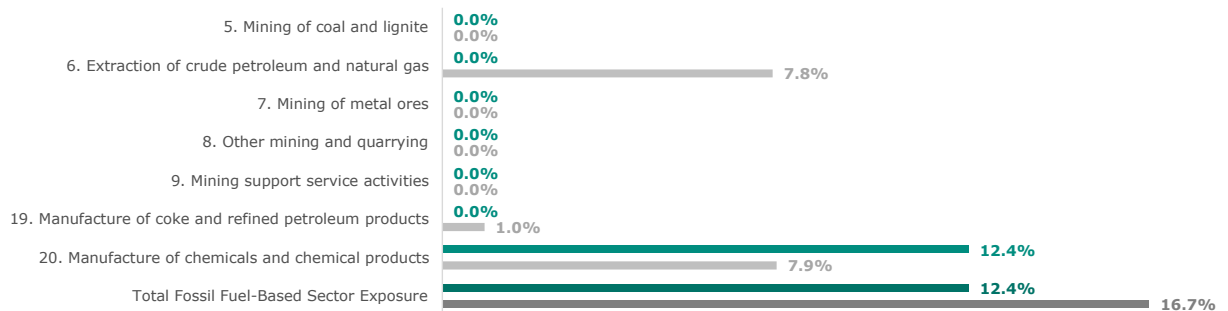

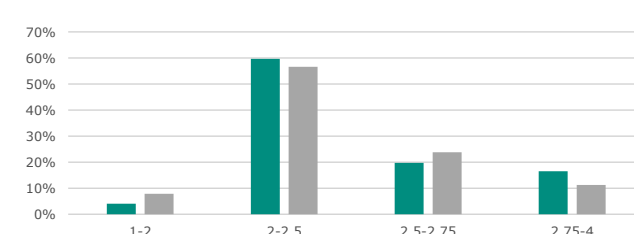

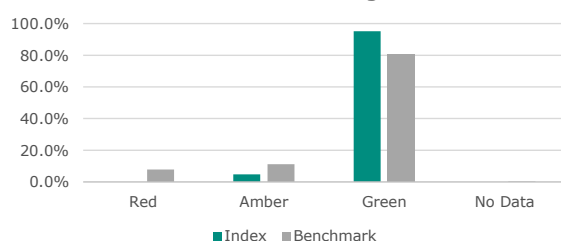

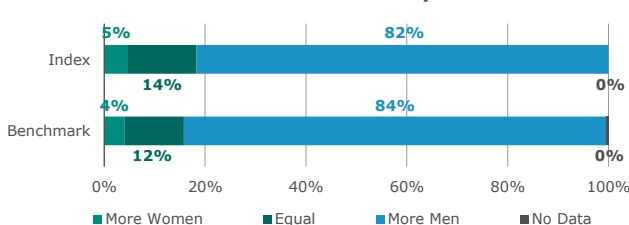

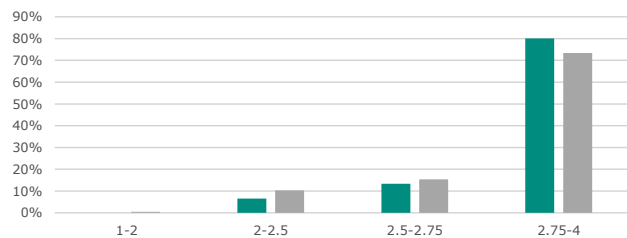

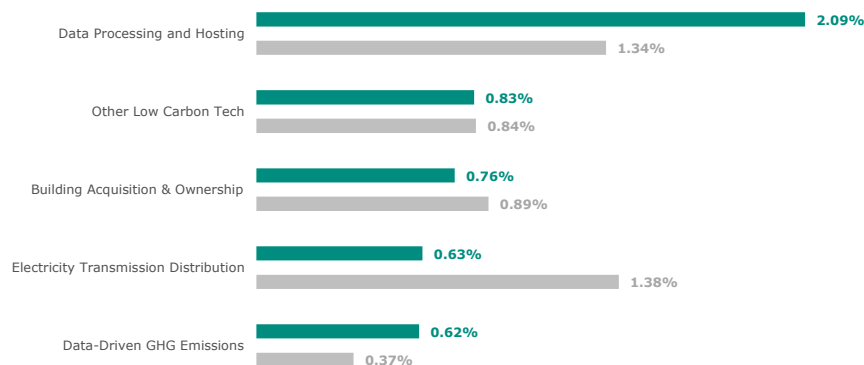

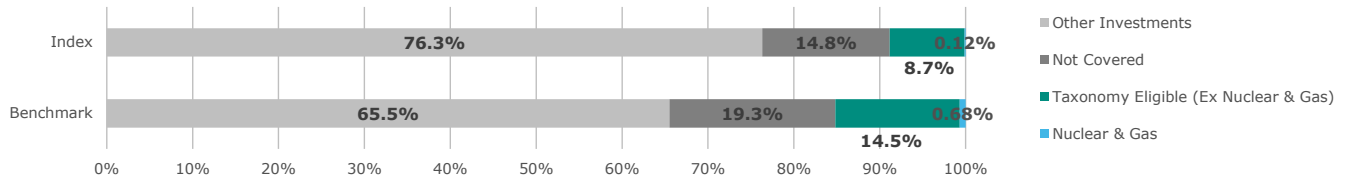
