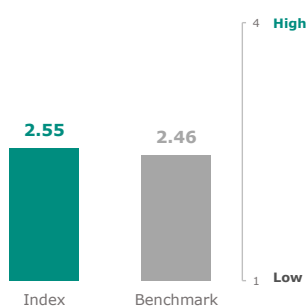
## Objective

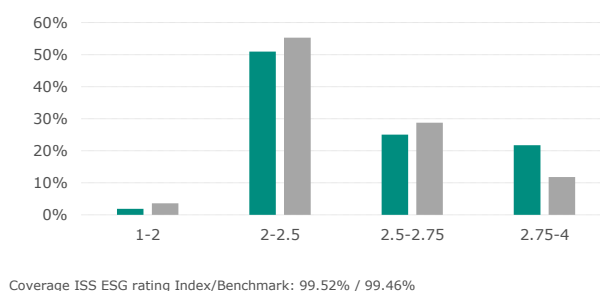

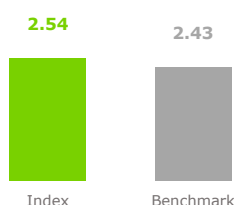
**Weighted average ESG rating**



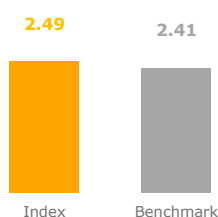
**ESG score distribution**



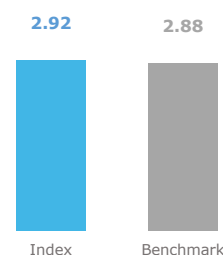

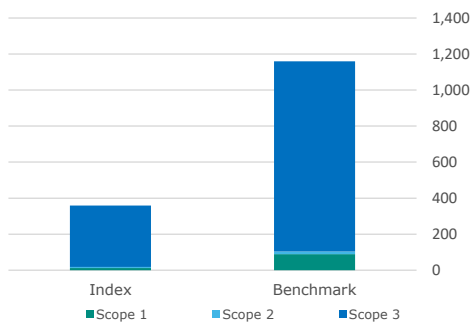

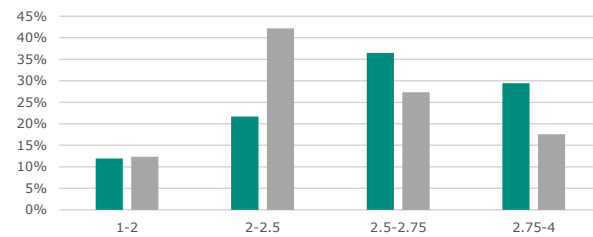

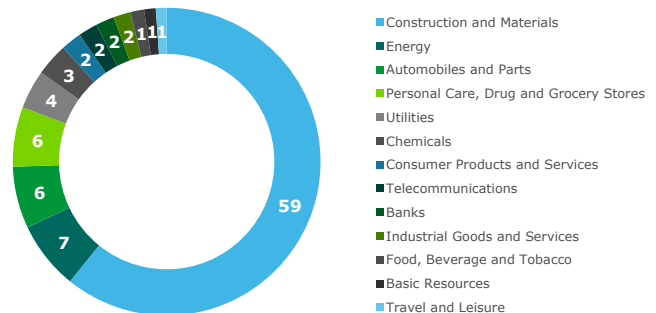
### Carbon footprint

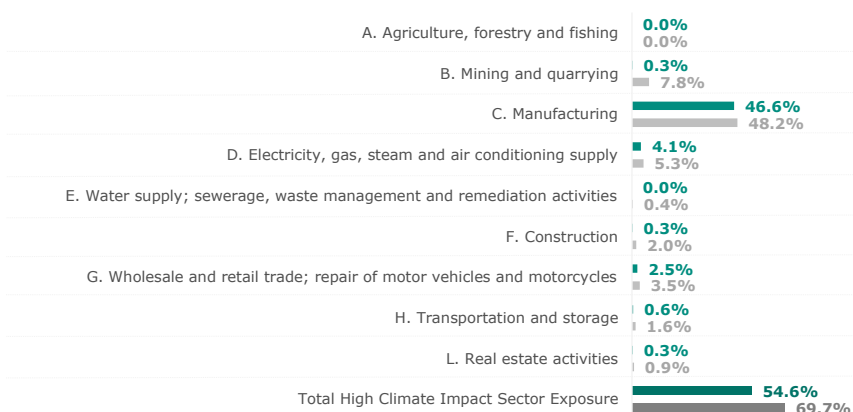

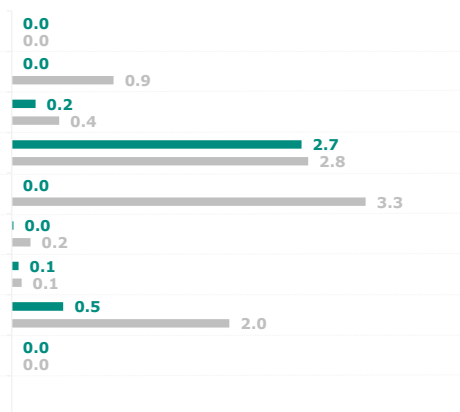

## High Climate Impact Sectors Exposure (NACE)



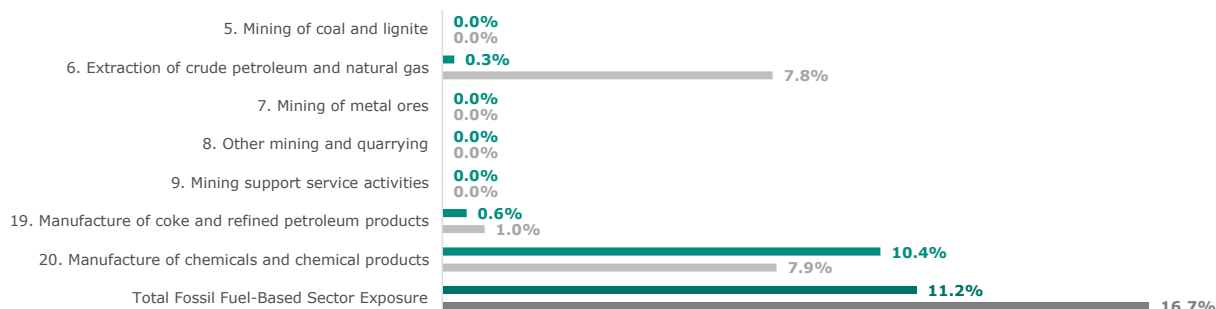

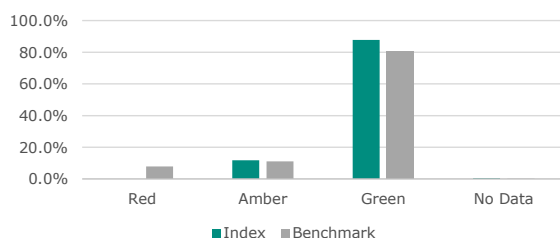

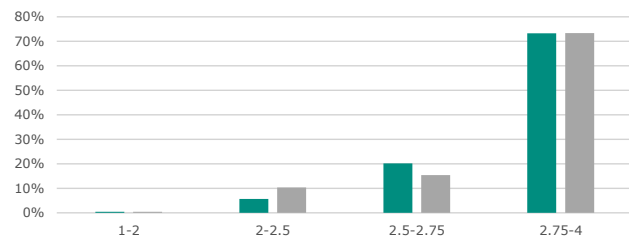

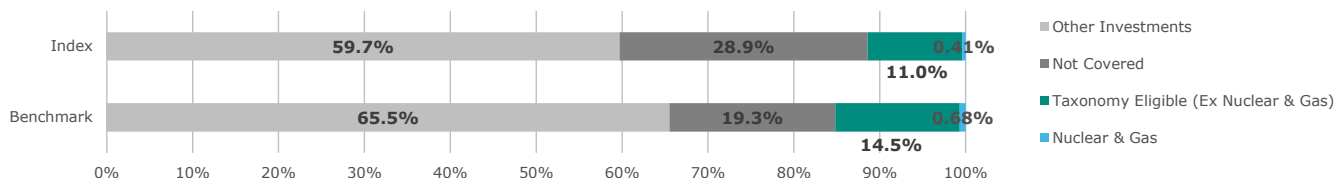
### Top Eligible Activities of the Index (%)

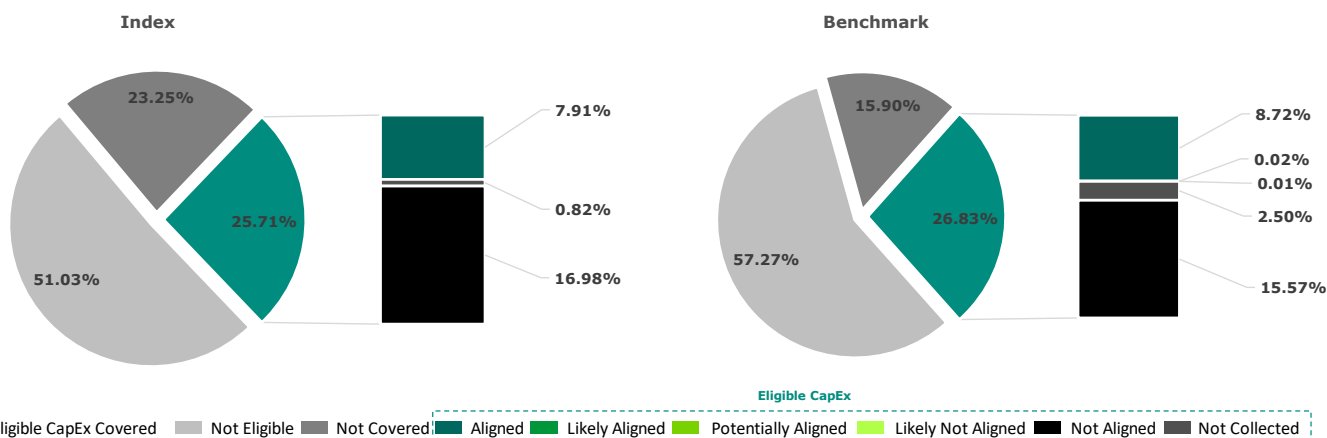

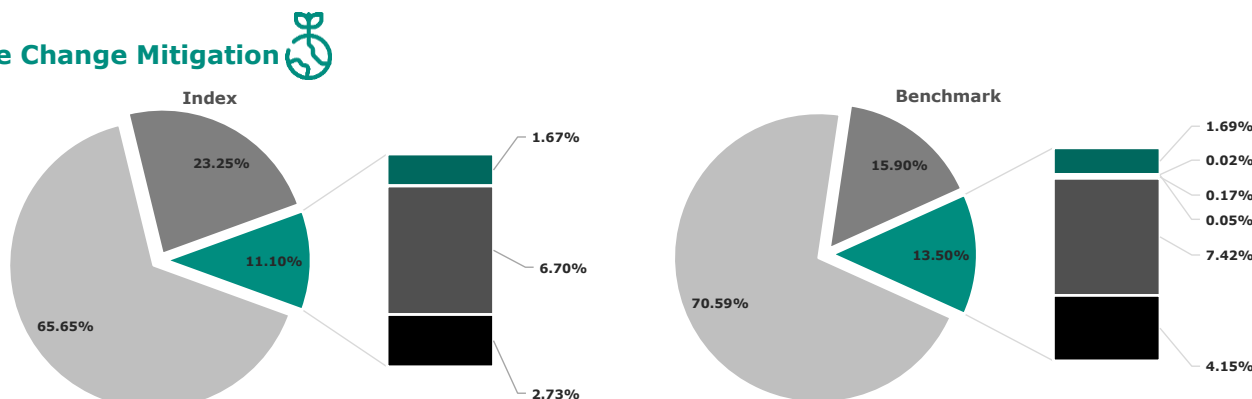

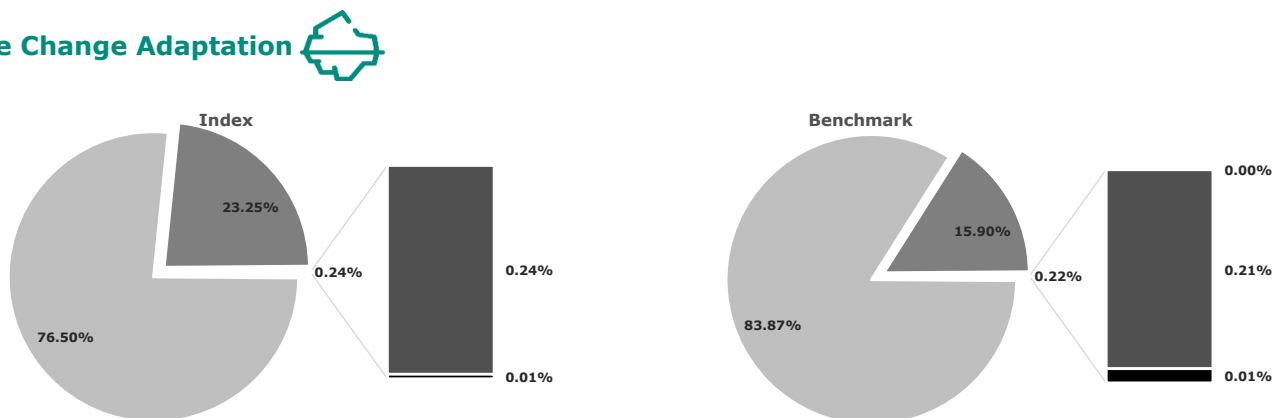
