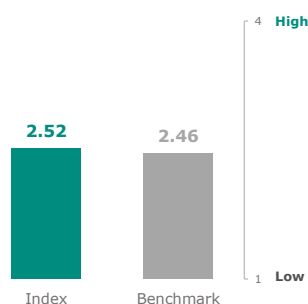
Objective

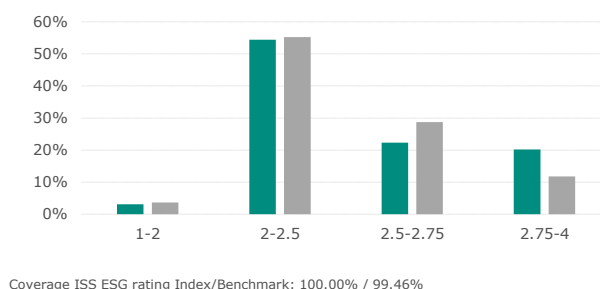

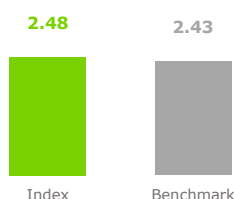
Weighted average ESG rating



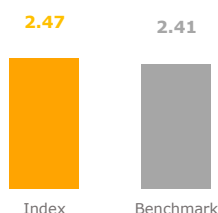
ESG score distribution



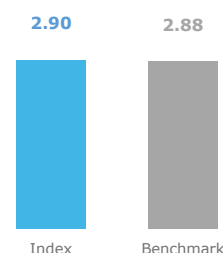

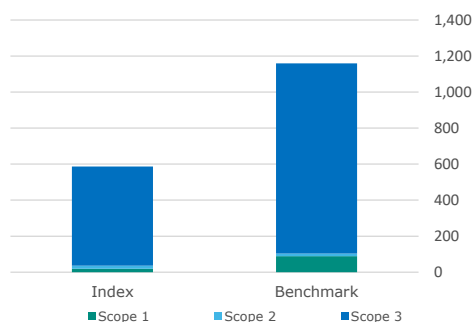

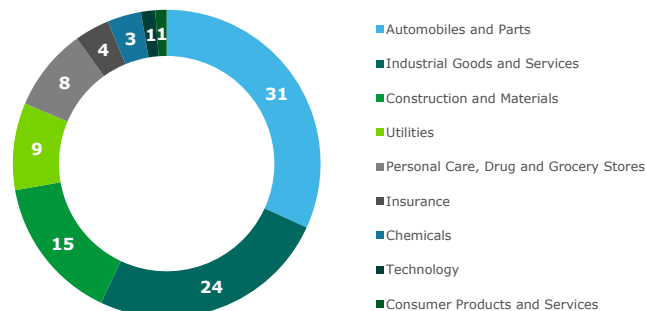

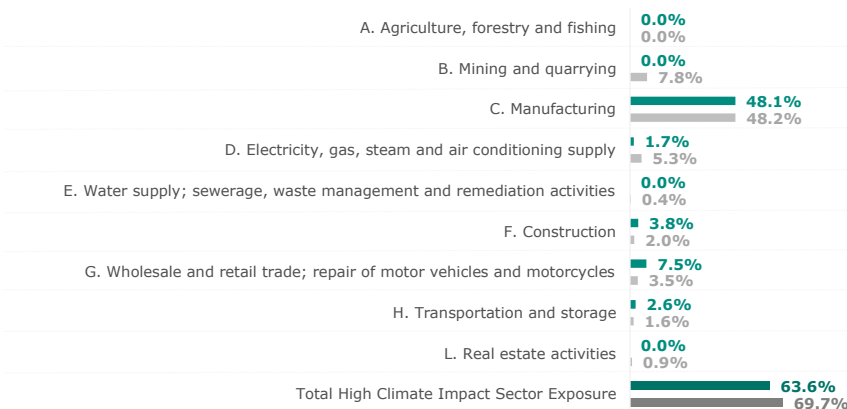

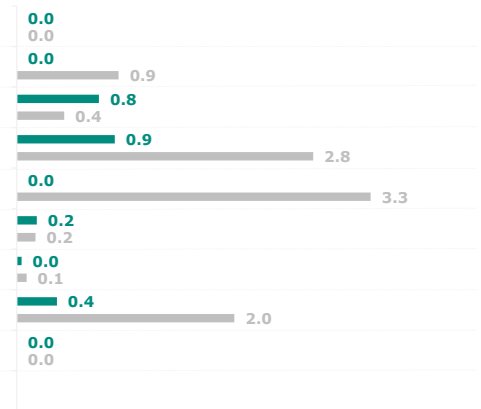

High Climate Impact Sectors Exposure (NACE)



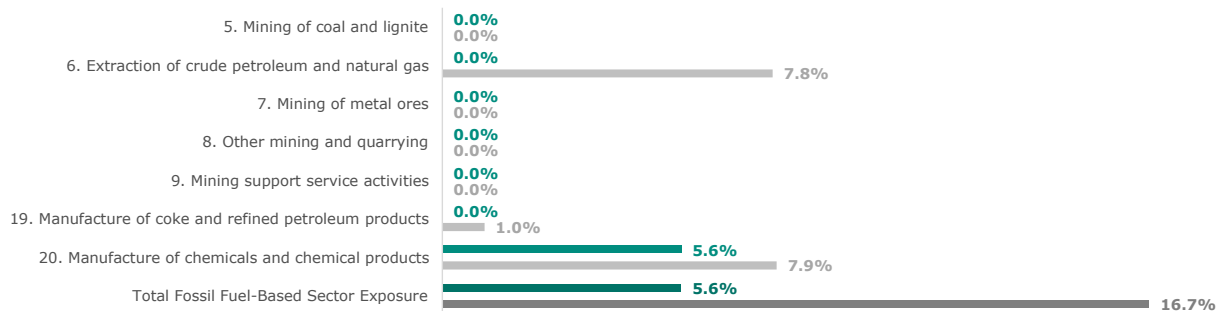

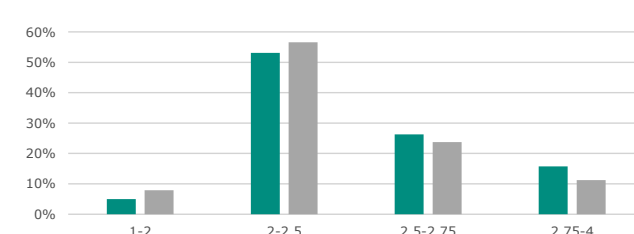

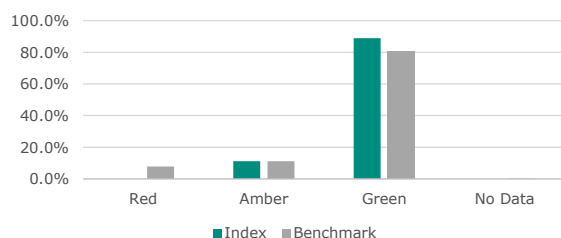

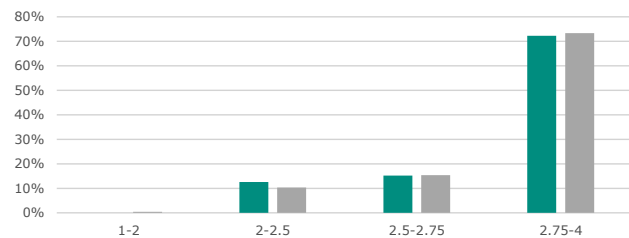

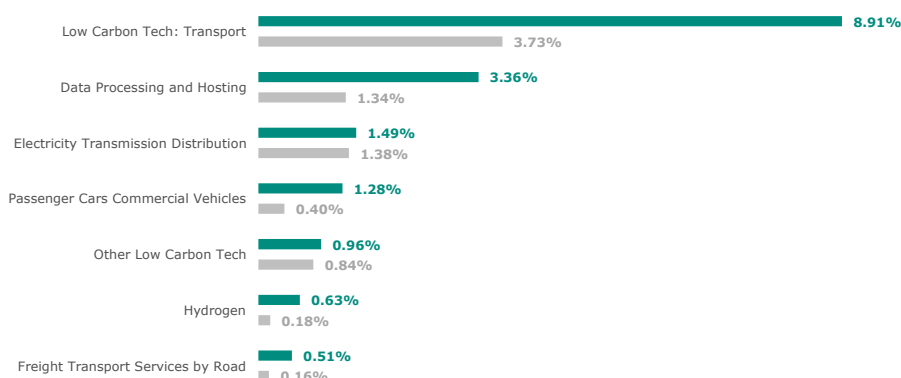

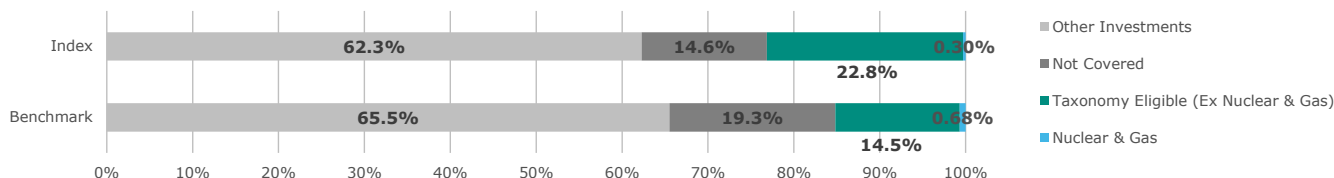
