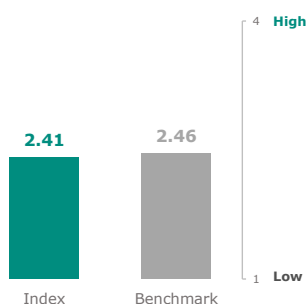
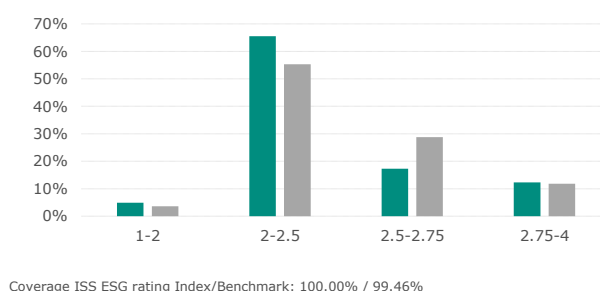

Objective

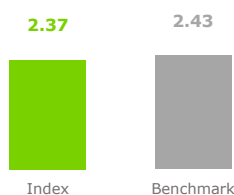
The Euronext® Eurozone Screened Climate Ambition 40 EW index selects the 150 companies with the highest Free Float Market capitalisation of Euronext® Eurozone 300 Index. Additional exclusion of companies' activity involvement and UNGC controversies. From the companies left in the universe after the exclusions, 75 companies having the lowest % Carbon Budget according to ISS-ESG are eligible, then the 40 highest-ranking in terms of Free Float Market capitalisation are selected. Euronext® Eurozone Screened Climate Ambition 40 EW index is an equal-weighted index. The index serves as an underlying for structured products, funds and exchange traded funds. 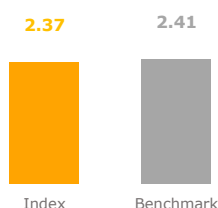

ESG score distribution


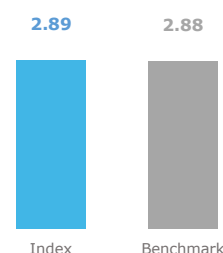

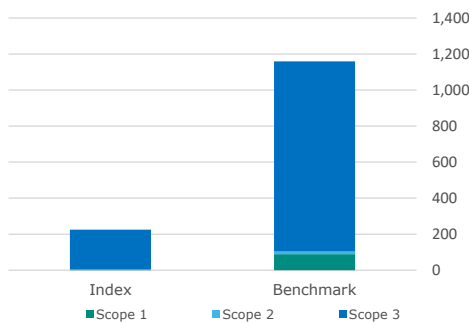

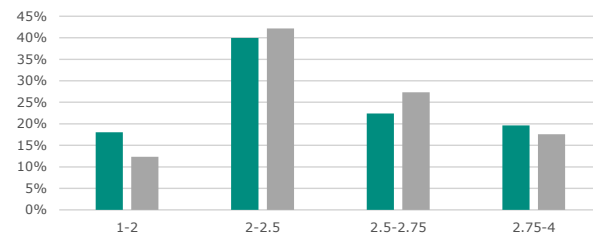

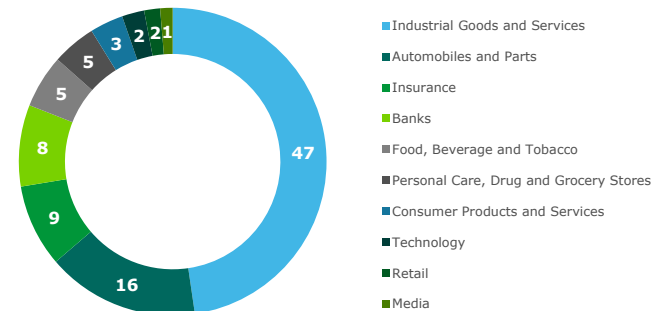
Carbon footprint

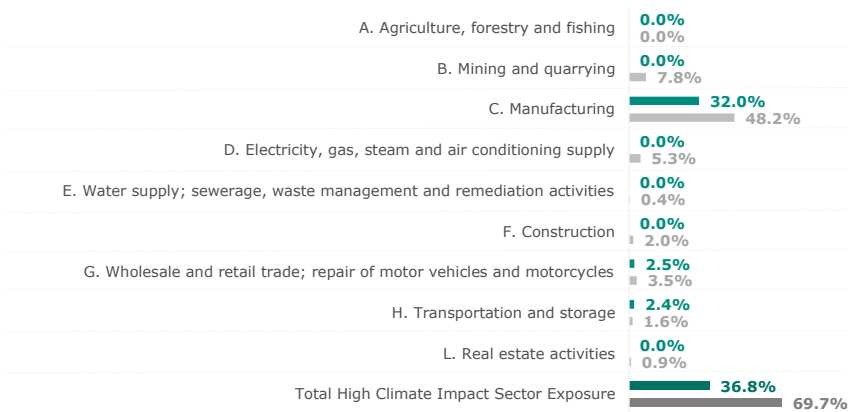

High Climate Impact Sectors Exposure (NACE)



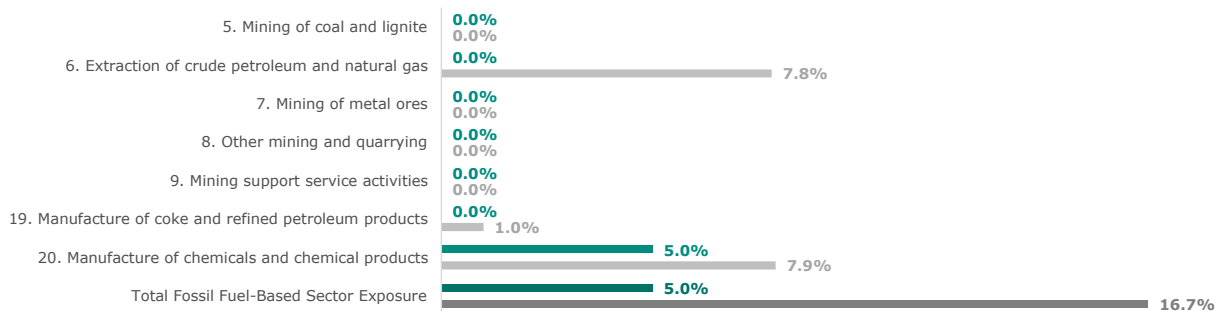

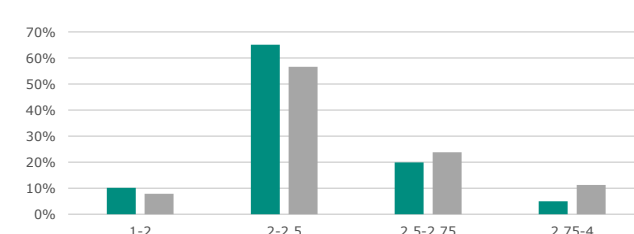

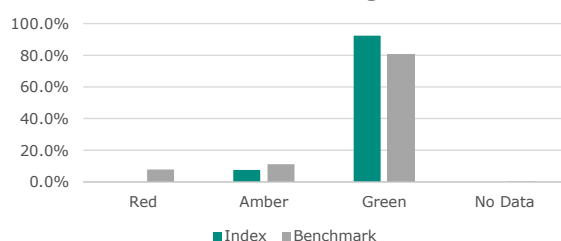

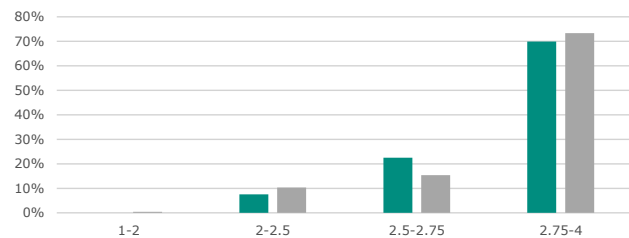

The EU Taxonomy Alignment report evaluates a portfolio's levels of alignment against the six climate and environmental related objectives set out by the regulatory text, by determining investee companies' involvement in Taxonomy eligible economic activities, quantifying the respective revenues from these activities, and subsequently applying the three technical assessment steps of Substantial Contribution, Do No Significant Harm, and Minimum Social Safeguards. Currently, only the first two objectives are covered: Climate Change Mitigation and Climate Change Adaptation.

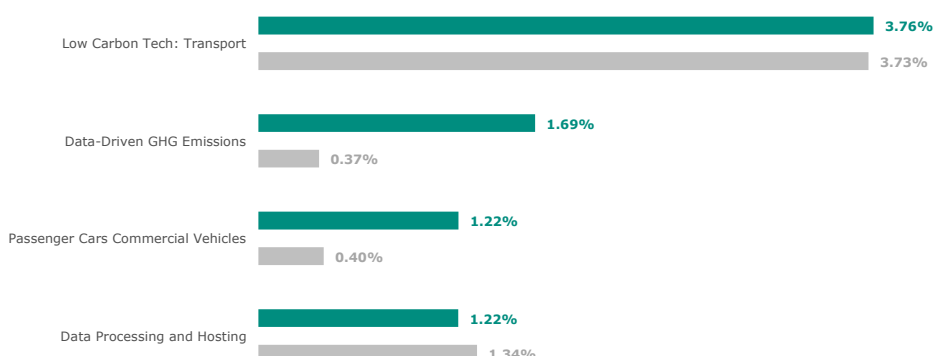

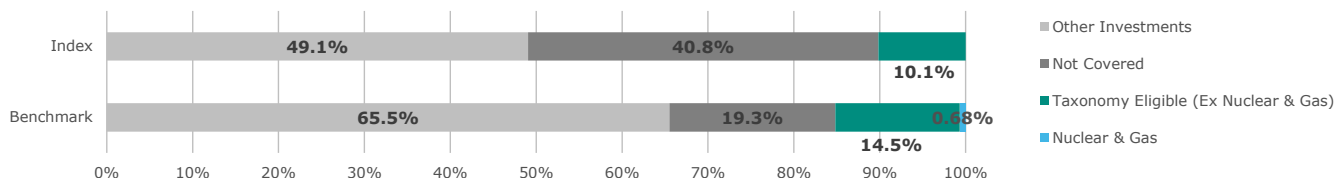
Top Eligible Activities of the Index (%)

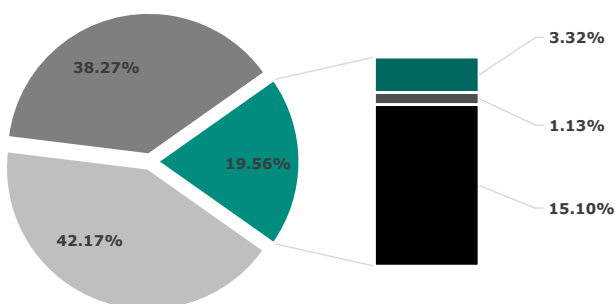

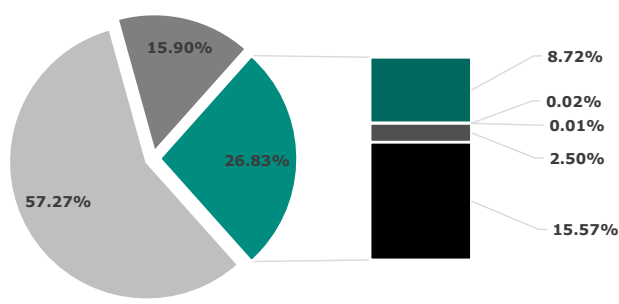
Eligible Capital Expenditure Overview

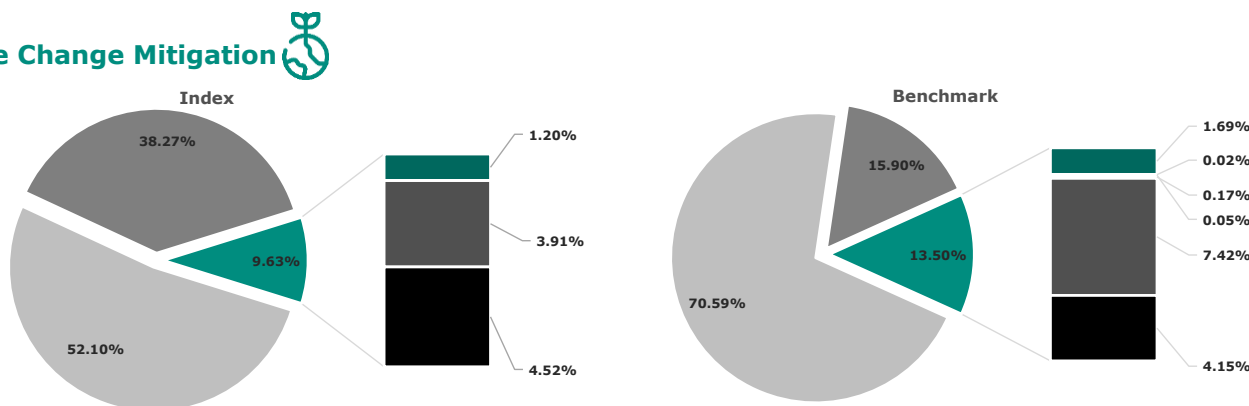

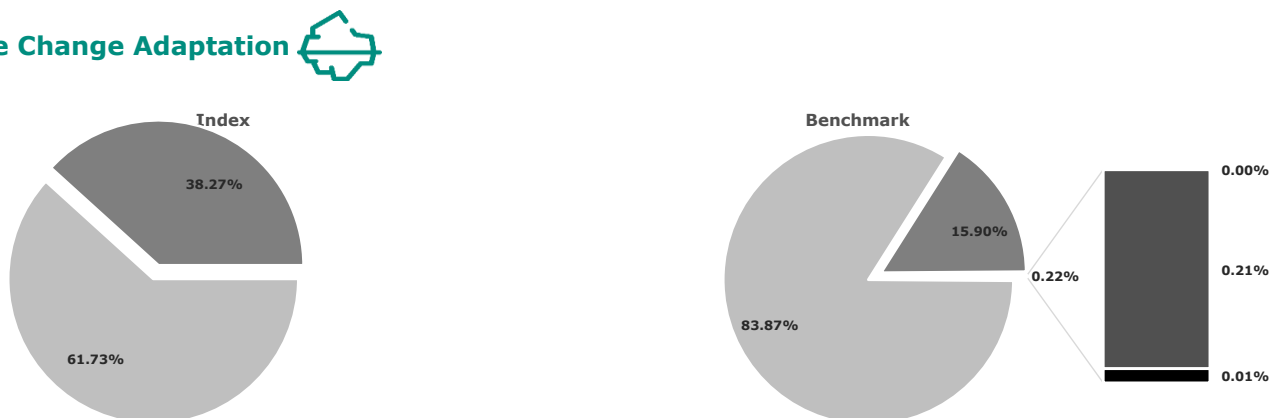
