Objective

The Euronext® PAB Transatlantic 50 index selects the top 50 companies included in the Euronext North America 500 index and Euronext Europe 500 index after exclusion of companies involved in controversial weapons, production of tobacco, coal, fossil fuel and with the worst SDG Climate Impact Ratings. Index weights are constructed using an optimization process that aims to achieve the PAB decarbonisation objectives while minimizing the weights' deviation relative to the Free Float Market Cap (FFMC) weights. The index rules are available on our website. Euronext acts as Supervisor. All our rulebooks can be found at:

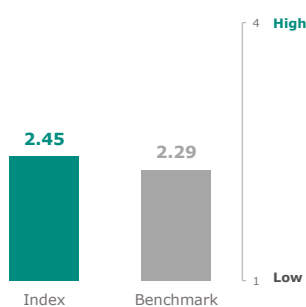

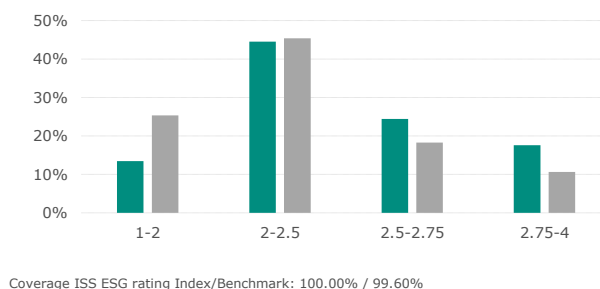

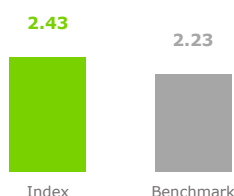
Weighted average ESG rating



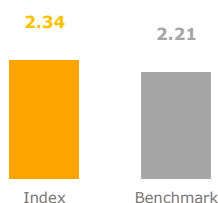
ESG score distribution



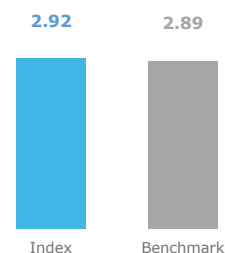

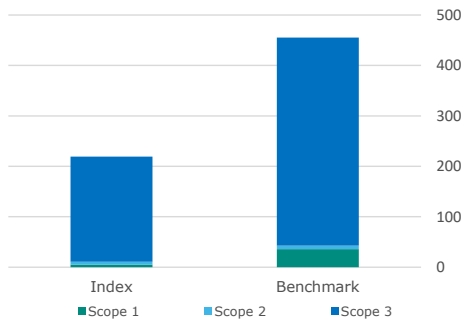

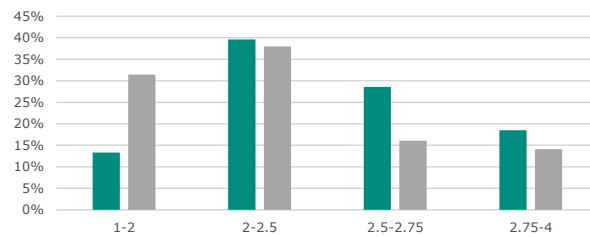

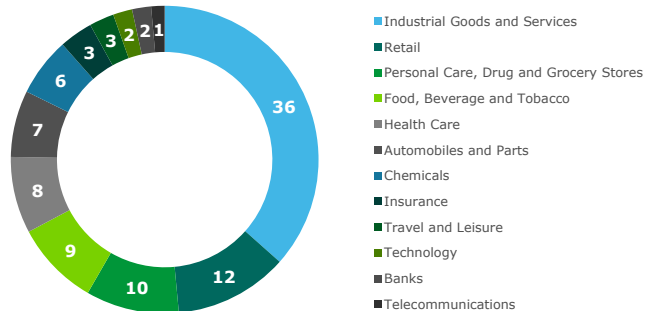
Carbon footprint

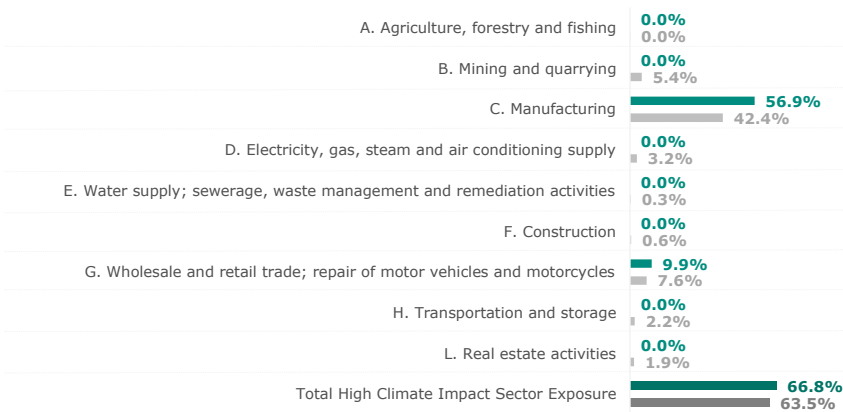

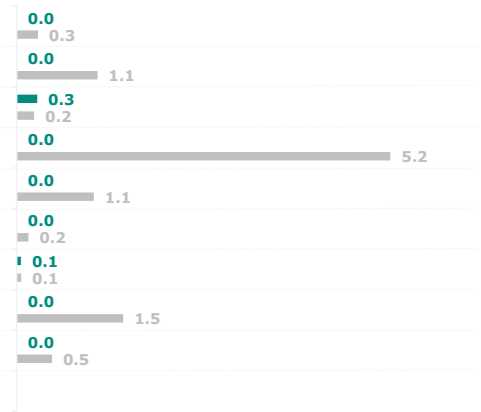

High Climate Impact Sectors Exposure (NACE)



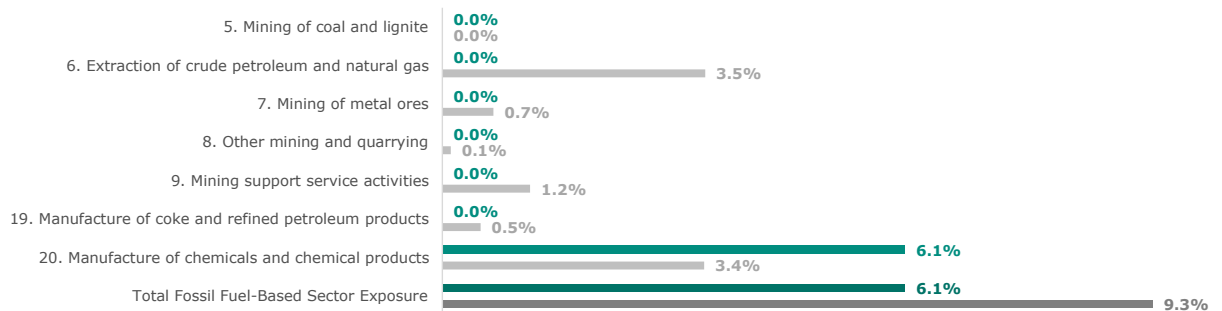

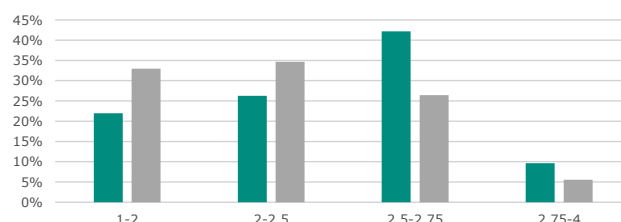

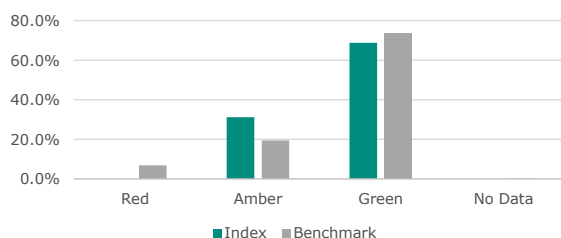

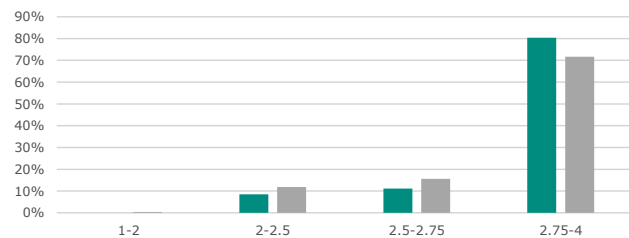

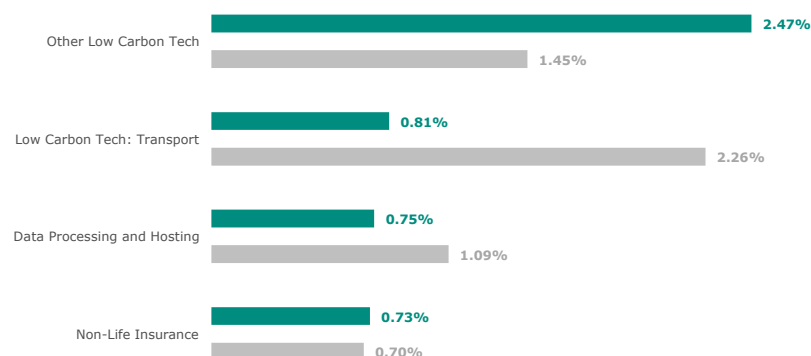

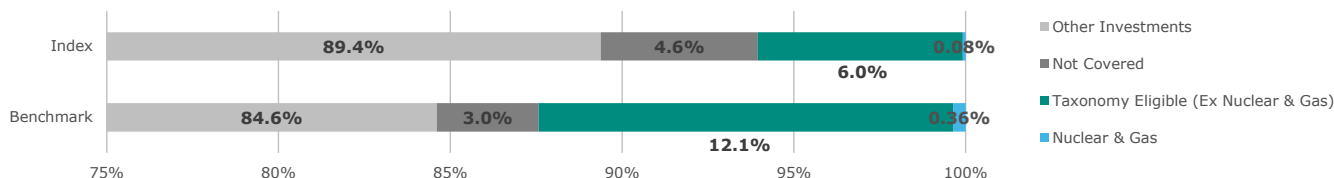
