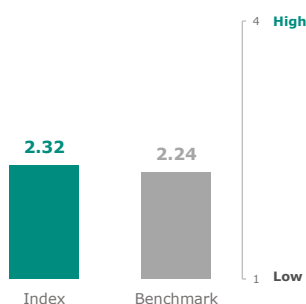
Objective

From the companies left in the universe after the exclusions, 35 companies with the highest Free Float Market capitalisation are selected. Euronext® US Screened Climate Ambition 35 EW index is an equal-weighted index. The index serves as an underlying for structured products, funds and exchange traded funds. 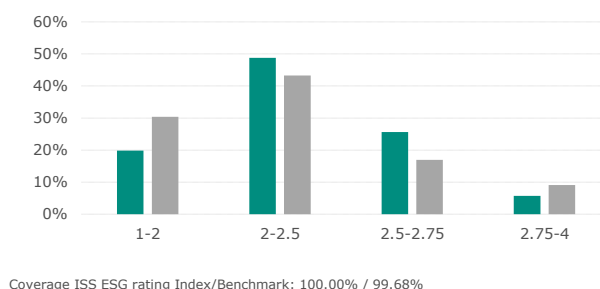

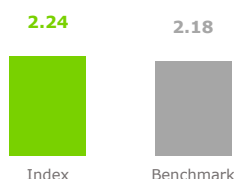
Weighted average ESG rating



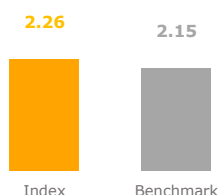
ESG score distribution



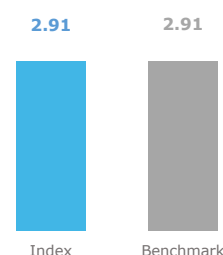

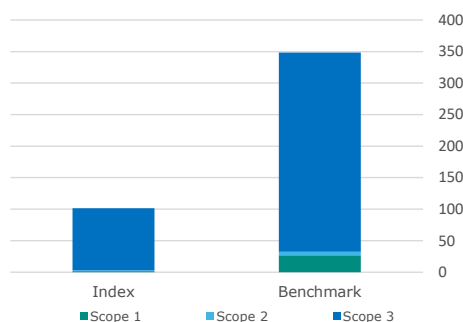

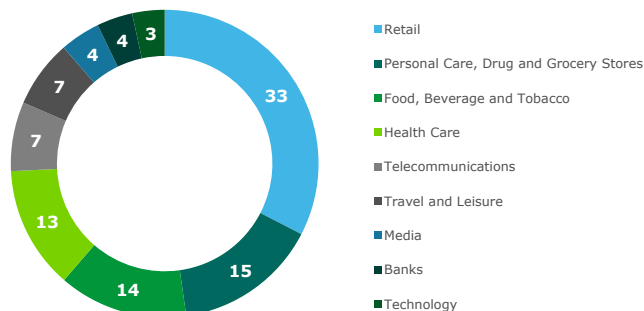

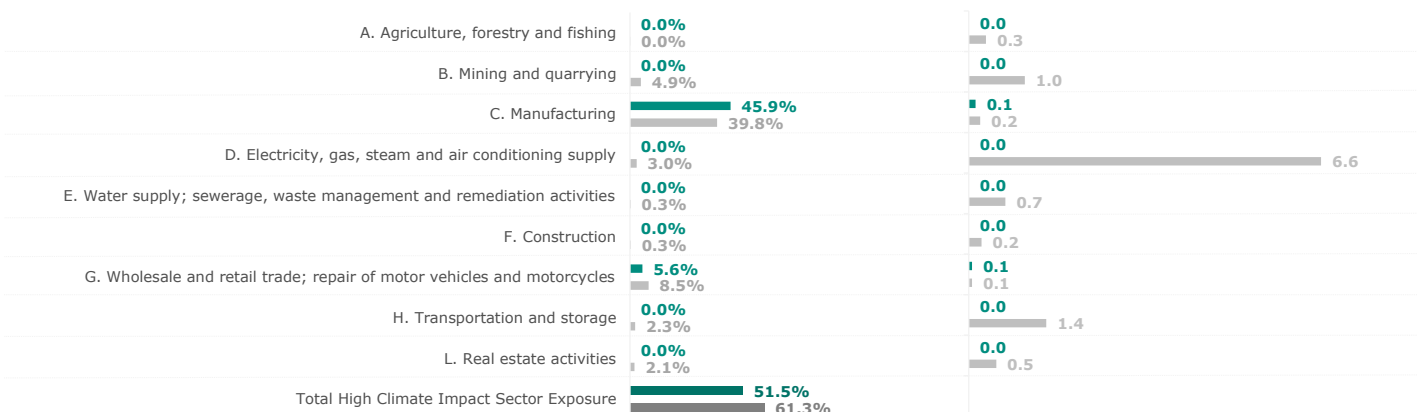

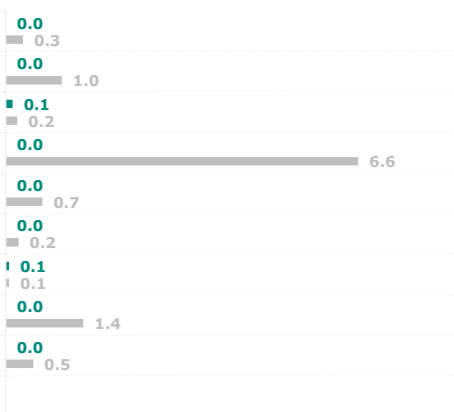

High Climate Impact Sectors Exposure (NACE)



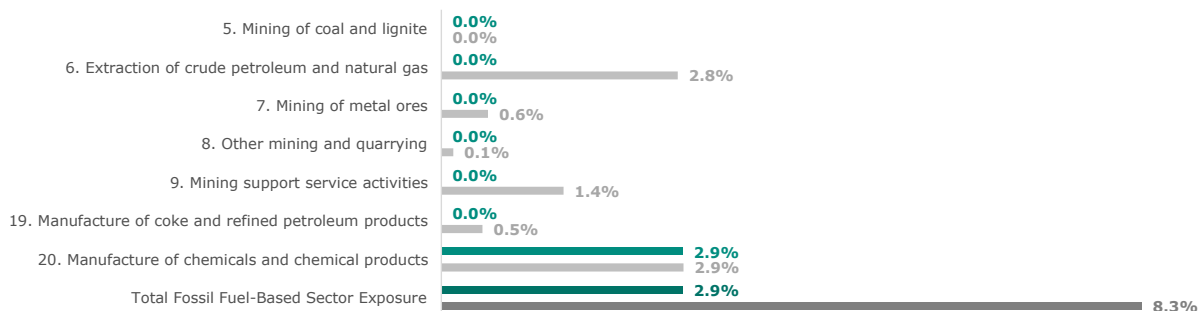

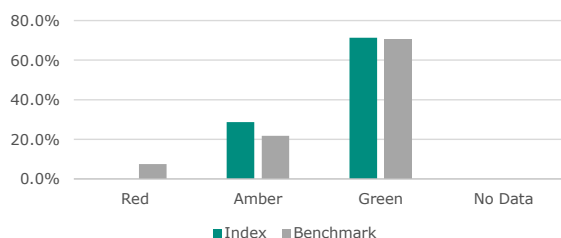

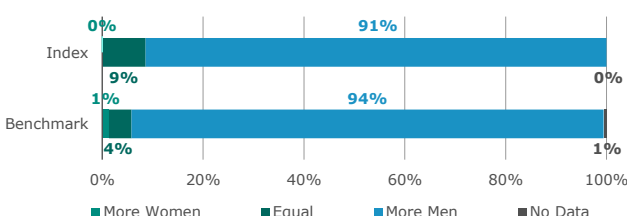

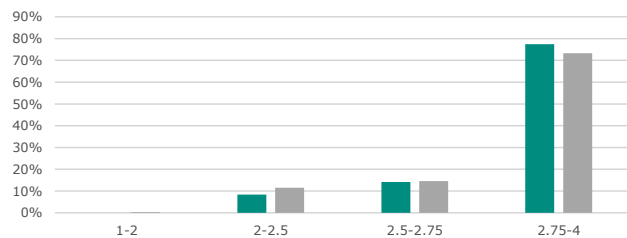

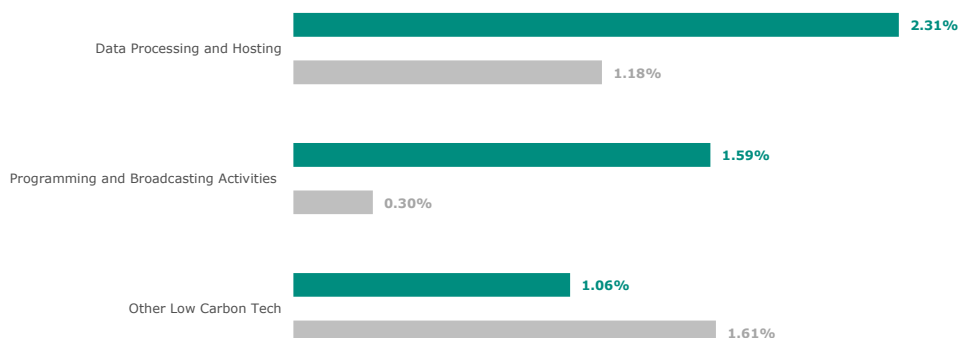

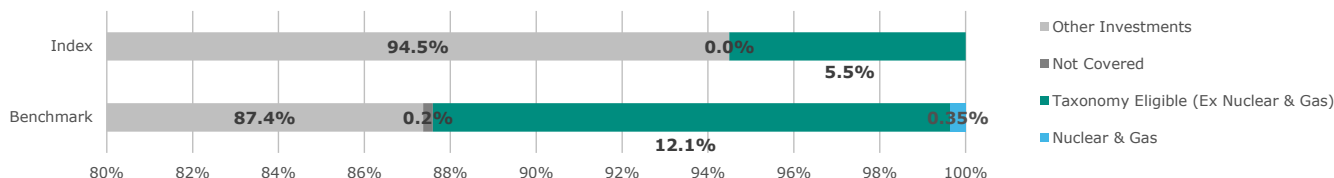
