The Environmental, Social and Governance risk rating is assessed by Sustainalytics.

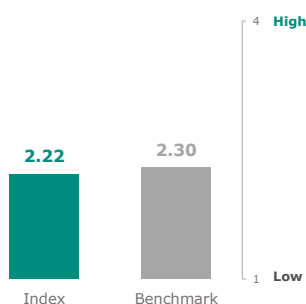

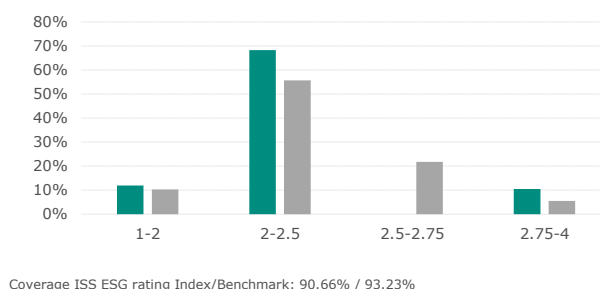

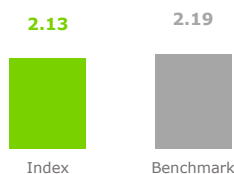
Weighted average ESG rating



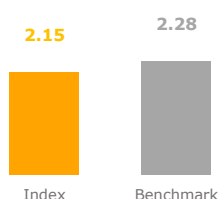
ESG score distribution



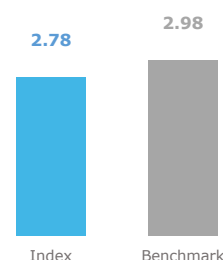

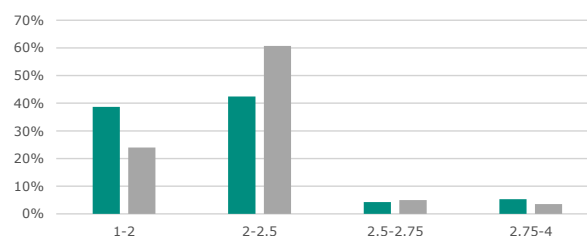

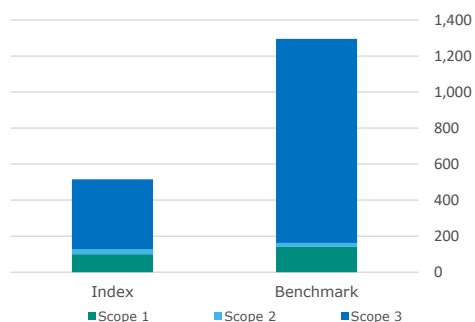
Environmental score distribution



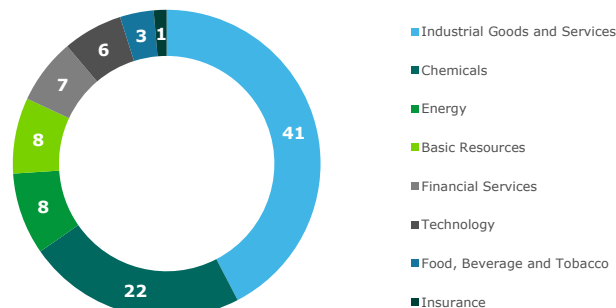

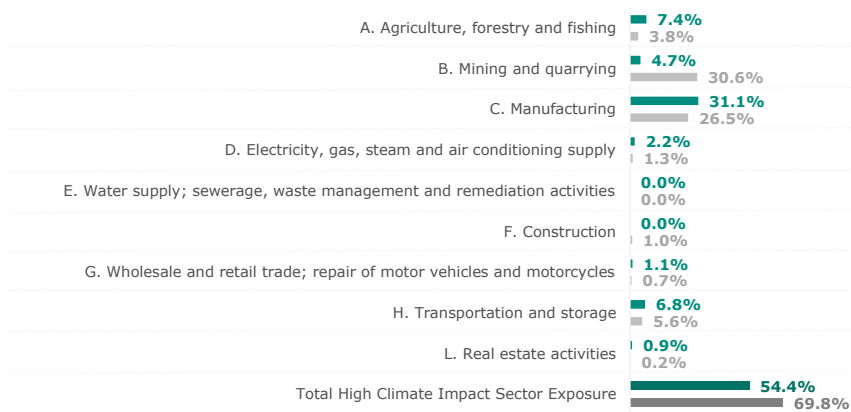

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 60.17% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 47.50% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 95.07% of the total weight of the index, 96.82% for the benchmark.

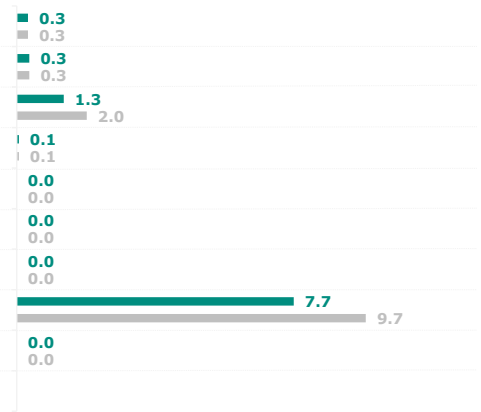

High Climate Impact Sectors Exposure (NACE)



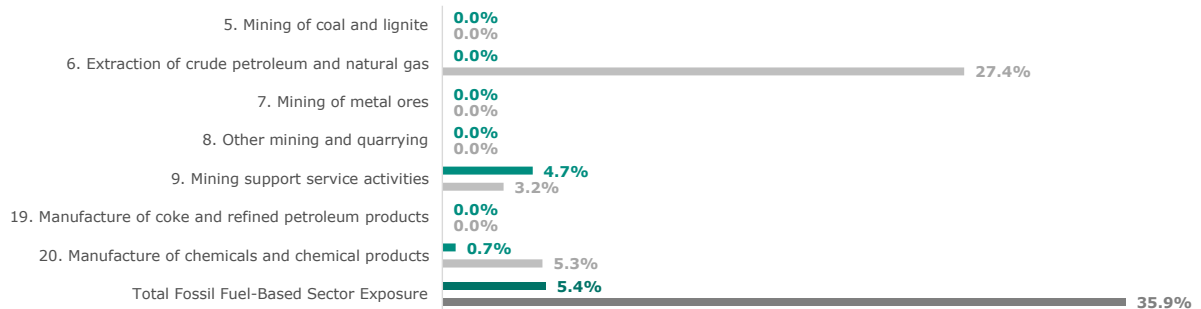

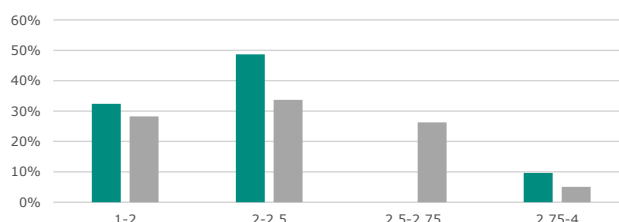

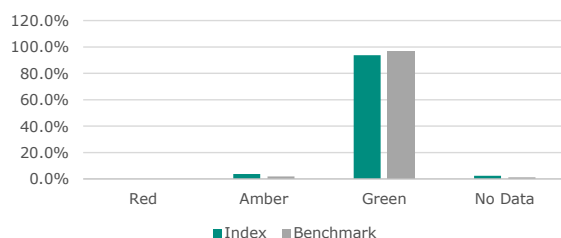

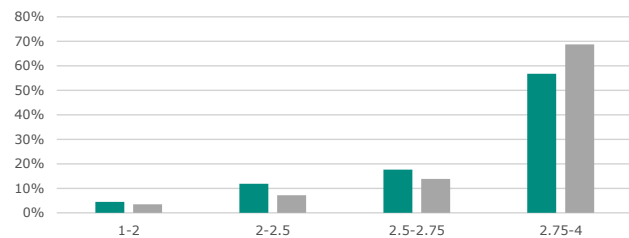

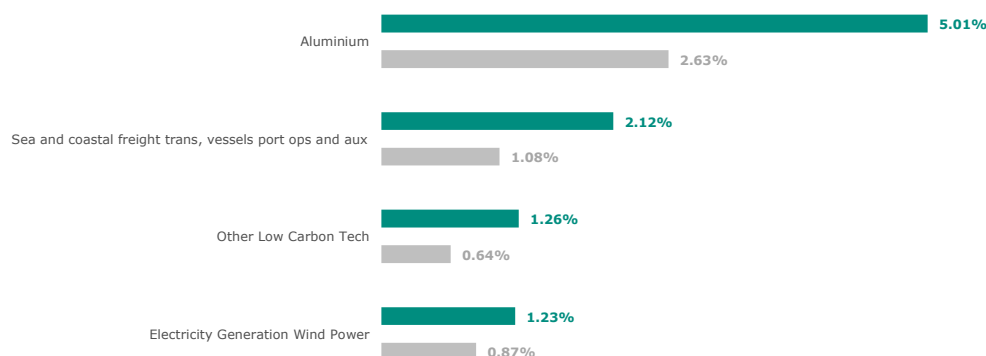

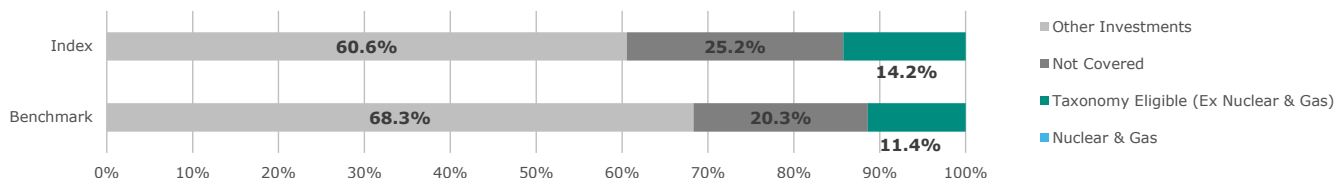

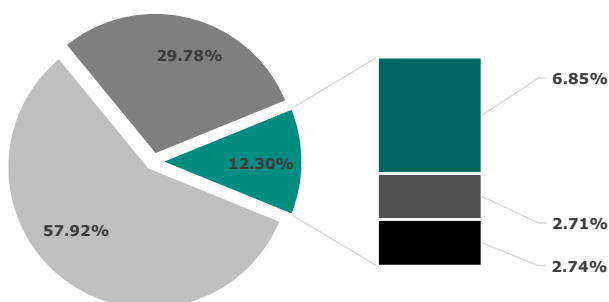

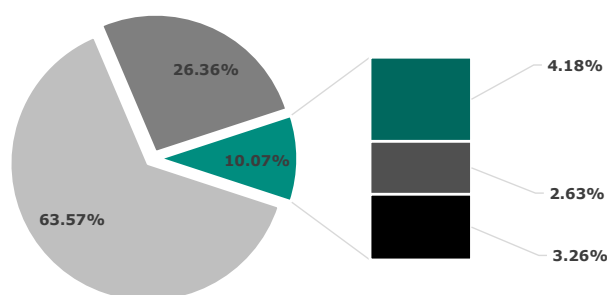
Eligible Capital Expenditure Overview

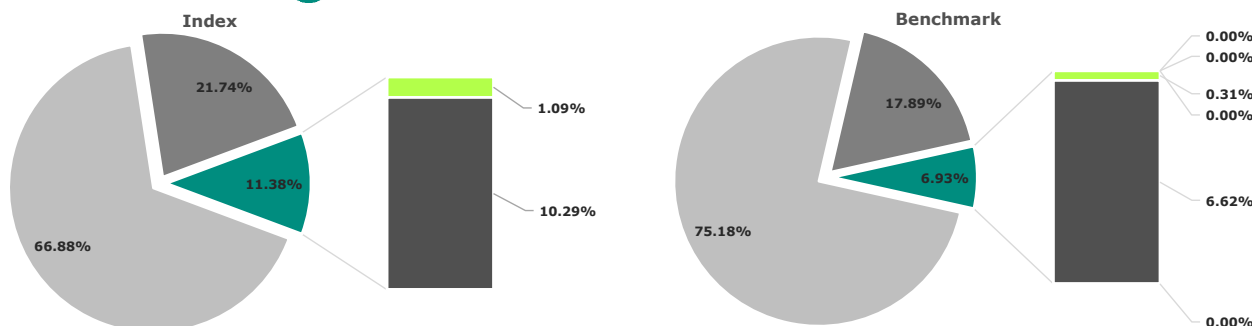
