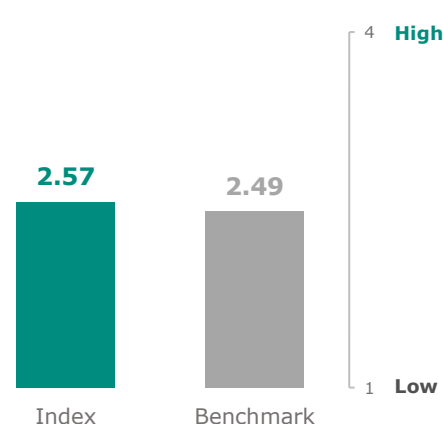

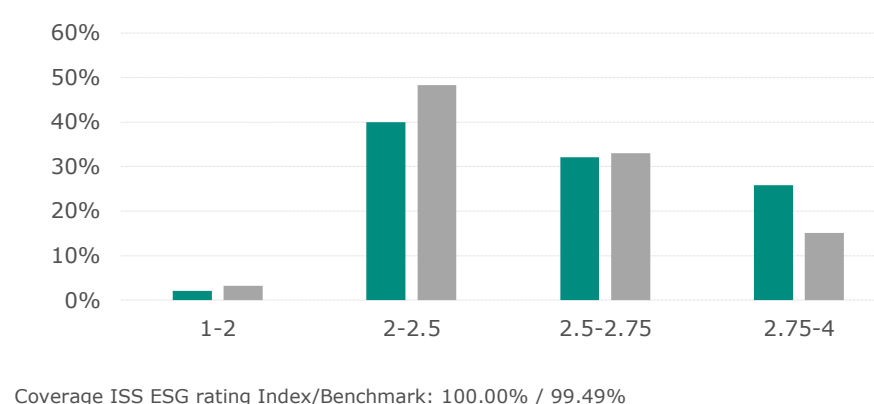

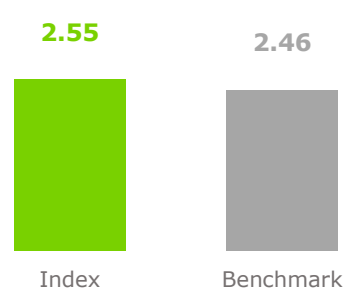
Weighted average ESG rating



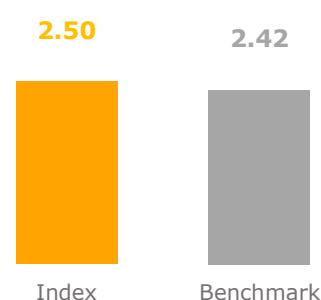
ESG score distribution



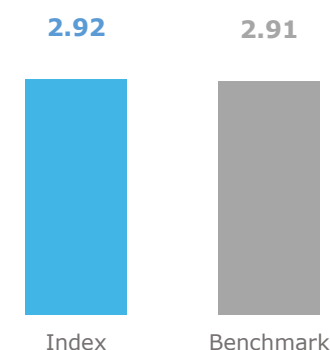

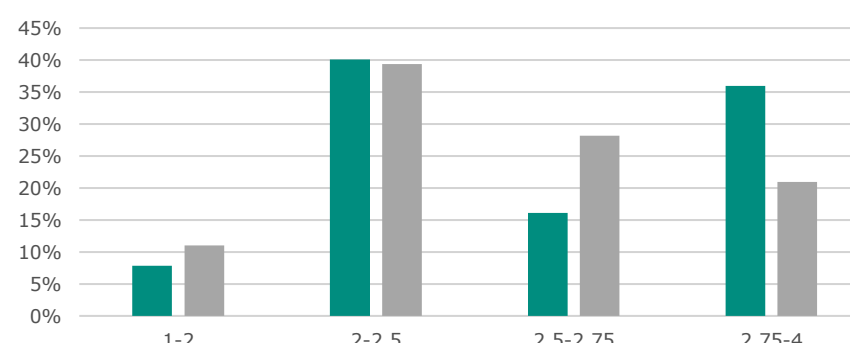

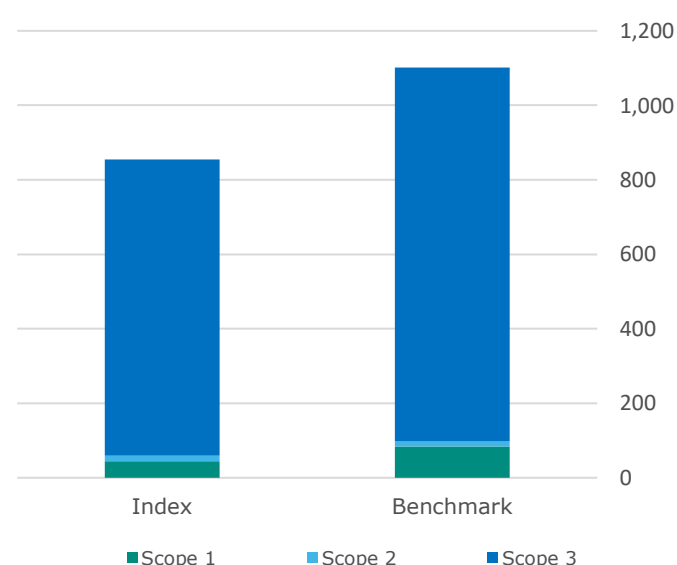
Environmental score distribution



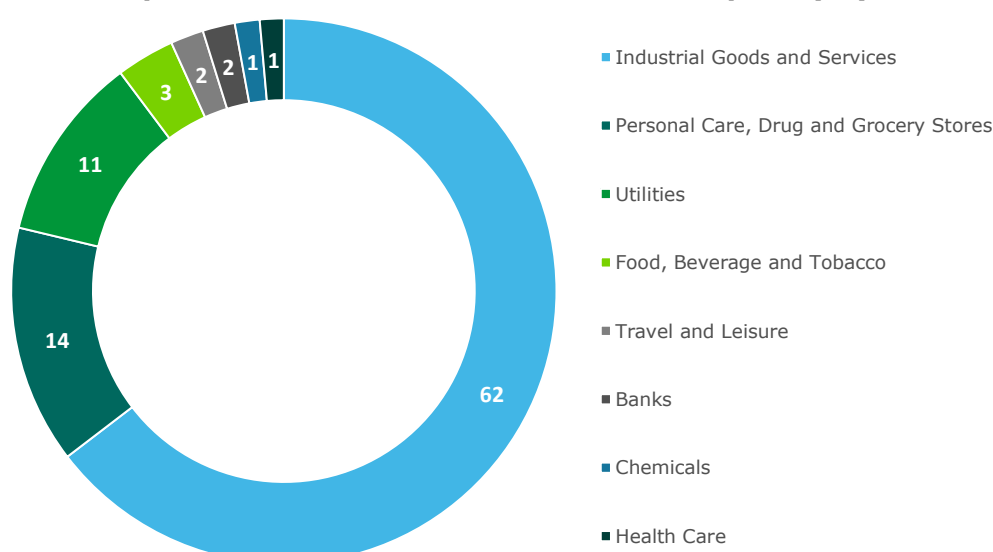

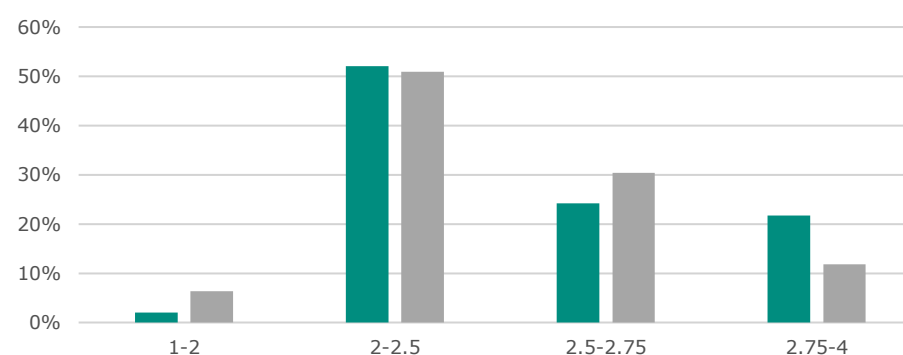

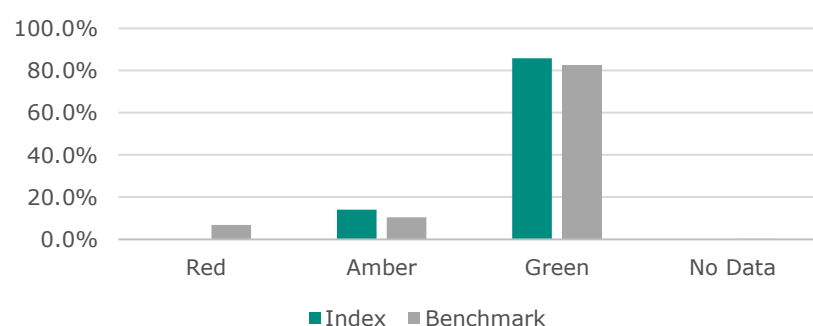

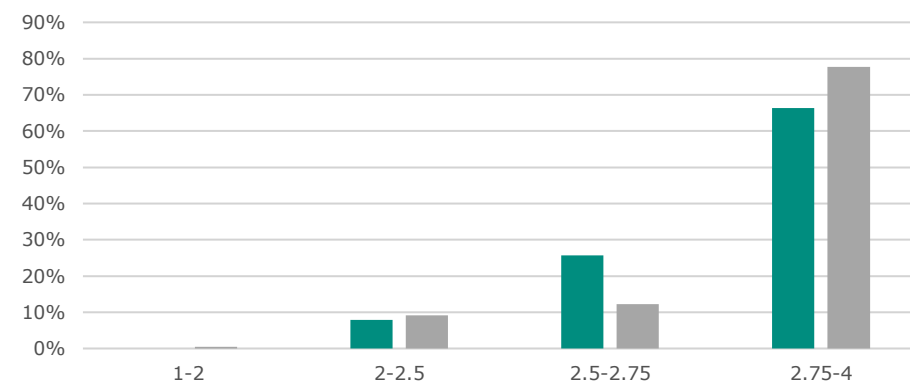

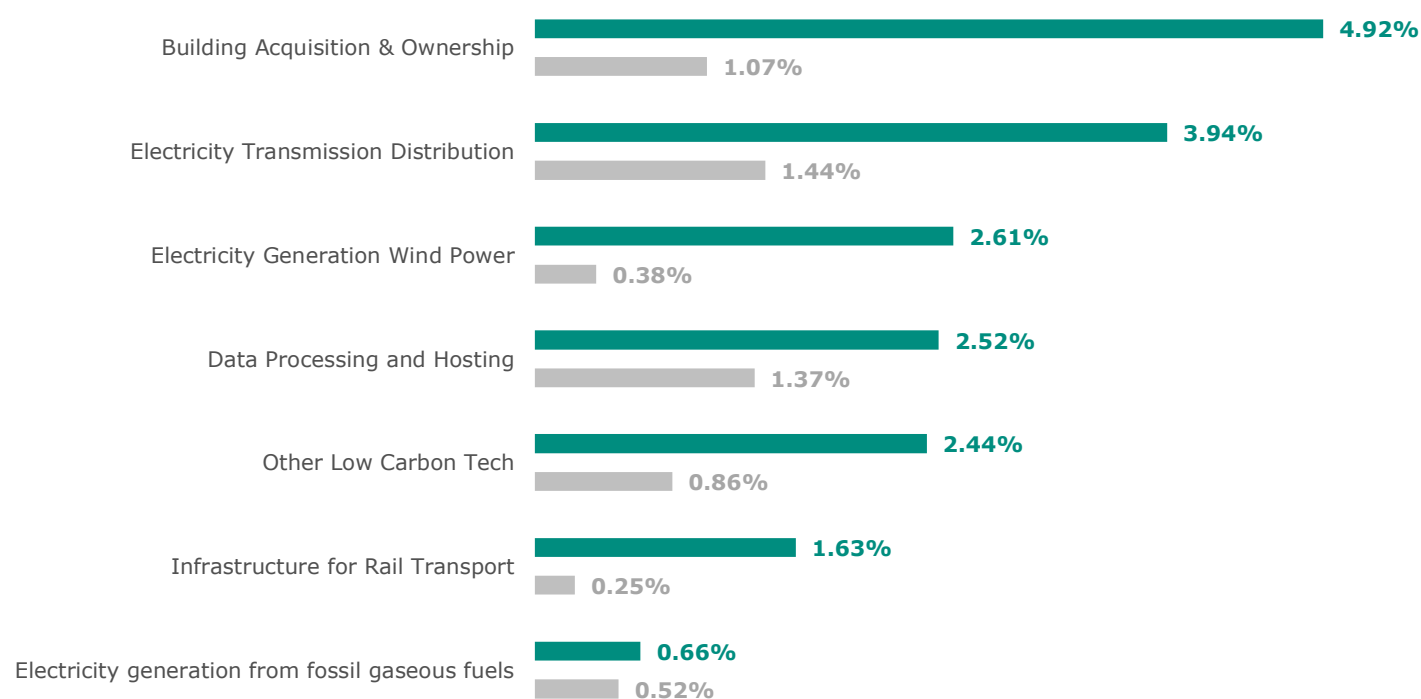

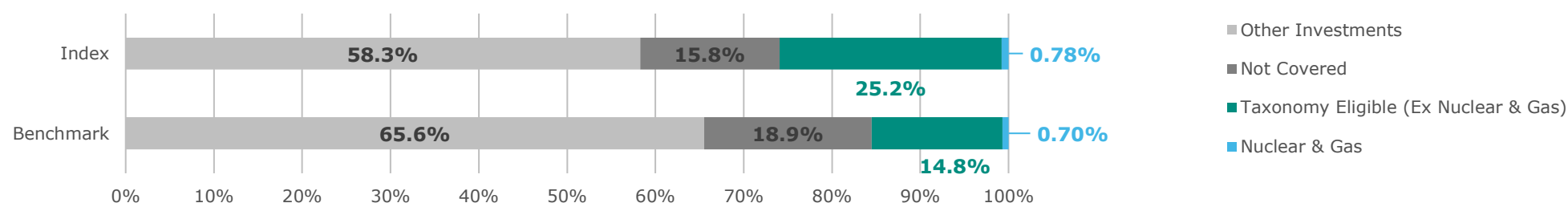
Top Eligible Activities of the Index (%)
