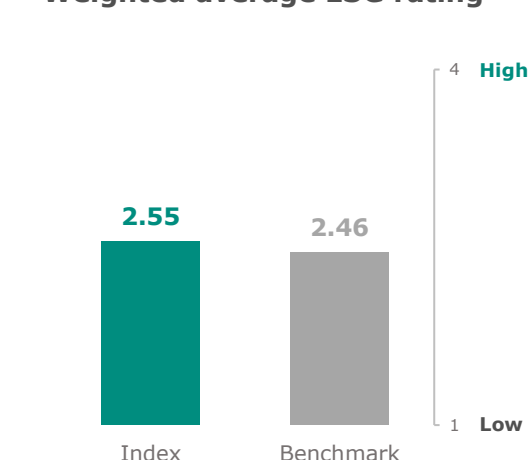

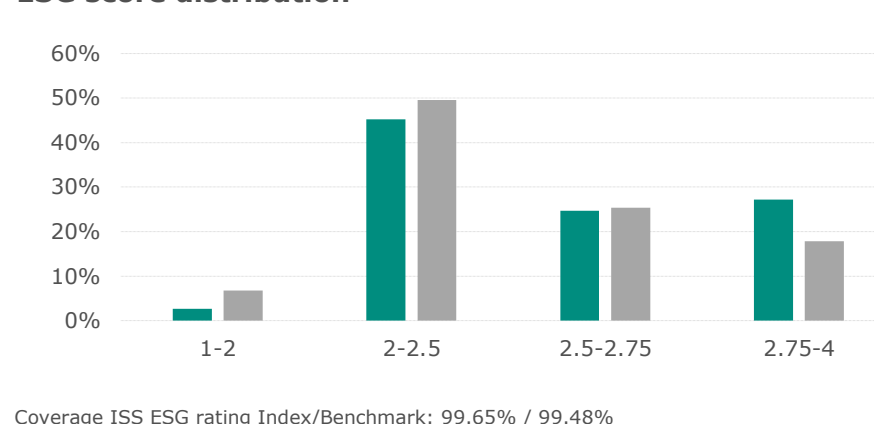

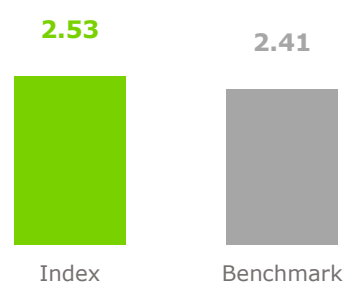
**Weighted average ESG rating**



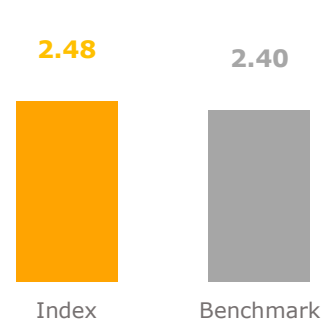
**ESG score distribution**



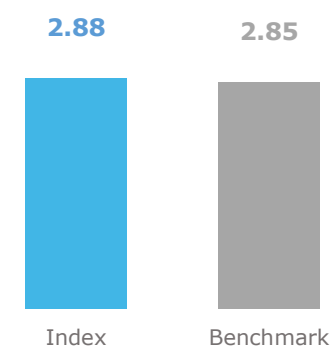

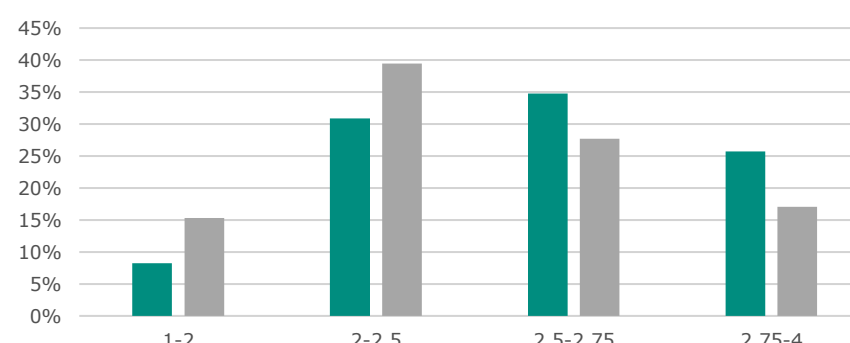

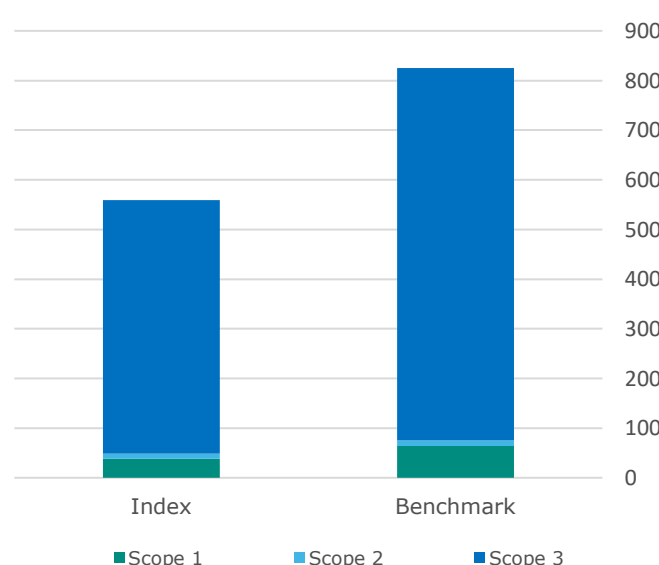

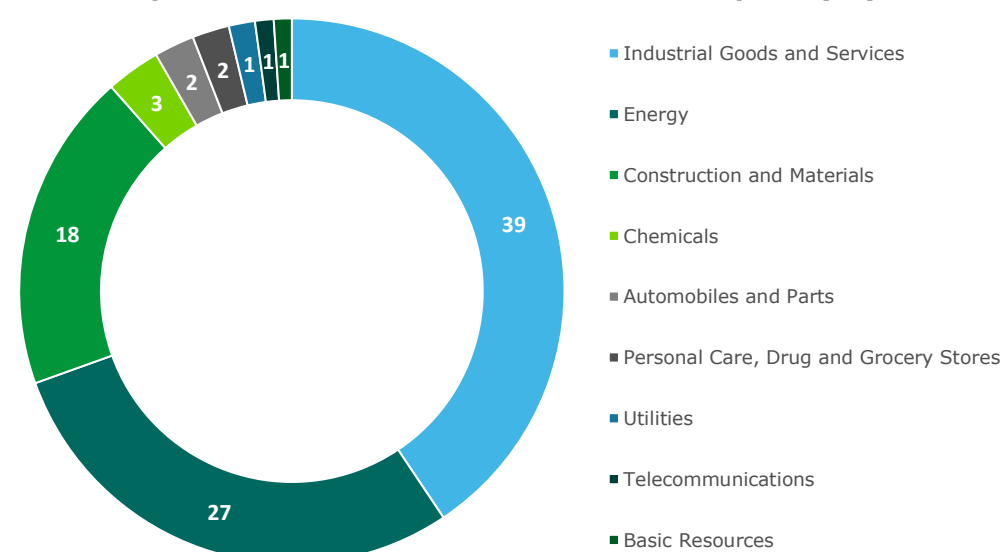

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 32.22% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 22.70% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 99.23% of the total weight of the index, 98.21% for the benchmark.

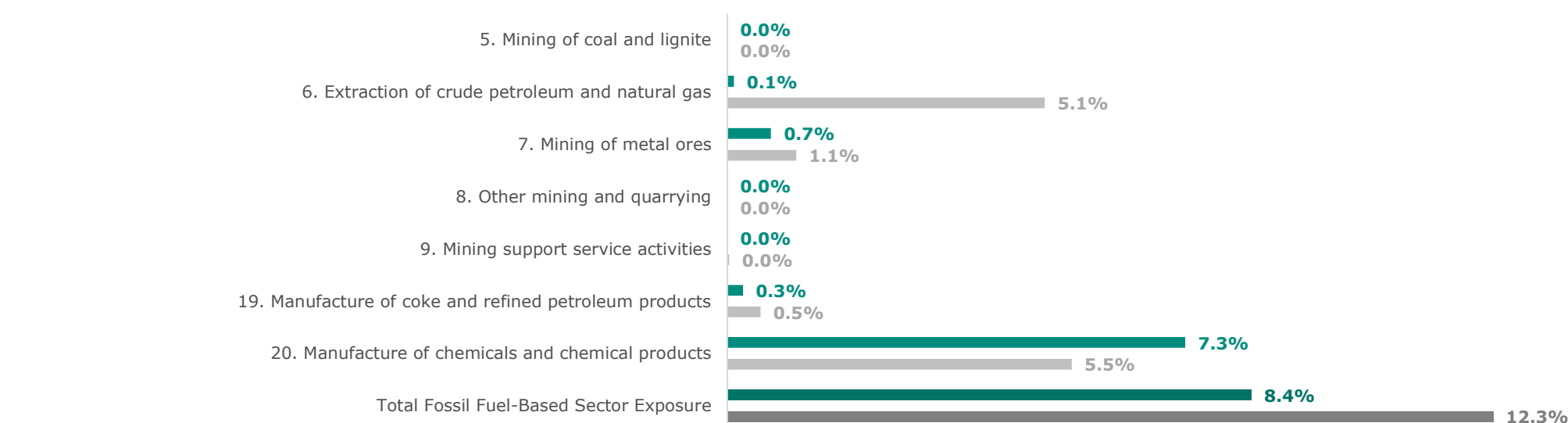

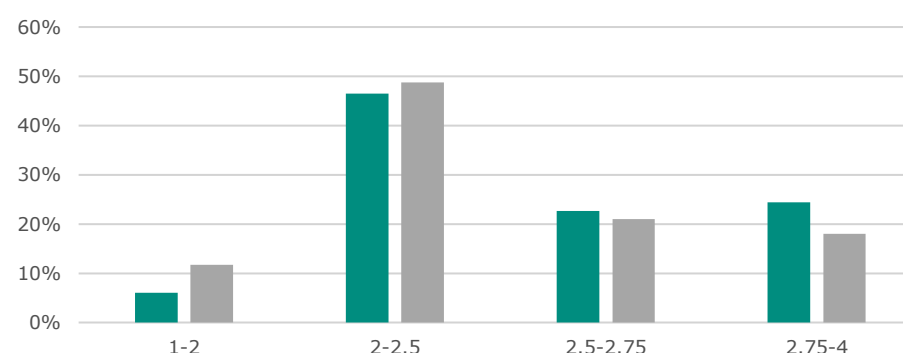

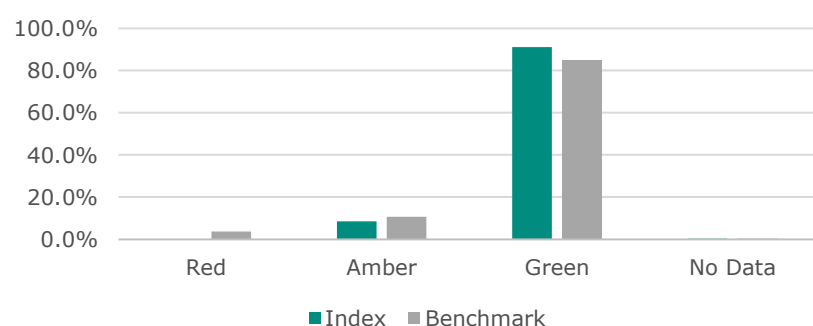

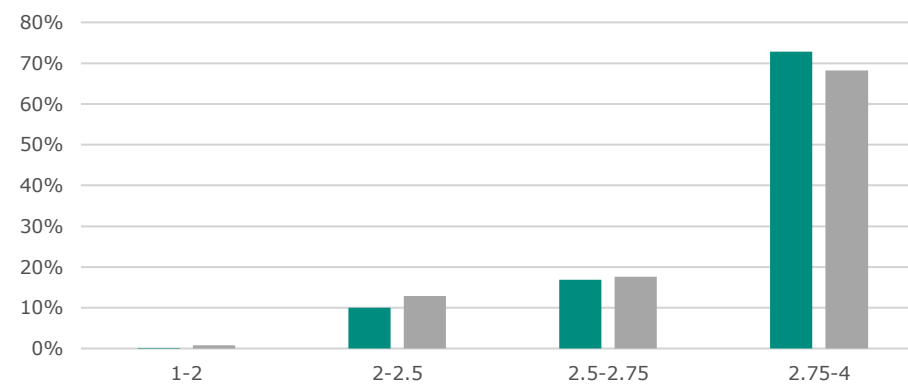

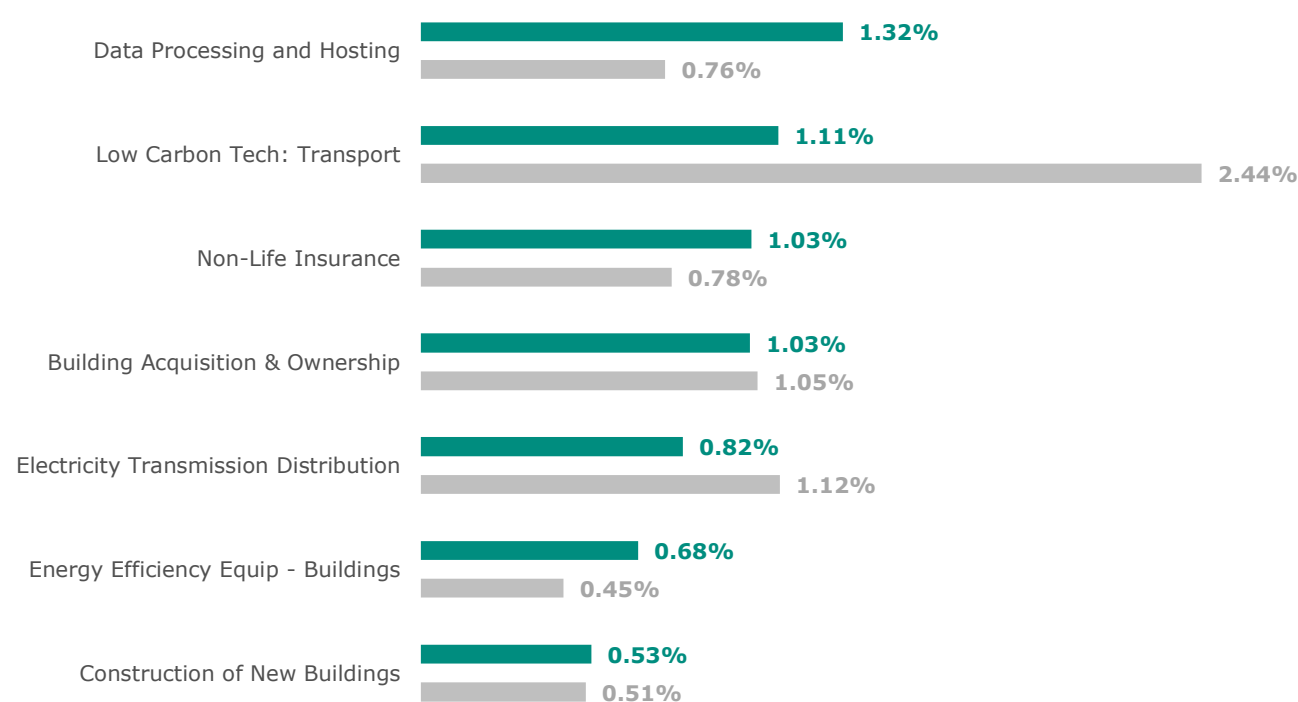

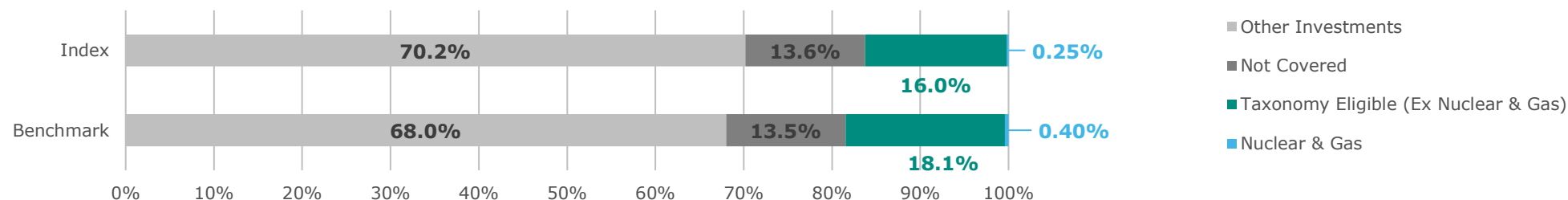

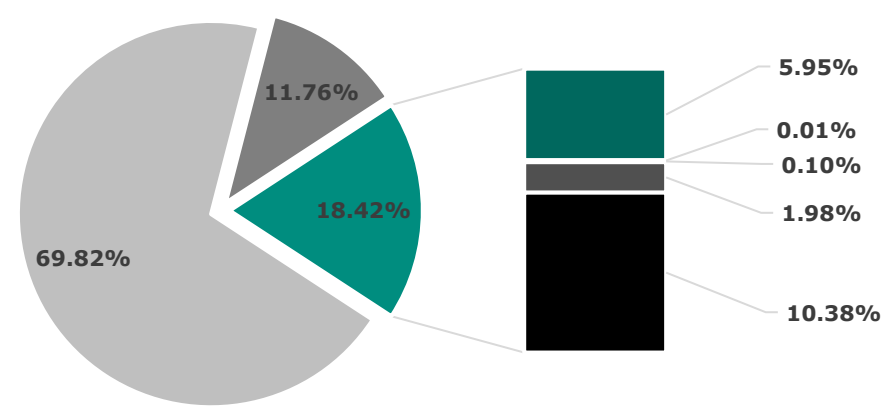
