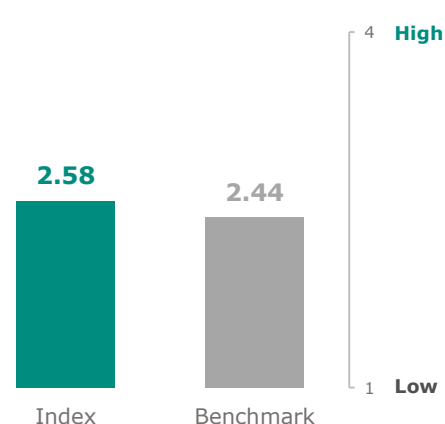
## Objective

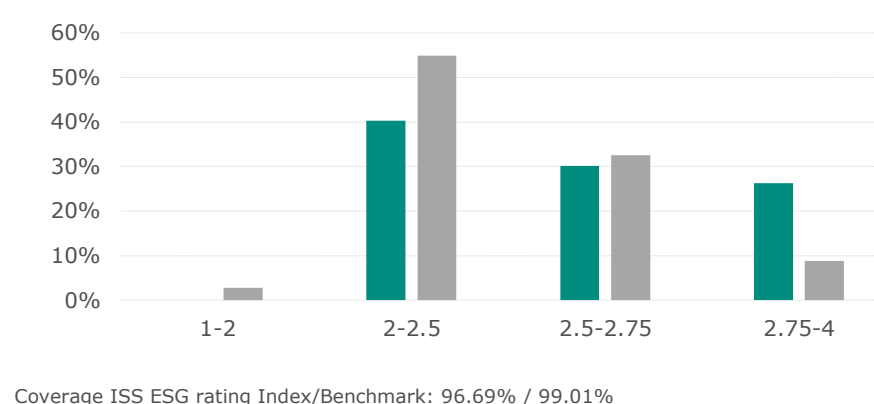

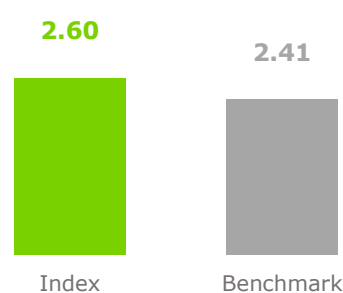
**Weighted average ESG rating**



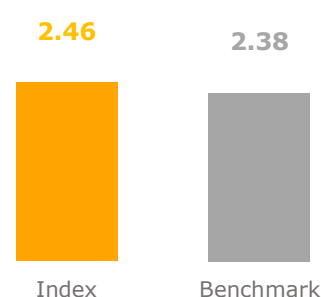
**ESG score distribution**



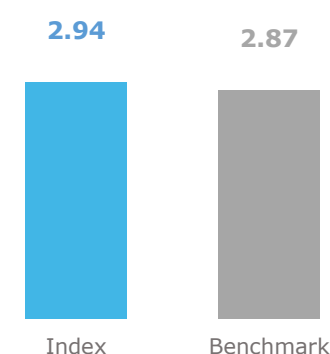

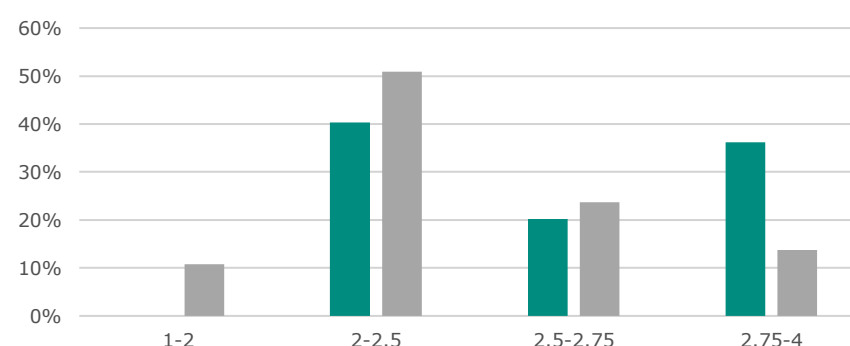

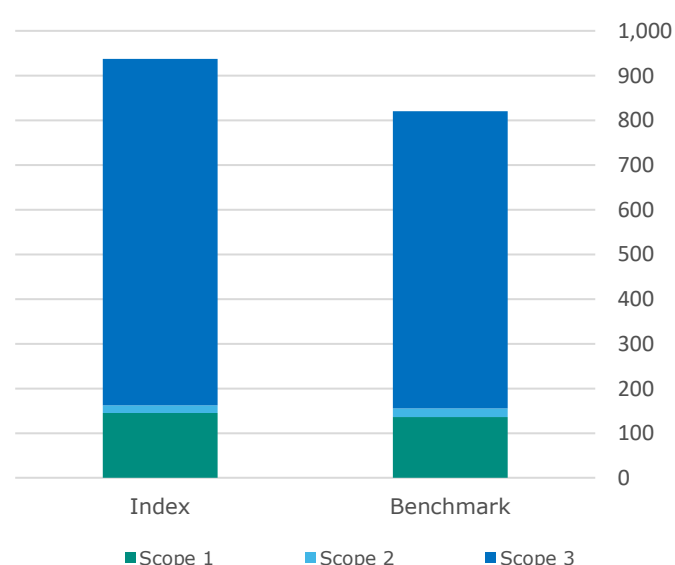

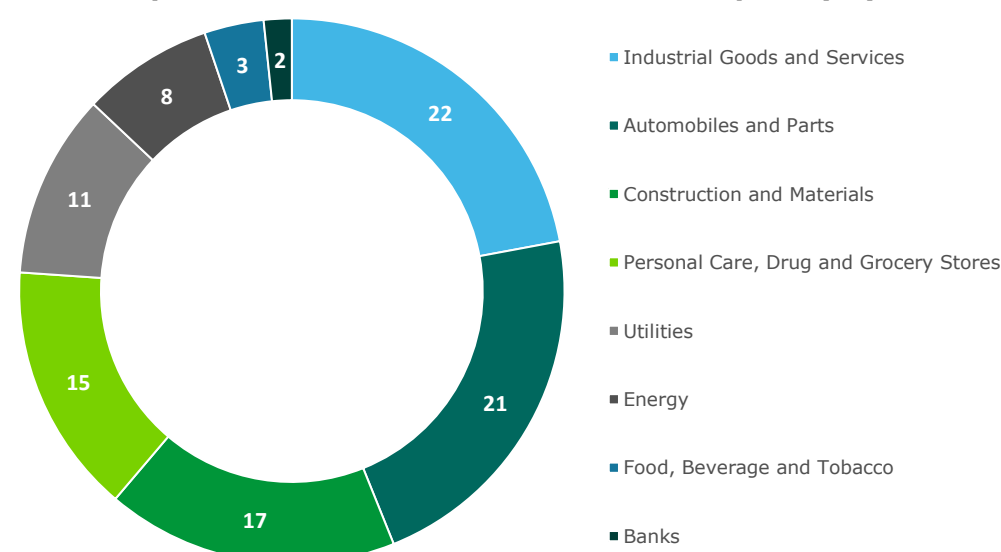
### Environmental score distribution

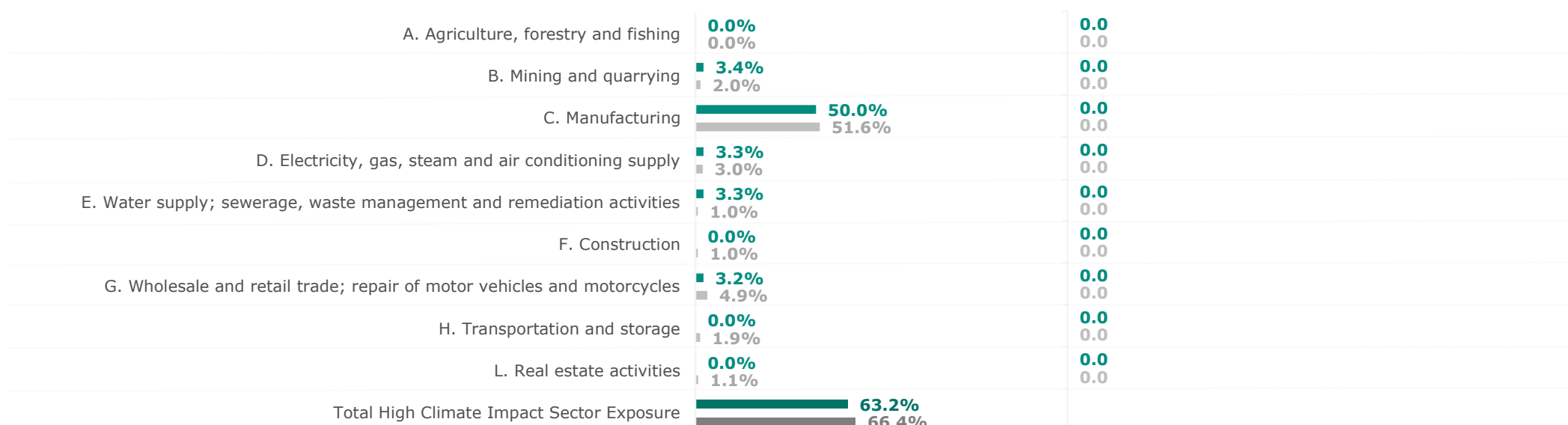

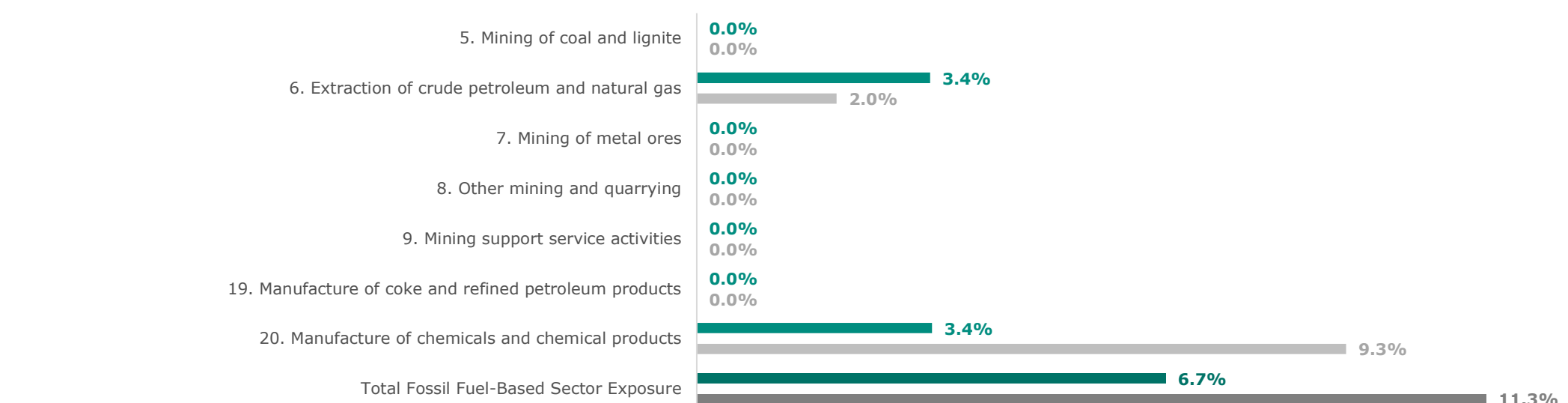
## High Climate Impact Sectors Exposure (NACE)

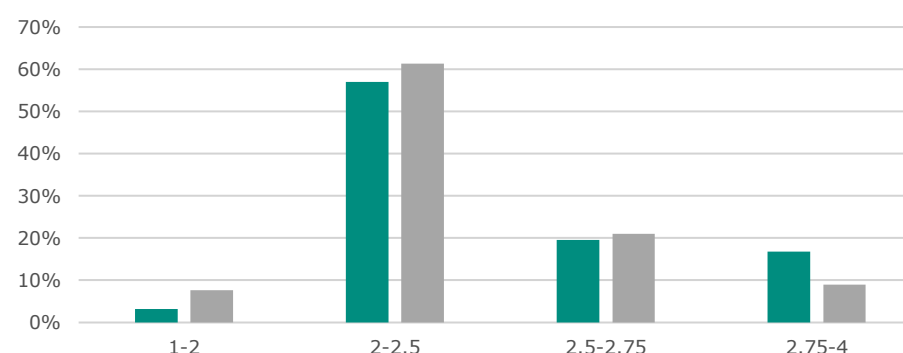

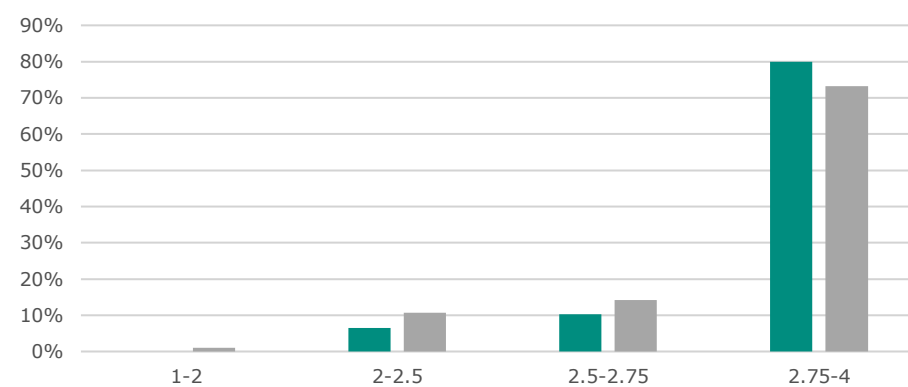

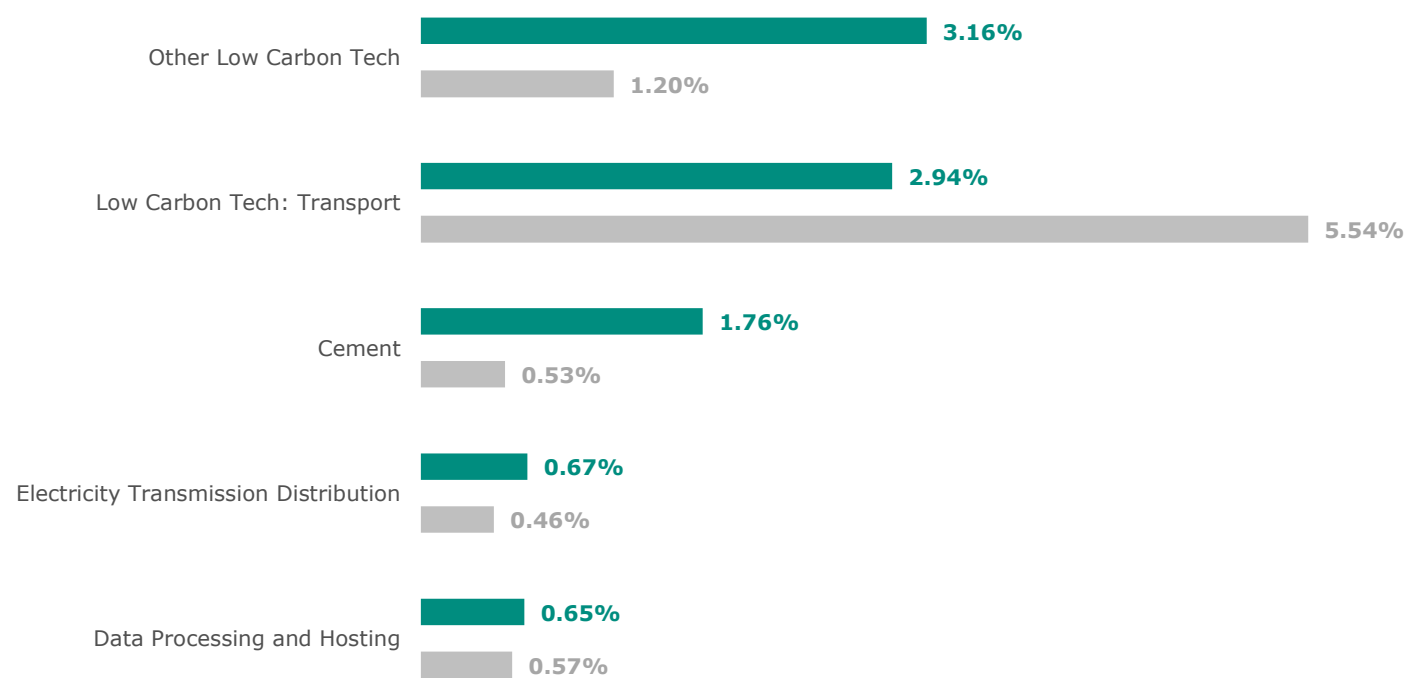
