From the companies left in the universe after the exclusions, 30 companies with the highest Free Float Market capitalisation are selected. Euronext® JPN Screened Climate Ambition 30 EW index is an equal-weighted index. The index serves as an underlying for structured products, funds and exchange traded funds. 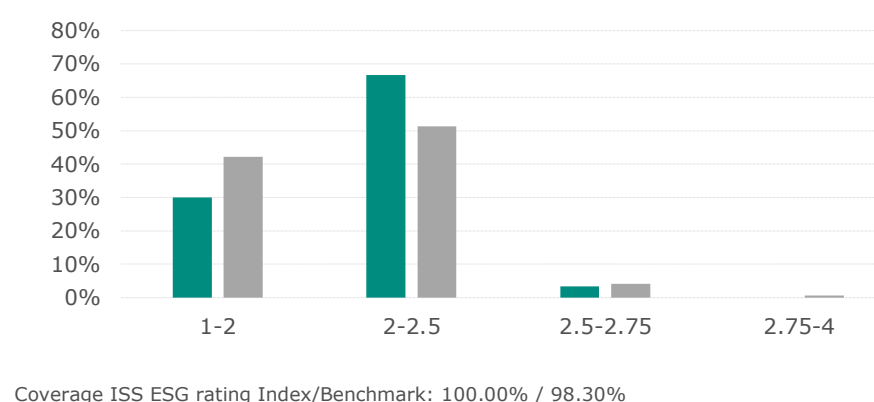

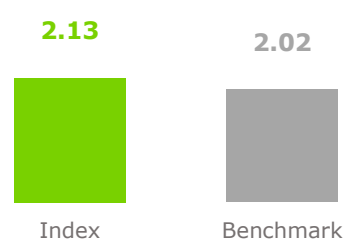
**Weighted average ESG rating**



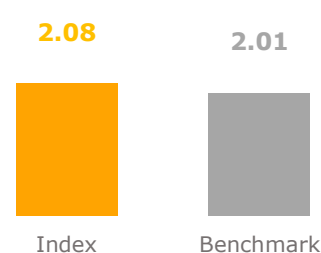
**ESG score distribution**



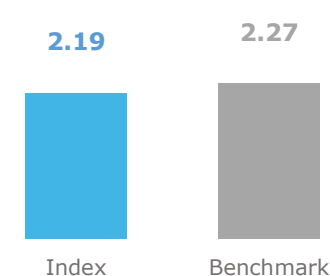

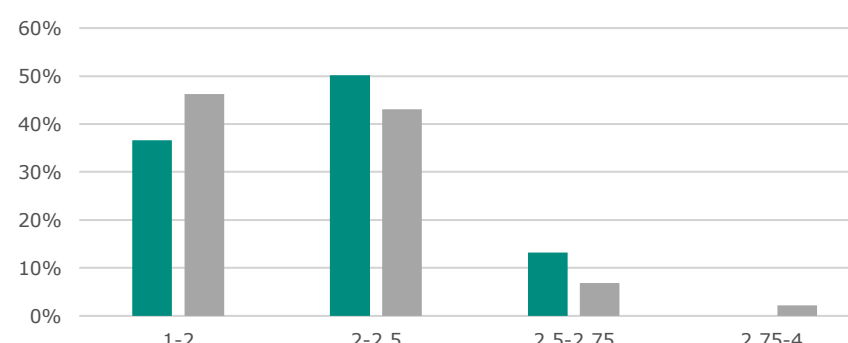

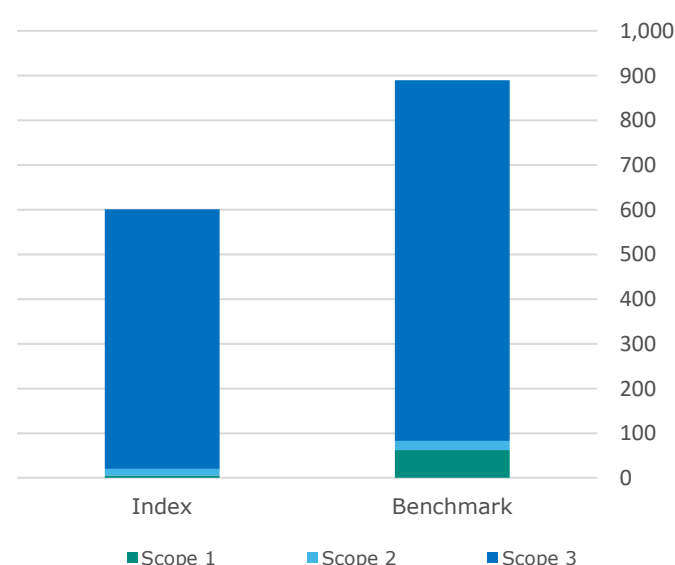

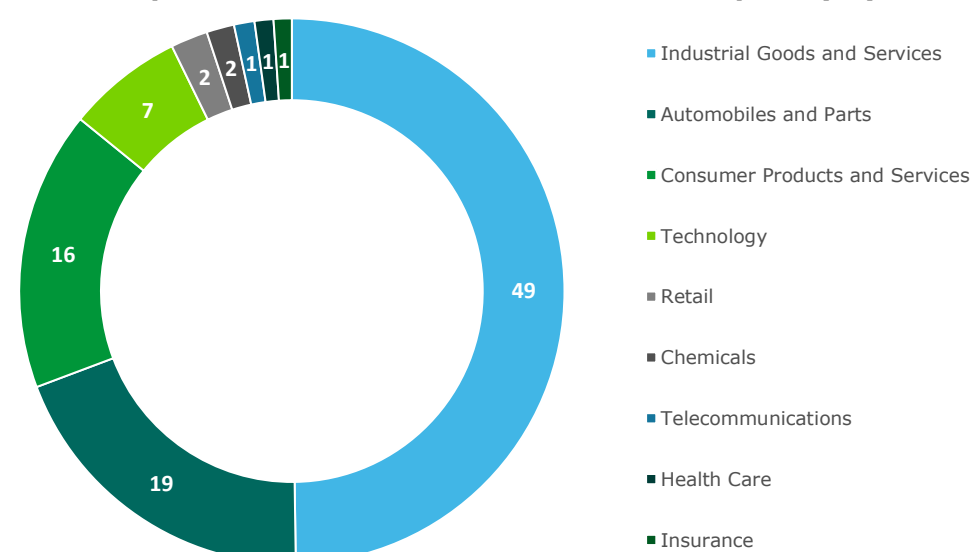
### Environmental score distribution

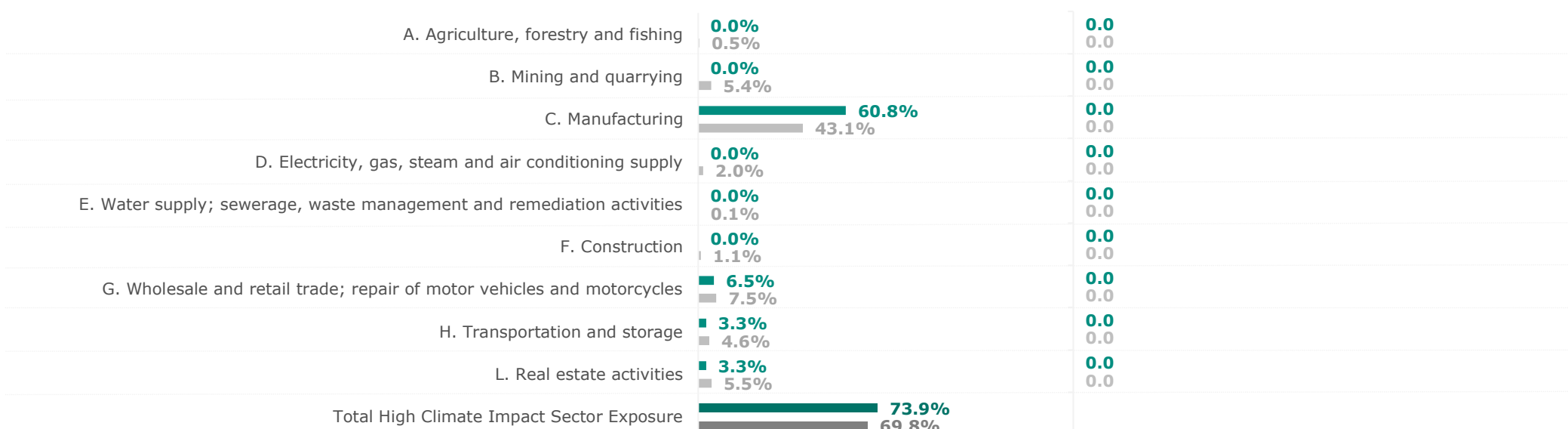

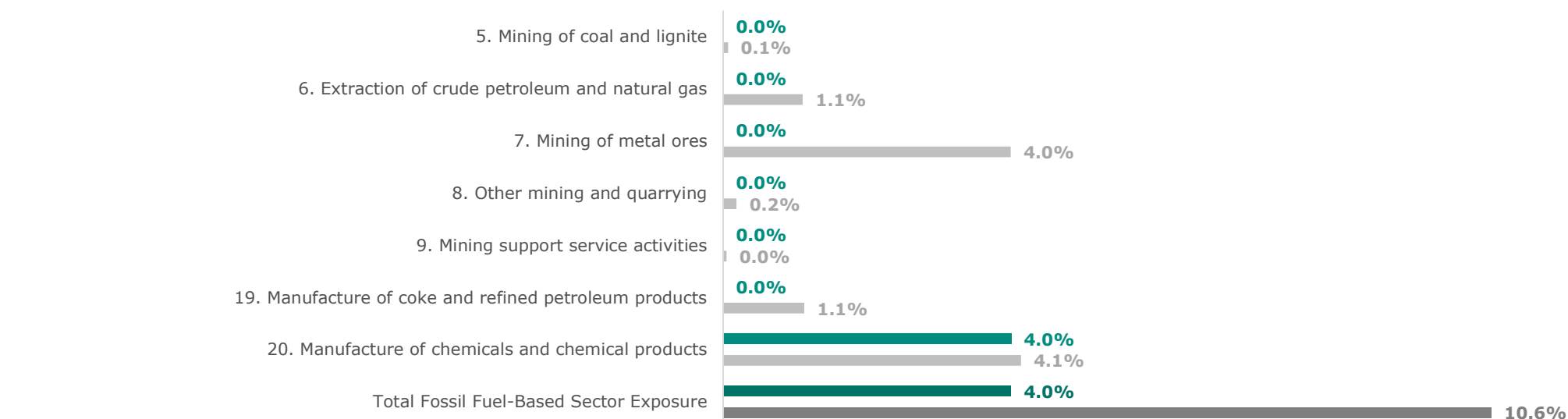
## High Climate Impact Sectors Exposure (NACE)

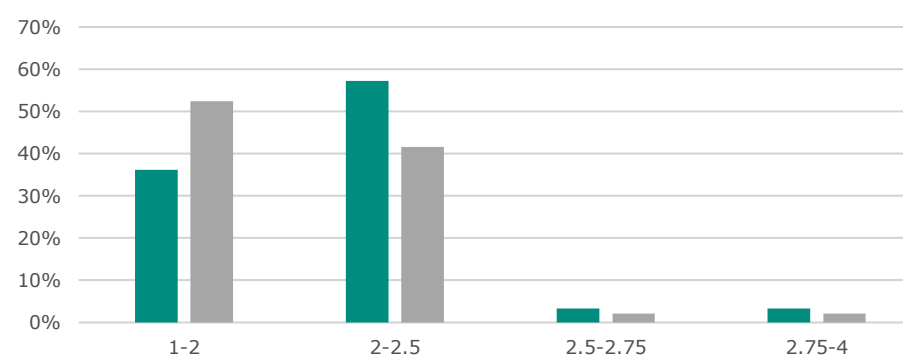

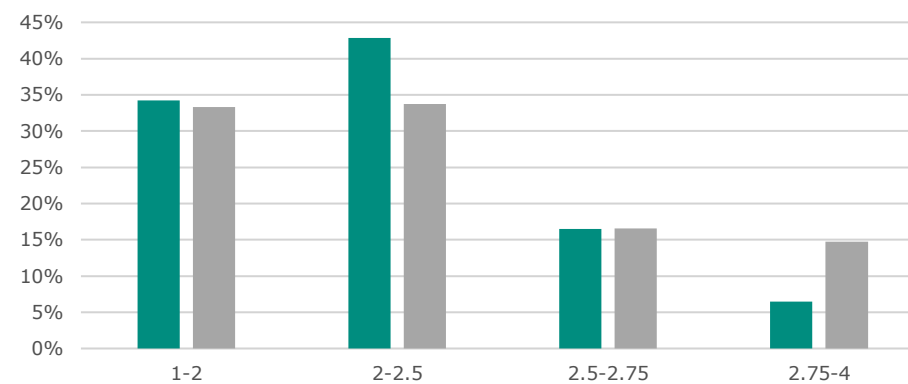

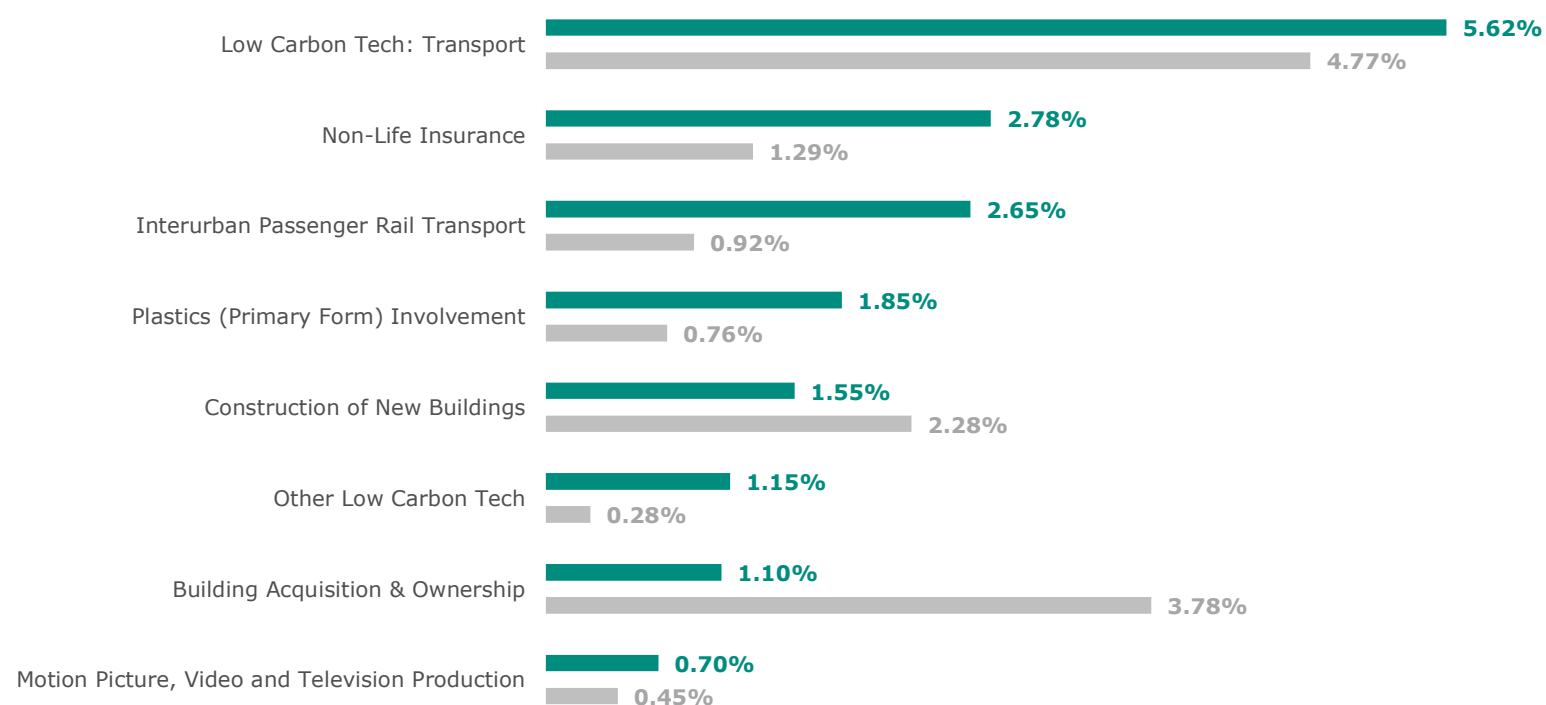

### Top Eligible Activities of the Index (%)



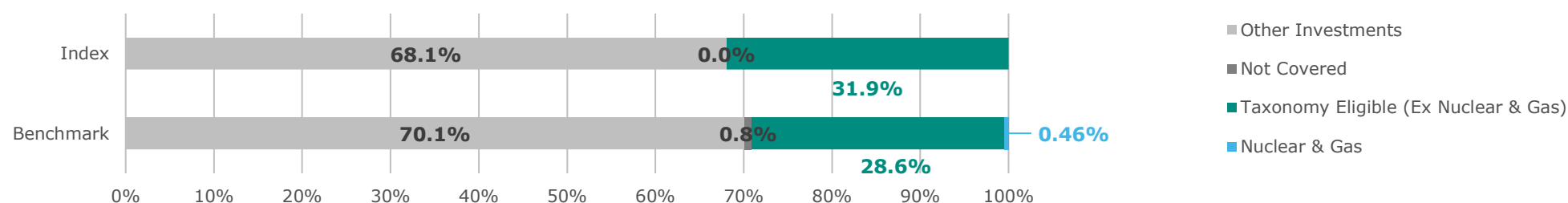

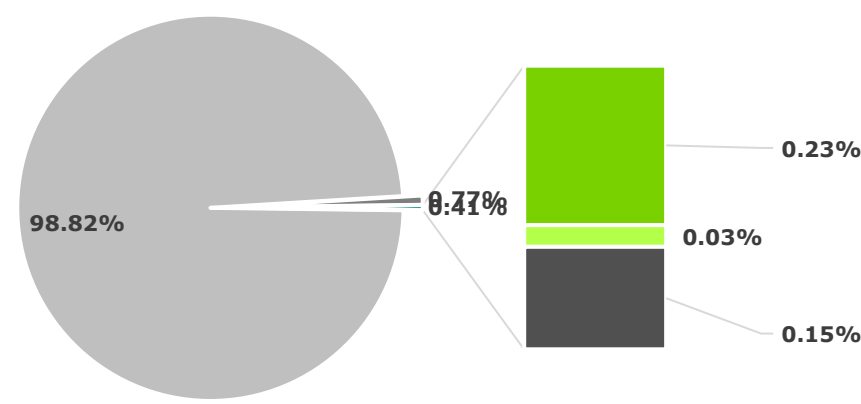
