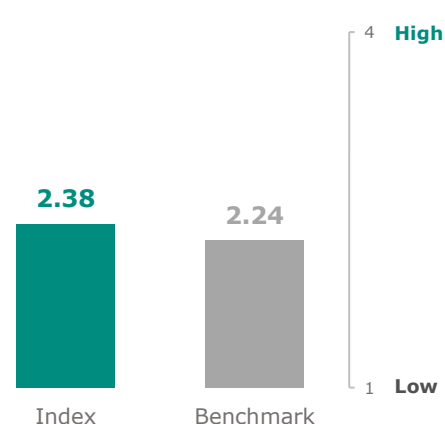

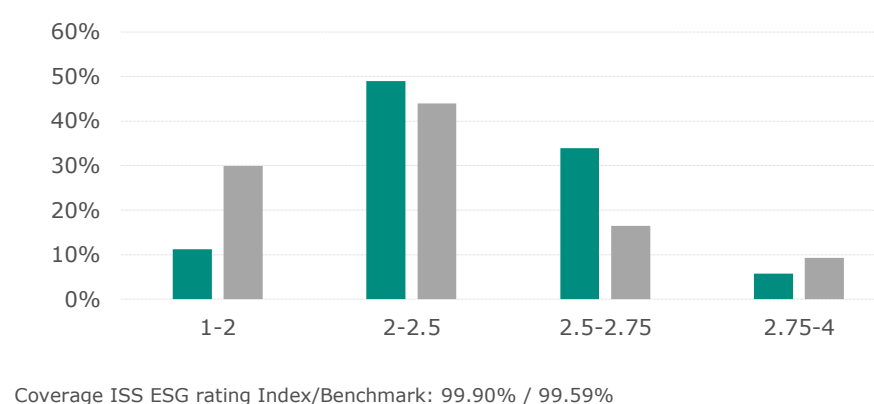

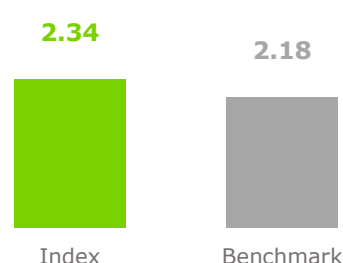
Weighted average ESG rating



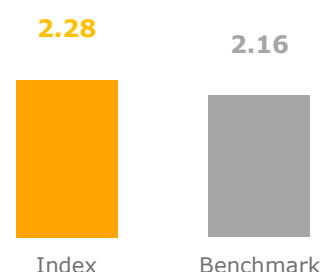
ESG score distribution



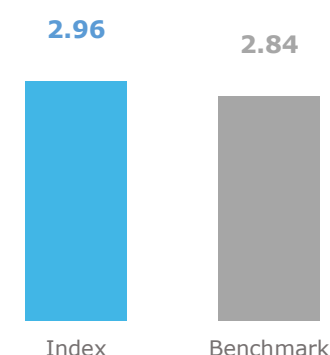

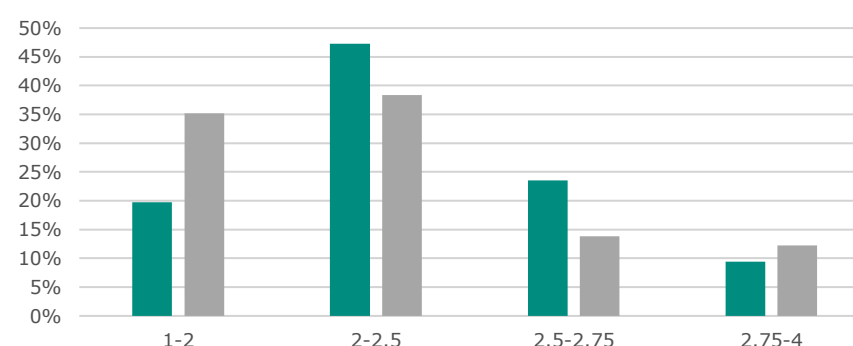

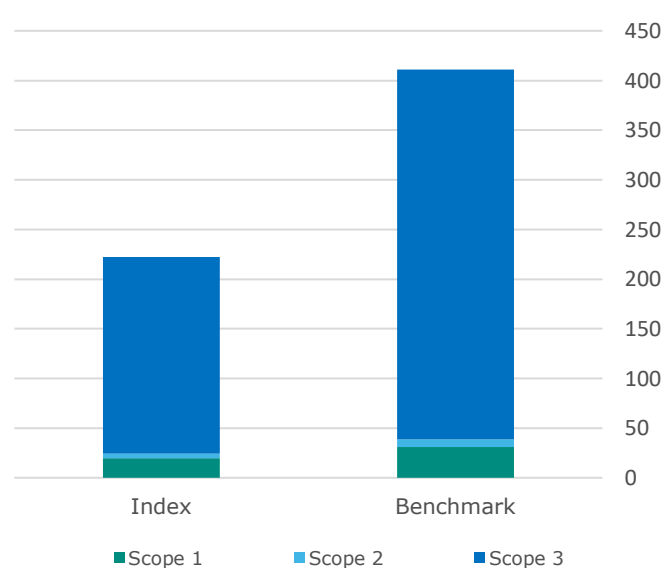

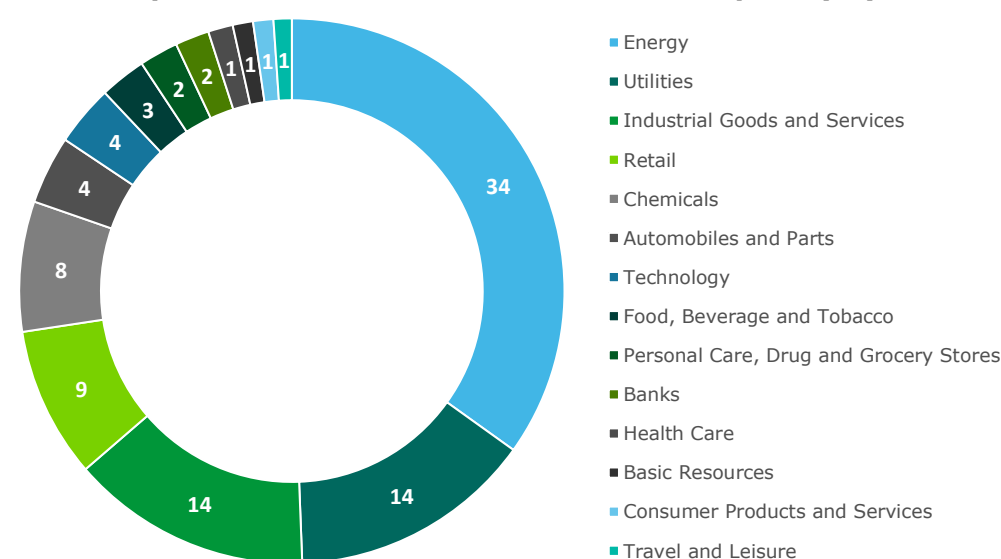
Environmental score distribution

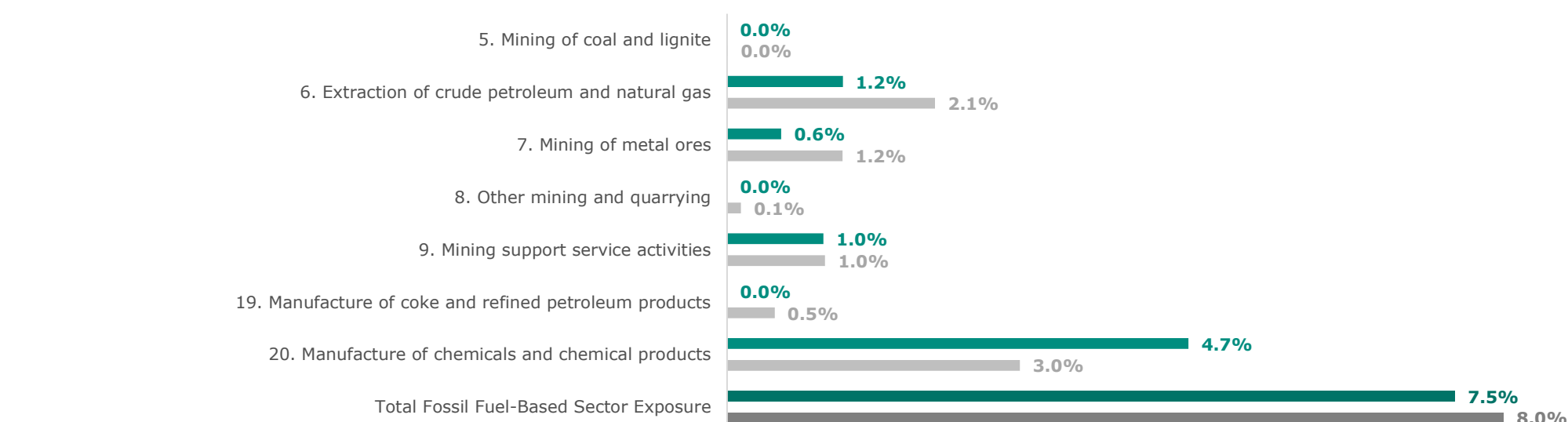

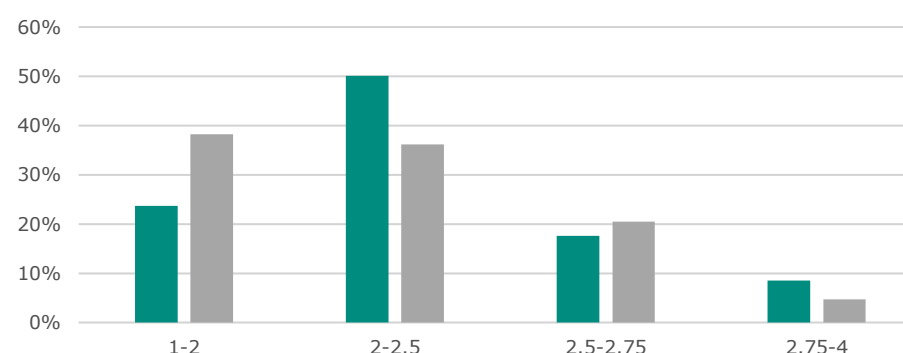

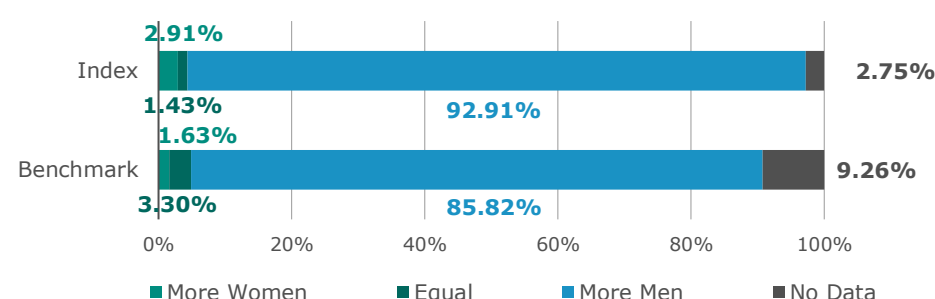

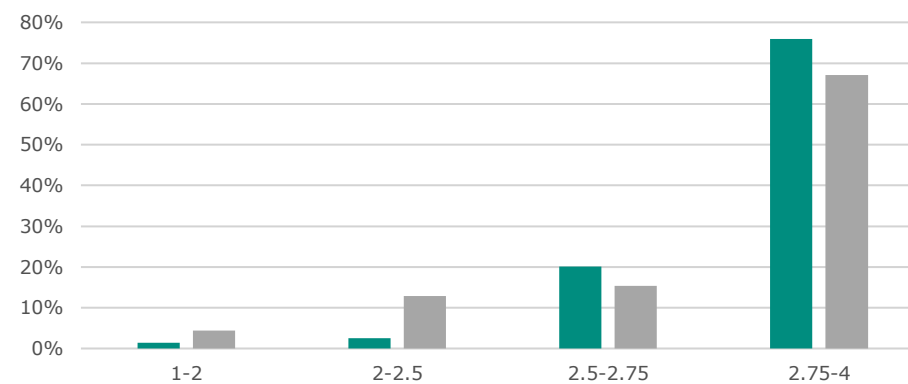

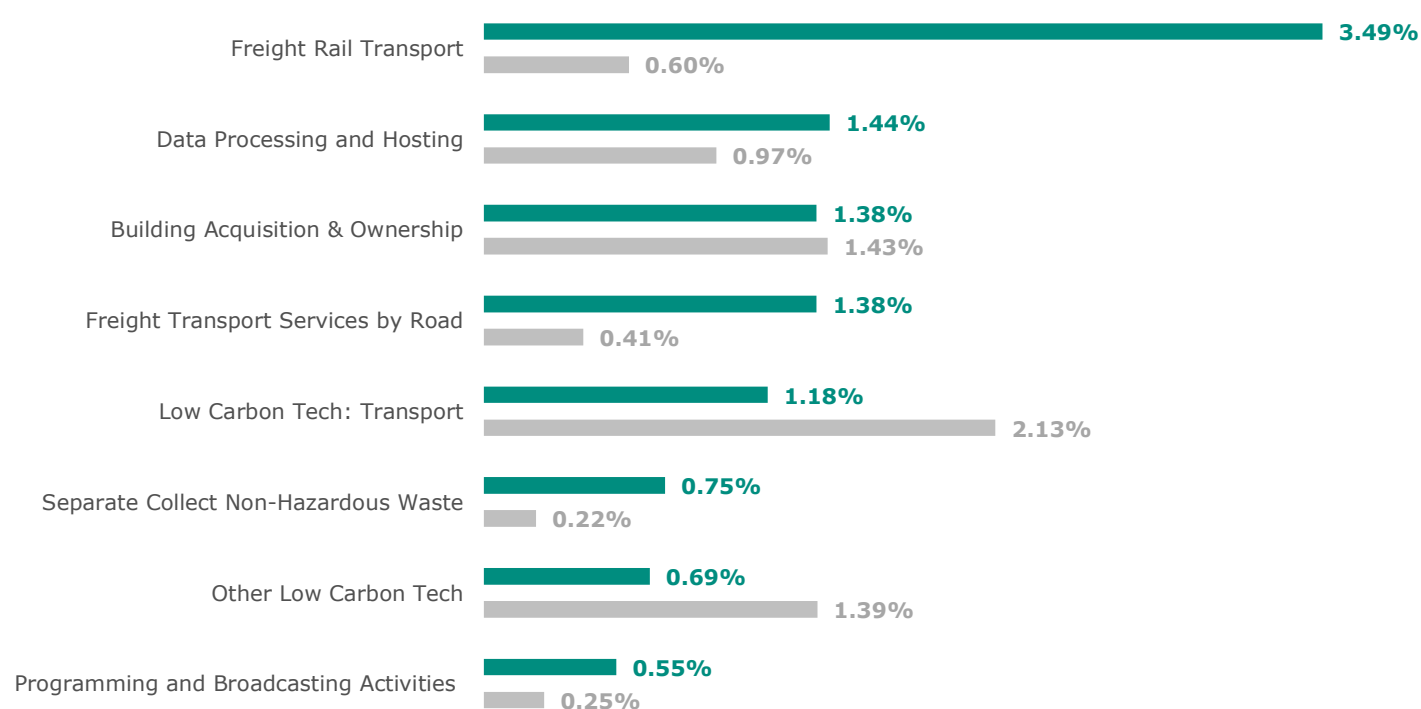

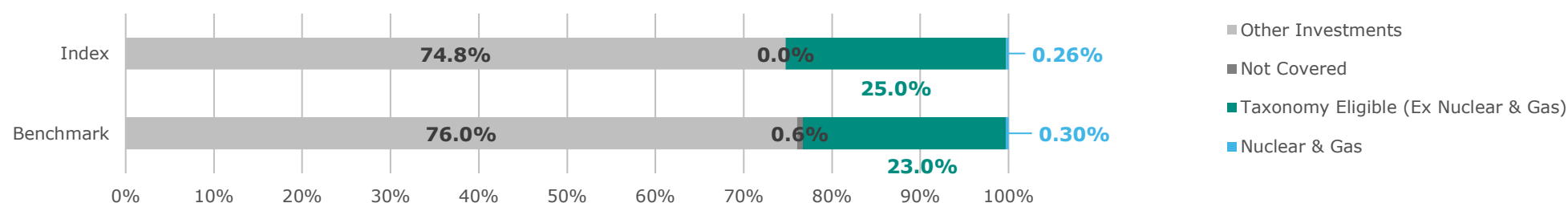

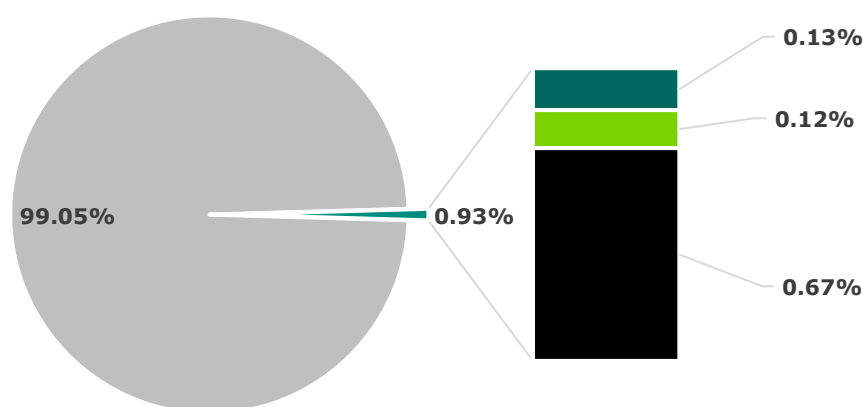

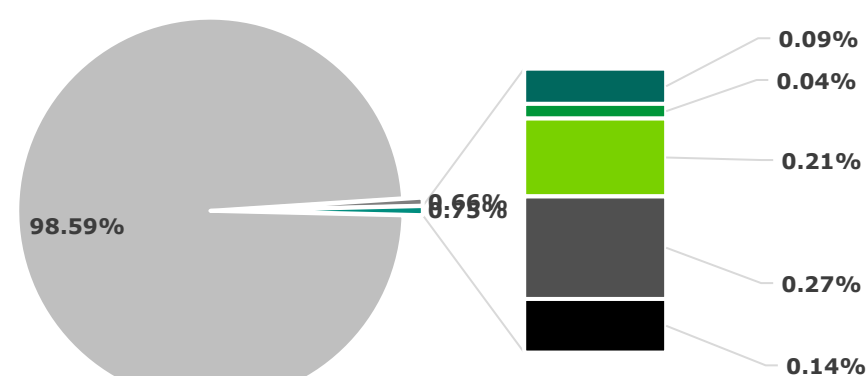
