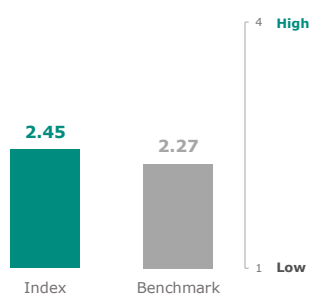
Objective

The Euronext® Vigeo World 120 index consists of companies included in the World Equities Universe, covering the the 1500 largest free-float market capitalisations in North American, Asia-Pacific and Europe. Companies may be excluded if their level of commitment is insufficient with regard to their overall score or their score in one of six key areas reviewed in the Equities methodology or are subject to serious, proved, or recurrent controversies. Then 120 highest ranking companies are selected according to their overall Equities score. The index is Non-Market capitalisation weighted, weighting are based on the overall Equities scores. The index serves as an underlying for structured products, funds and exchange traded funds. The index rules are available on our website. Euronext acts as Supervisor. 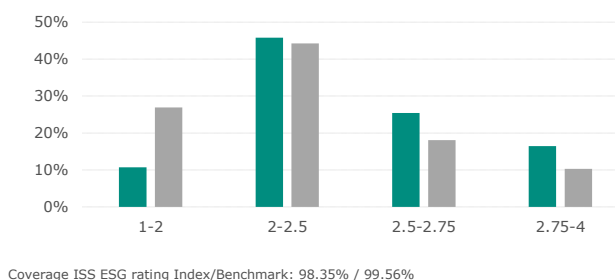

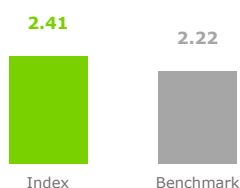
Weighted average ESG rating



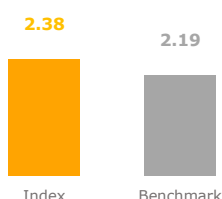
ESG score distribution



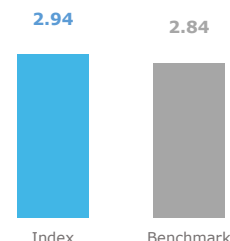

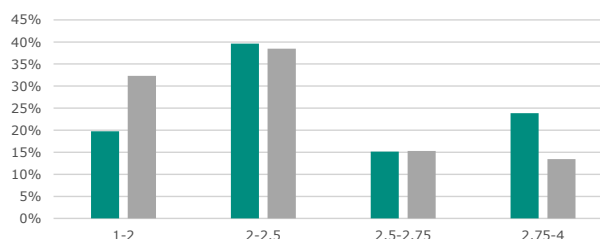

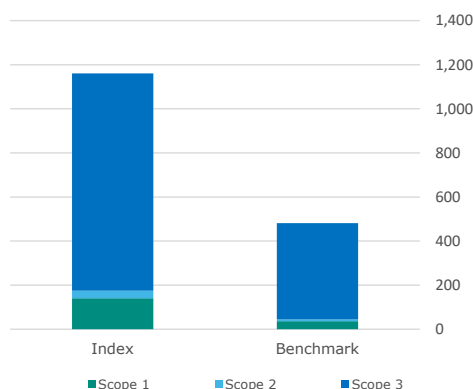
Environmental score distribution



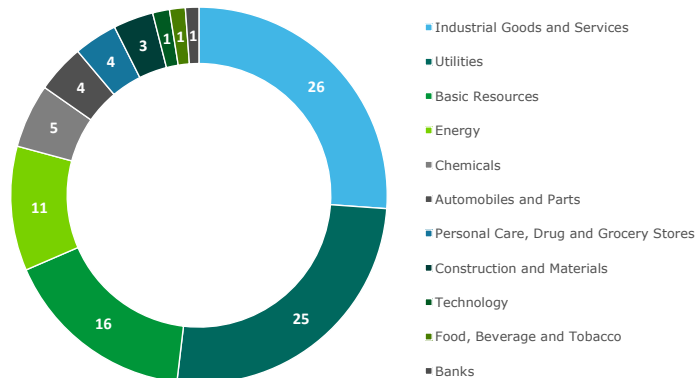

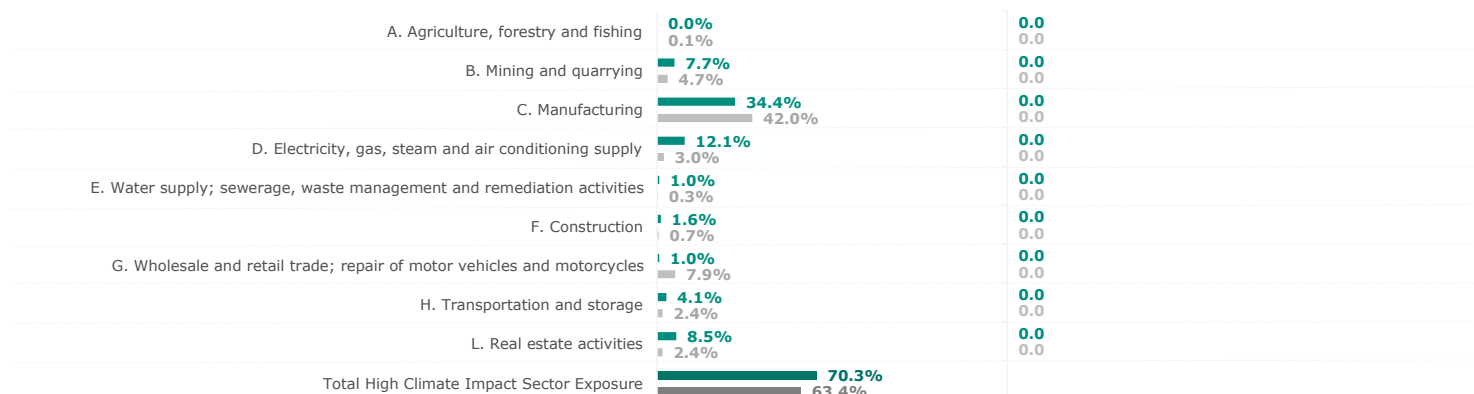

High Climate Impact Sectors Exposure (NACE)

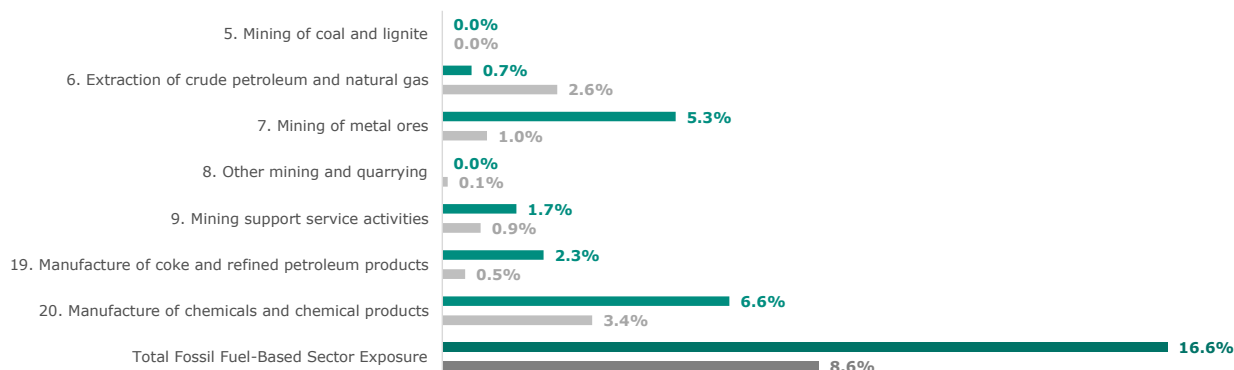

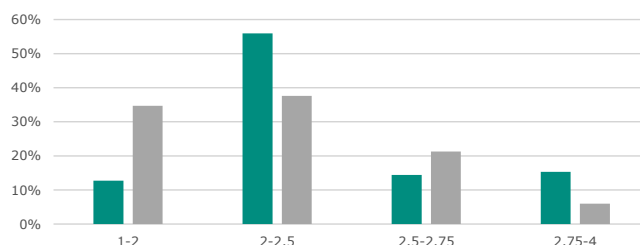

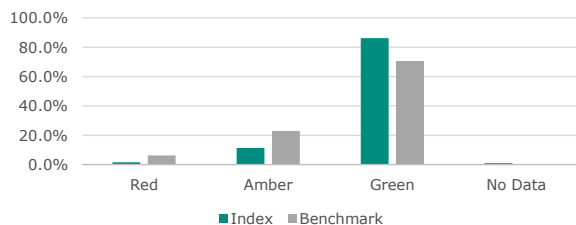

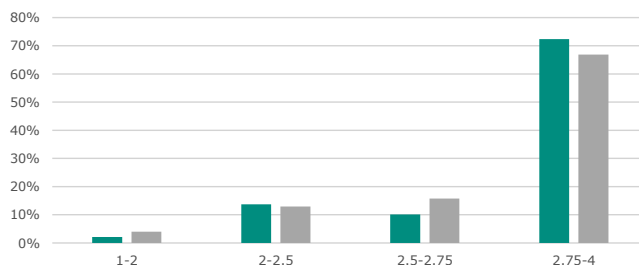

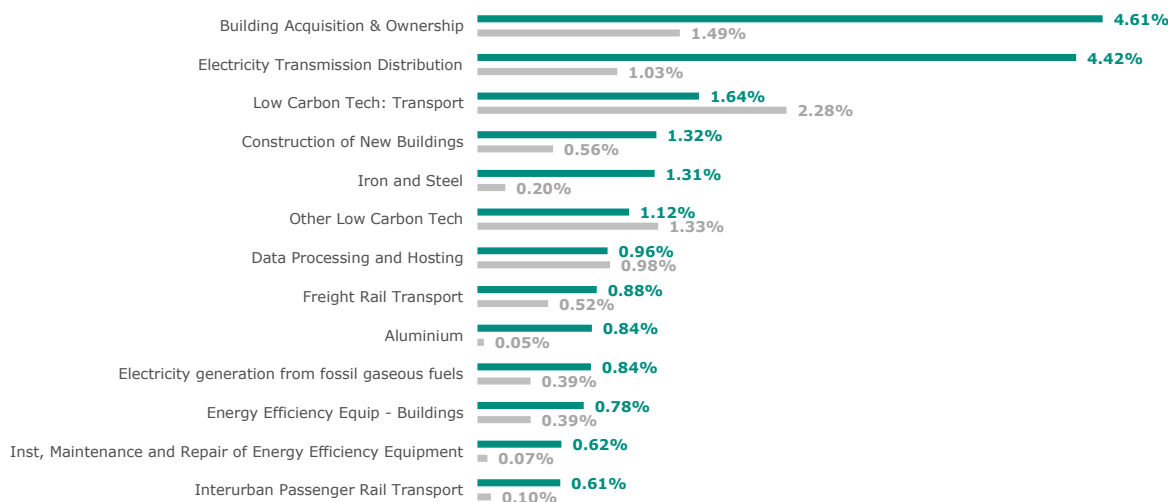

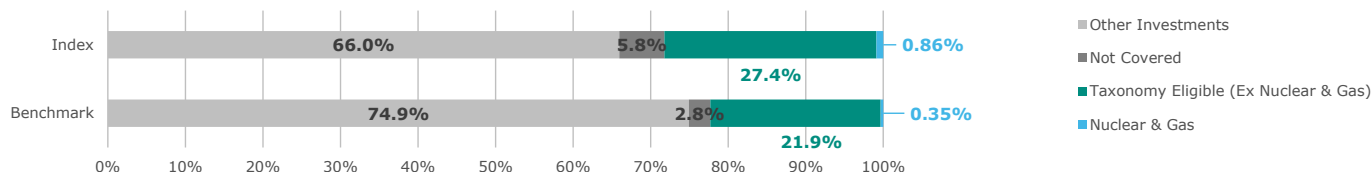
Top Eligible Activities of the Index (%)

Eligibility Breakdown - Nuclear & Gas



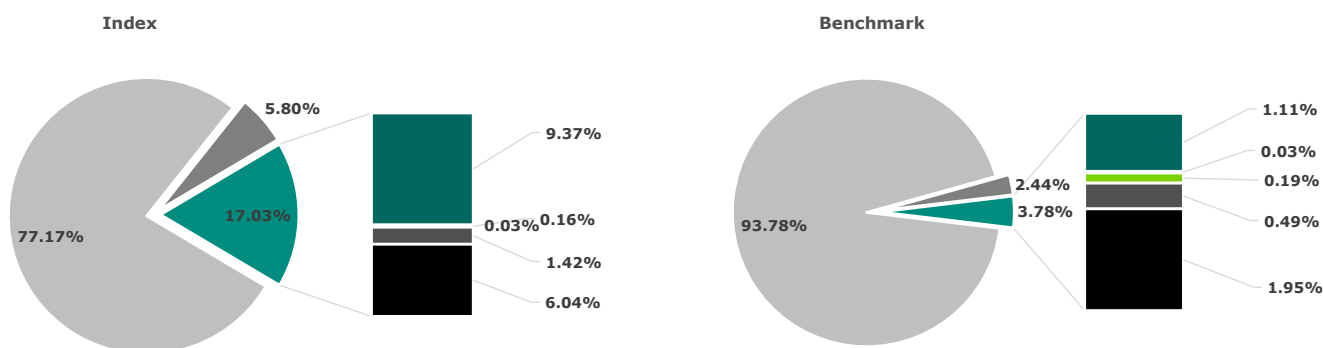
