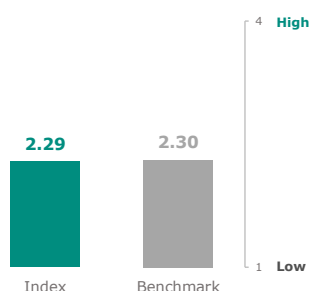
## Objective

The Environmental, Social and Governance risk rating is assessed by Sustainalytics. The index serves as an underlying for structured products, funds, exchange traded funds, options and futures. 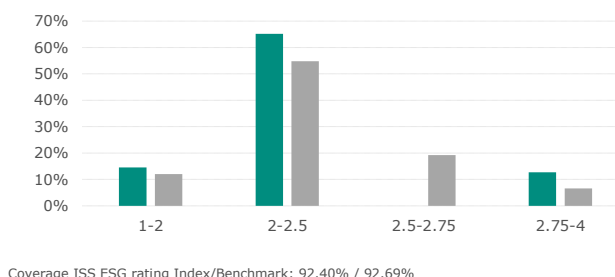

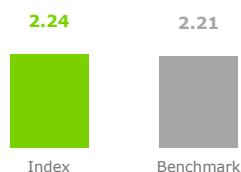
Weighted average ESG rating



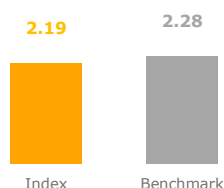
ESG score distribution



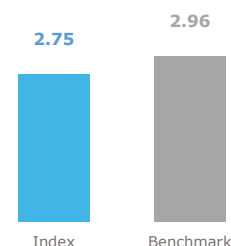

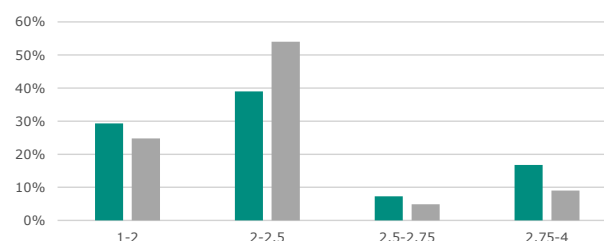

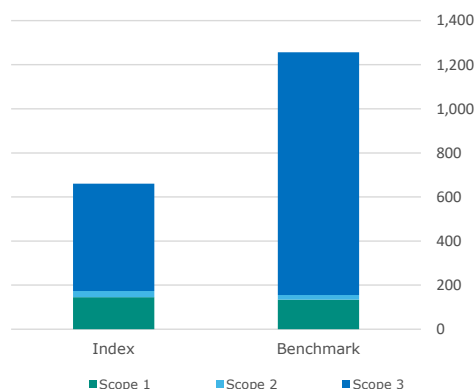

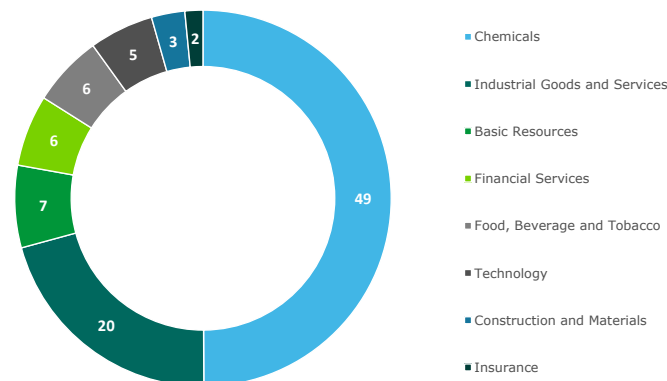
### Environmental score distribution

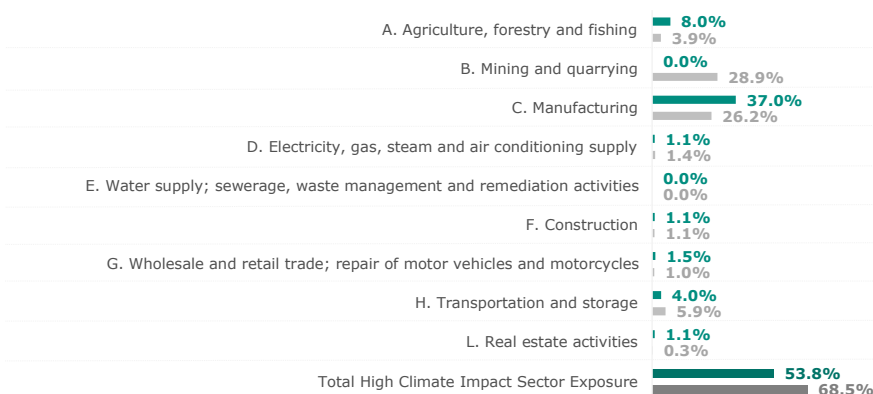

The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 93.78% of the total weight of the index, 96.35% for the benchmark.

## High Climate Impact Sectors Exposure (NACE)



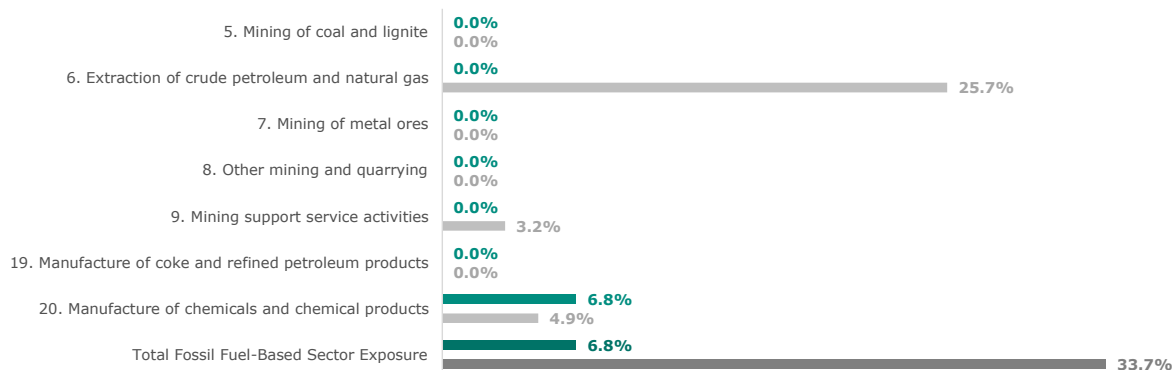

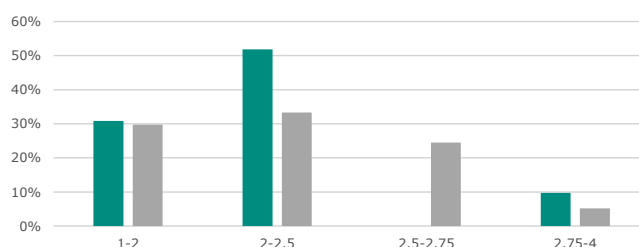

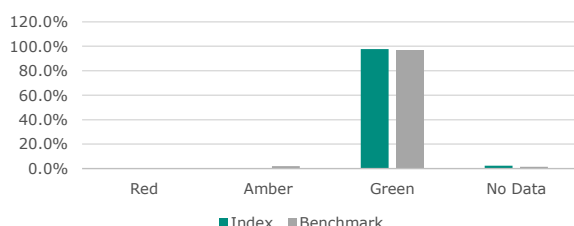

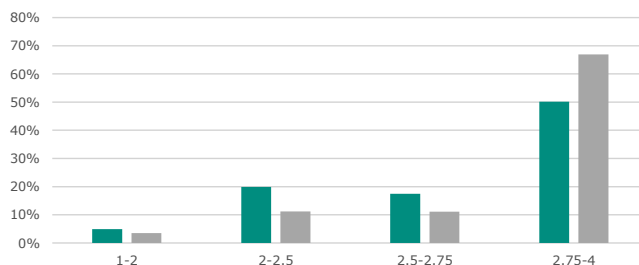

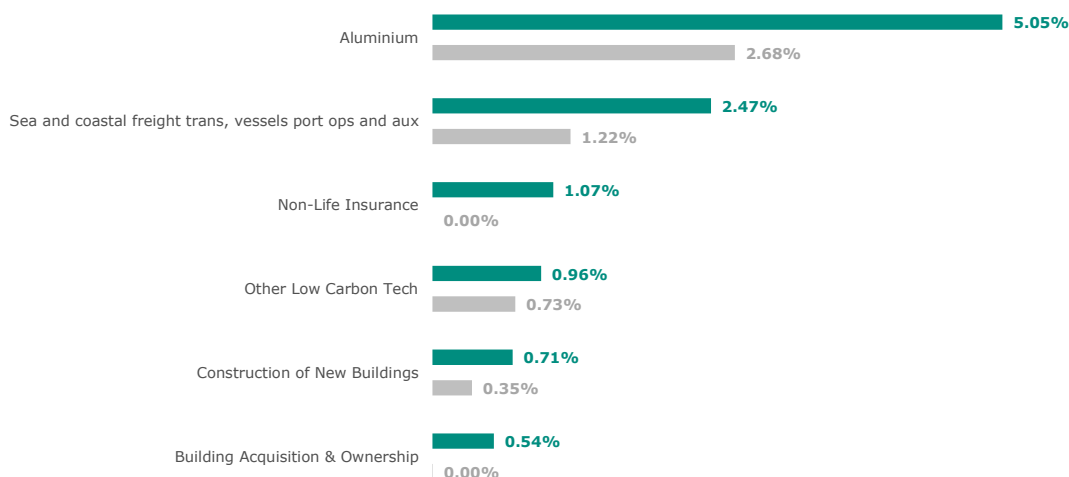

## Eligibility Breakdown - Nuclear & Gas



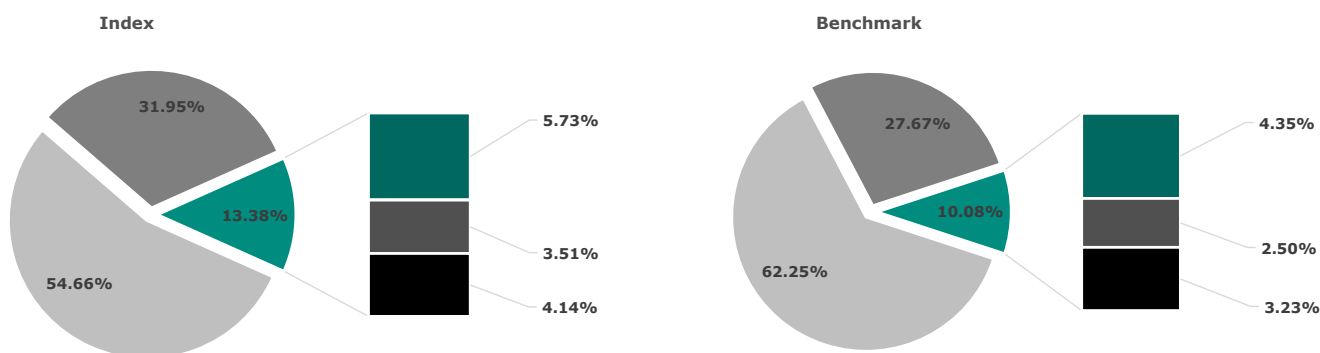
