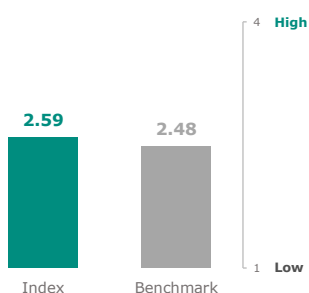
The Euronext® Eurozone SBT 1.5 index is a free float market capitalisation weighted index that reflects the performance of companies from the Euronext® Eurozone 300 index with approved Science Based Targets 1.5°C on Scope 1 & 2 and below 2°C on Scope 3. The index also excludes companies involved in controversial activities, tobacco, controversial weapons, thermal coal extraction; shale energy, oil sands and arctic oil & gas extraction; or assessed Non-Compliant with regards to the UN Global Compact principles. The index is powered by SBTi, a partnership between CDP, the United Nations Global Compact, World Resources Institute (WRI) and the World Wide Fund for Nature (WWF). The index serves as an underlying for structured products, funds, exchange traded funds, options and futures. The index rules are available on our website. Euronext acts as Supervisor. 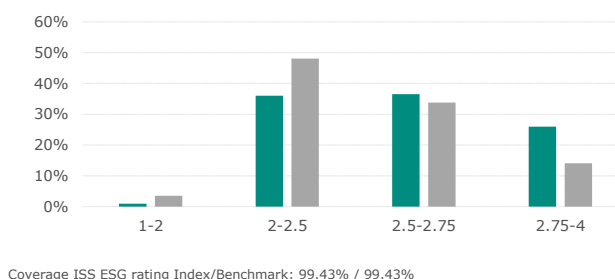

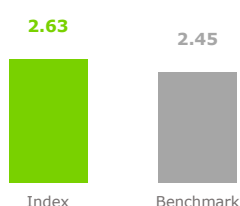
Weighted average ESG rating



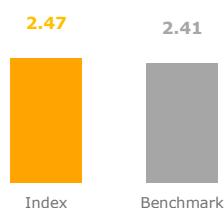
ESG score distribution



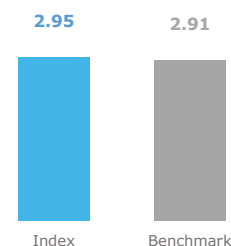

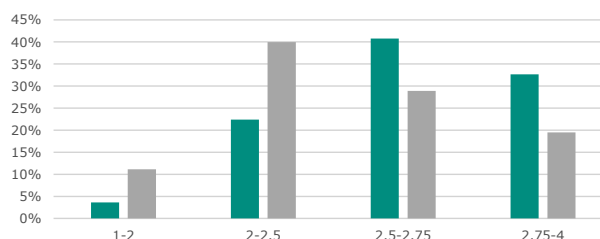

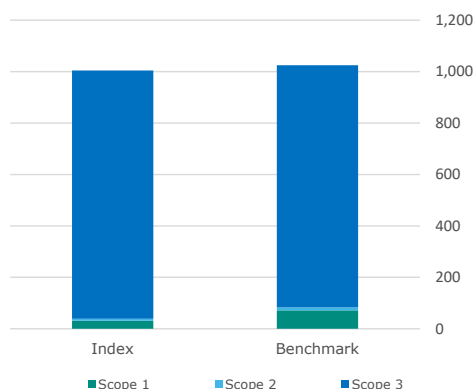
Environmental score distribution



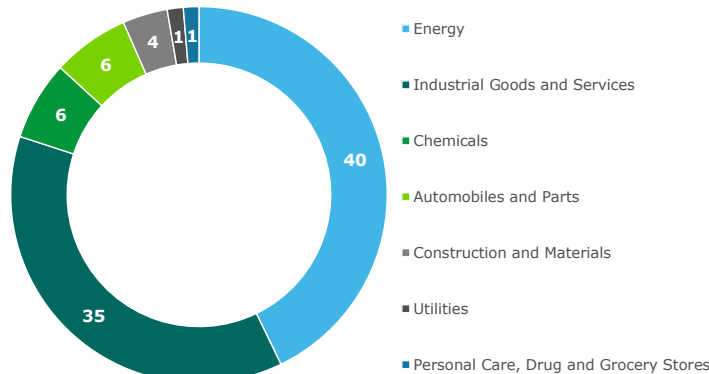

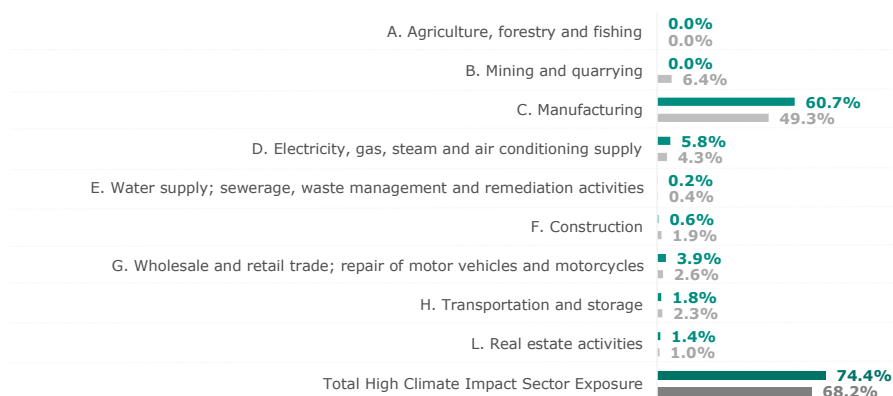

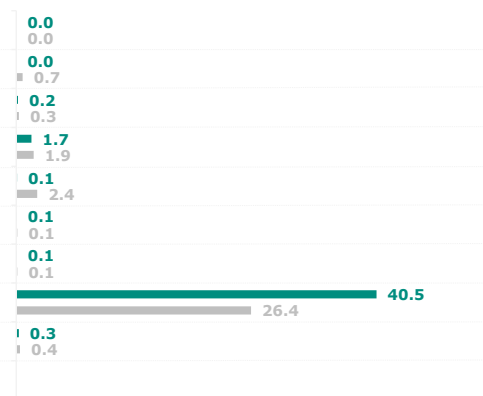

High Climate Impact Sectors Exposure (NACE)



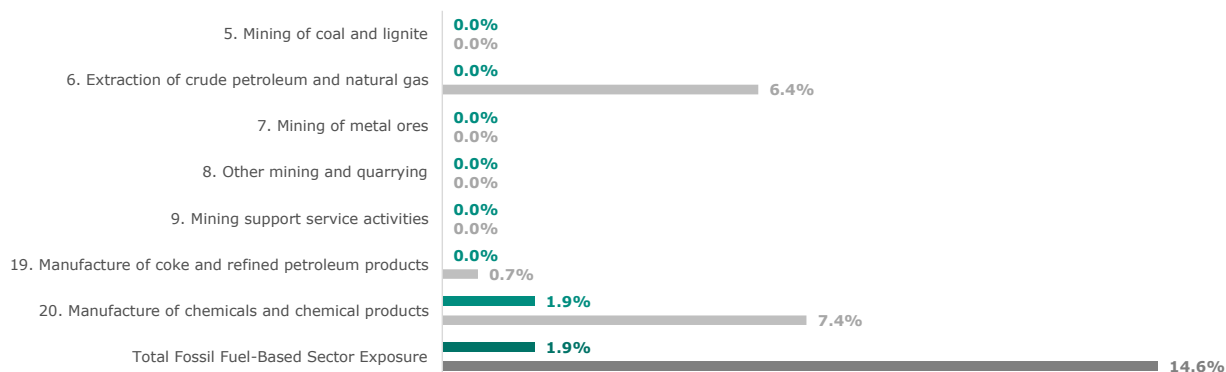

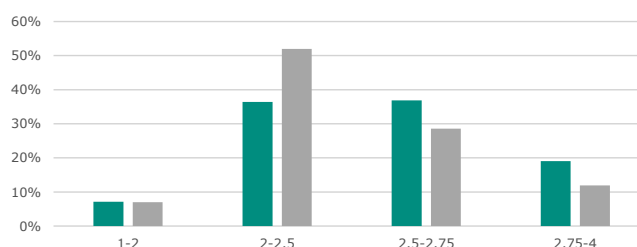

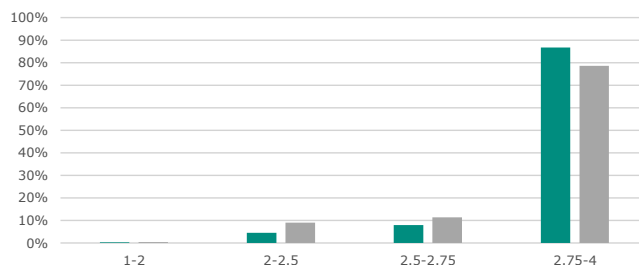

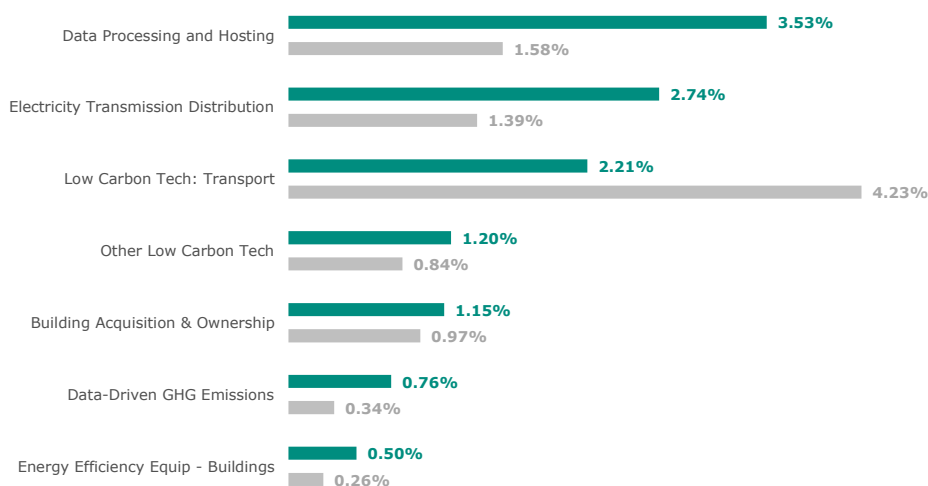

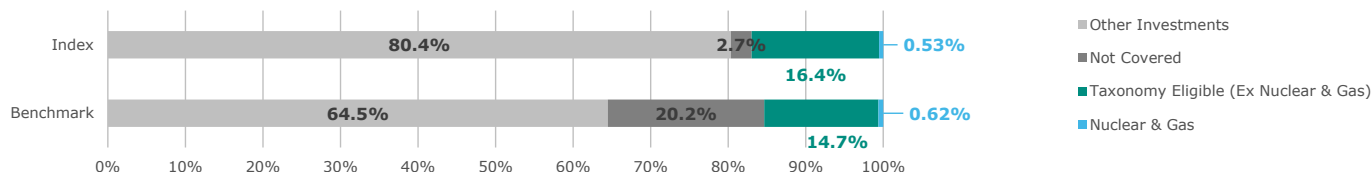

Eligibility Breakdown - Nuclear & Gas



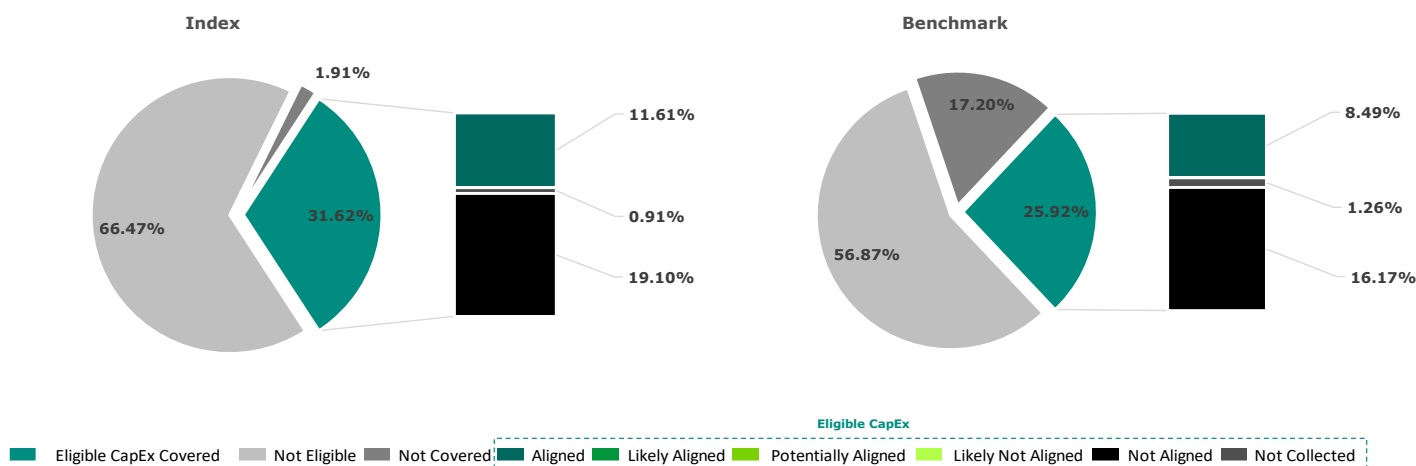

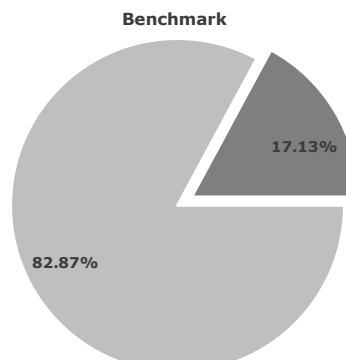
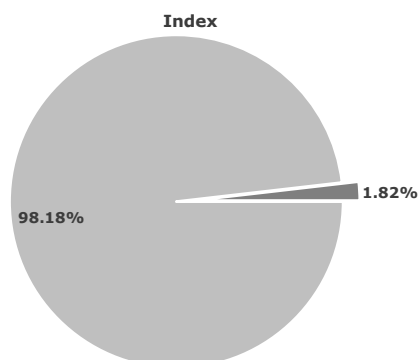
Circular economy

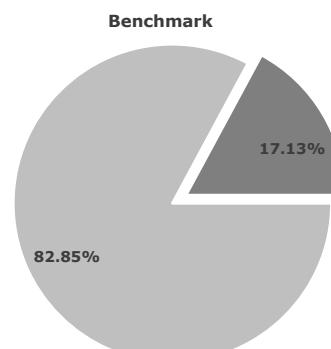
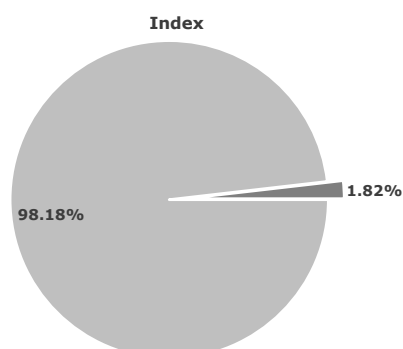
